Immanuel Evangelical Lutheran Church Congregation Meeting Minutes January 27, 2019

The annual Congregational Meeting of Immanuel Evangelical Lutheran Church was held Sunday, January 27, 2019 following the 10:00 am worship service. Council members arranged for lunch with Michael's Deli on Fairview providing the roast beef sandwiches. Council members contributed other dishes and dessert. A free will offering basket was provided.

Tom Neher, President, called the meeting to order at 11:55 am

Pastor Lee led the congregation in prayer.

There were 38 voting members present, providing the quorum necessary to hold the meeting.

Secretary's Report – **Motion** was made, seconded and approved to accept the minutes of the 2018 Annual Meeting as presented.

Financial Report: **Motion** was made, seconded and approved to accept the unaudited financial report for 2018 as presented.

Pastor's Report was reviewed, with no questions.

Synod TMFT Phase 4 Task Team: Karl McClellan reported on his participation on this Southeastern Pennsylvania Synod committee.

Christian Education Report – was reviewed by Mary Lyn Horne-Onimus. She thanked the members of her committee and Sunday School teachers for their time. Background checks are required for any volunteers that are working directly with youth. Question? Does this mean all volunteers at VBS? Including Kitchen help? The committee will get back to the group.

Bible Adventure Club, (Sunday Church School) - was reviewed, no questions. Please bring children who are at least potty trained.

Cradle Roll was reviewed, with no questions.

Vacation Bible School – was reviewed, with no questions. Planning will start soon.

Youth Group - was reviewed, no questions. Trying to reactivate the EPIC Youth by recruiting additional youth from local congregations. The SEPA Synod spring youth gathering has changed location from Harvey Cedars, NJ to a place in the Pocono Mountains.

Property - was reviewed. Fred Warner thanked the members of the committee especially Frank Martinsen for his daily walkthroughs. Missed in the report - Carillon was repaired using several donations after it was not working for a while.

Social Ministry – was reviewed, with no questions. Janice Kintsche thanked committee members and others for their help and support.

Resource Committee - was reviewed by Karl McClellan. Thanks to Jeanne Warner, the committee members who record transactions, and the counters and the audit committee. Thanks to the Narcavage Family and their helpers for selling the grocery coupons.

Thanks to the new fundraising committee. Please support all their activities such as pancake breakfast and Michael's Deli (Fairview) Spirit Nights.

Audit Committee report was reviewed, with no questions. (See note at end of committee reports for a motion to accept the Audit Committee report.)

Outreach – was reviewed, with no questions. Joyce Morrison asked for folks to clip any press coverage they see and give the copies to Joyce or place them in her mailbox.

Lay Eucharistic Ministry – Thanks to all who participate. Sylvia Hunsberger invites members to let the committee know of folks who are homebound or if individuals are interested in becoming a Lay Minister. All members are asked to call folks who have missed attending church and refer them to the committee if they are ill and unable to come.

Half Century Group - was reviewed, with no questions. All are welcome to join the group for luncheon, regardless of your age.

Altar Guild - was reviewed with no questions. Thanks to the three new members, Sue Potteiger, Vicki Slotterback and Colleen Kelly. Altar Guild needs additional members or helpers for the current members. Special thanks to Peg Martinsen for sewing a new missal cover for the altar. Thanks for the donations to cover the costs for wine and grape juice. Please consider sponsoring Altar Flowers.

Acme / Giant / Shoprite: was reviewed, with no questions. Thanks to those who purchase grocery gift cards.

Worship and Music - was reviewed with no questions. Thank you to the committee members. Please help us find a new pianist/organist. Thank you to all the folks that help with the service (assistants, readers, ushers, acolytes), if any member is interested to helping, see Darlene McClellan.

Congregational Statistics 2018 - was reviewed. Pastor reported on the "cleansing of the rolls". Inactive members were contacted before they were removed from the roll. There were no questions.

Mutual Ministry – was reviewed, with no questions. Joyce Morrison extended an invitation to members to give feedback to our staff, either personally or through a member of the committee.

NEW BUSINESS

Motion to accept the audit committee report as presented was made, seconded and approved.

Nominating Committee: Karl McClellan reviewed the open positions on Council, identified nominees for several positions and asked for nominations from the floor for any of the positions. There were no nominations from the floor, so a **motion** was made to elect the slate as presented and was seconded and approved by the congregation.

Certificates: Pastor presented certificates to the outgoing Council Members thanking them for their service.

Budget: Karl McClellan highlighted changes in the budget from 2018 – 2019. Correction: subtotal under utilities and care is incorrect. It should be \$18,600. Totals at the end of the budget are correct as presented. Thank you to the property committee for the work they do.

Income projections: Karl reviewed the Income Budget projection page. Jeanne Warner pointed out the expected deficit of \$9,600.

After review of the budget there was a **motion** made to accept the budget as corrected, which was seconded and approved by the congregation.

New Business

Reconciling in Christ: Motion below is made by the RIC Committee, as approved by the Church Council on January 20, 2019.

Motion is made for Immanuel Lutheran Church to join the Reconciling in Christ (RIC) program which recognizes congregations across several denominations as places where all people are sincerely welcome regardless of their background, ethnicity or gender orientation, including LGBTQ individuals and diverse races. This would include all the sacraments such as Baptism, Communion and Holy Matrimony.

The motion was seconded and approved by the congregation.

The President asked for any other business. There being no requests, the meeting was adjourned at 1:06 pm.

Pastor - 2019 Annual Report

The year 2019 was year of significant change for Immanuel. Not the least of which was changing your worship service from 10am to 11am. I am eternally grateful for your willingness to move with the Holy Spirit. We also have gone more than a full year without a dedicated organist. Our prayers and patience paid off as we look forward to the addition of Kathleen Schneider to enhance the worship experience.

We have also seen a modest but steady increase on our worship attendance with an average attendance of 47 worshipers on a Sunday. This is up from an average of 43 worshipers in 2018. This year we added eight new members total, three through Baptism. Two of our members entered life eternal: Ed Fredrick and Edna Mae Potteiger.

We have been treading water and we have been doing a fantastic job of holding things together. Where are we at holding things together...I'm sure some of you may not want to ask. Using the numbers from the 2018 End of Year report I have broken the budget into seven categories. The first five categories are our toil, our work. The second two are grace, that for which we did not toil.

Please keep in mind these are generally accurate. I am not an accountant and some line items I was not 100% sure where to categorize them. There are not any major changes to the budget that would skew our budget too much for this year. As you can see, we are blessed by the many groups that use and rent our building.

Our giving to the synod is on par with much larger churches, not only in this synod but in neighboring synods as well. Our benevolence, as a percentage of giving has been maintained while many larger churches give the same percentage we do! I am thankful that we have maintained our membership and attendance as others have seen a large decrease in both.

The ELCA churches are challenged. Perhaps we are the front runner of change. We have seen neighbor churches close; we've welcomed those who have joined us from other places.

This church is NOT IN DECLINE! This church is just as GENEROUS as it has been able to be! These members are ENGAGED! Let's look to the current time and the future! The large glory days of huge congregations are over! Now it's about QUALITY!

This past year I formed the Immanuel Building Options Team (IBOT) after the annual council retreat. Karl, Joyce, Fred, Thom G. and I began to look at our physical building and explore options. The hope was to have explored some options for the future of the building, the educational wing specifically and to be completed with recommendations by the Annual Meeting. The process has been slower than expected but we have made some ground.

What is my vision for Immanuel this year and going forward? First, I want to talk about my belief in the importance of corporate prayer. Individually our prayers are like a strand of thread, but they are bound together and made stronger in their unity. I believe in the power of corporate prayer. Ideally everyone would set a reminder at 7am to pray for Immanuel as well as any other intercessory prayers.

Worship: There are some changes I would like to experiment with this year. Personally, I would like to video tape the worship services and review the worship as a whole as well as my preaching in the hopes of improving the quality of both. Liturgy literally means "work of the people". I'm including more members in the worship planning this upcoming year. I want to transform worship from more of a passive to participatory experience. This is in addition to incorporating sermon series and other services like "brunch church" and making of communion bread during worship.

Worship is our "product" that is competing with sports and sleeping in. We need to do it well! We need every single person united in making Sunday worship and associated ministries amazing. Not adequate, Amazing! (Experiential/creative worship, musical concerts, forums, monthly healing service).

Communications/Outreach: As we look to commit to quality, I want to look at our communications. I'd like to move to quarterly newsletters. Not only will this help reduce costs, I think this will help us to think ahead to prepare well for upcoming events. I also want to focus on lives being transformed and of opportunities for transformation. In order to maintain communication between newsletters, I would like to move to weekly emails which could include study guides, prayers (including intercessory), and general announcements.

I would also like to start sending direct mailings 2-3 times per year. I'd like to send like 6000 at each mailing. Will this be pricy? Yes! To grow by 100 people, we need to invite 1000 visitors. To make that happen we must focus on sharing stories in preaching about life-change, especially how God is using our worship services to facilitate it. But that

happen we must focus on sharing stories in preaching about life-change, especially how God is using our worship services to facilitate it. But that is not enough. We must ask each member to bring new people EVERY WEEK and make it easy. Give invite cards for each new series. Create "special days" on Sunday that will intrigue new people and cause them to bring their friends.

Change the Chester Pike signs to include: "open for mediation: free lifetime wireless connection!" "Thinking about Baptism/getting married?"

Discipleship Formation: Yearlong discipleship course focused on spiritual/emotional wellness. Other ways to promote wholeness: financial wellness, physical, intellectual, vocational, social wellness.

Evangelism: I'd like to spend more time meeting with local non-profits and elected officials to better understand the needs of the community. I'd like to have 1-2 visits a week with community leaders to build relationships as well as reveal opportunities for greater community engagement. To this end I am simultaneously working to build and develop the ministerium to aid in our attempt to help churches provide for the needs of the community.

I think it would be helpful for Lay Eucharistic Ministers (LEMs) to continue to make regular home visits and let me know of special needs. Additionally, I'd like to get the Phone-A-Lutheran (PAL) program a more formal role. Not only does this strengthen the congregational bonds (foundation) but especially with new visitors, who is going to get contact information and be their "buddy"? People have anxiety about being in church for the first time or the first time in a long time.

What kind of atmosphere do we want to create? Supply coffee/tea and some goodies (healthy and traditional)?

Many of the challenges I'm asking you to journey toward also reflect what you called and asked me to do with this congregation in your Mission Site Profile.

Lastly, I want to say that none of this would be possible without the help of you all. I would especially like to thank Council: Jean Crane, Thom Graham, Colleen Kelly, Joe Kintsche, Frank Martinsen, Joyce Morrison, Janice Narcavage, Emily Narcavage, Vicki Slotterback, Fred Warner, Jean Warner, Don Watts and Robin Woodrow. I would also like to thank the chairs and co-chairs for their time and effort as well. Jean Crane, Mary-Lyn Horn-Onimus, Janice and Joe Kintsche, Joyce Morrison, Karl and Darlene McClellan, Fred and Jean Warner. Again, thank you all.

ONE MORE CHALLENGE: Join the evolution. Whether this or something else, when I think about the mission here and a way to sum it up, **Join the Evolution** is what I came up with. I believe that the next step in our evolution as a species is a spiritual one. It provides a common, unifying thread that can inform all the ministries of Immanuel.

It is my hope that a clear mission will energize this church. We will be clearer on our purpose, vision and values. I believe this will help committees to be will be more efficient, and effective ministries.

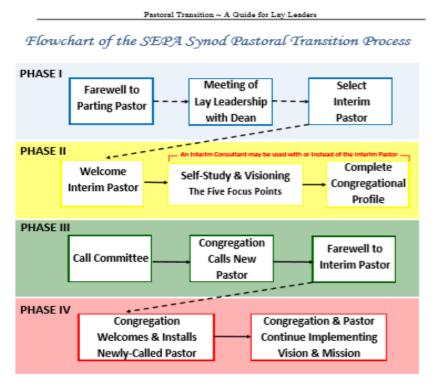

Synod TMDT Phase 4 Task Team - 2019 Annual Report

I would like to share with you an update on the work that I am doing with the Synod that I believe is also helping Immanuel! It is an extension of our Transition Team work from 2016. At the end of our Transition Team effort at Immanuel, Teri Lanan (our consultant) asked me to join the Synod's Transitional Ministry Development Team (TMDT) which I did in May 2017. This team, which has been working in the Synod for a number of years, has been evolving their process as they go.

Here is an overview of the TMDT from Synod as a refresher:



Dashed lines indicate where during the process it may be necessary to use a Bridge Pastor.

The process, documented in the "Transition Guide", serves as a navigational tool for congregations to use as they discern what God is calling them to be and do and what qualities and gifts they need in a pastor to journey with them in answering that call. The Synod serves as a travelling companion by providing congregations with resources and support (information, materials, and people) throughout their journey. Responsibility for overseeing Interim Ministry in the SEPA Synod lies with the Transitional Ministry Development Team (TMDT). The TMDT is comprised of experienced Interim Pastors/Consultants as well as lay members who have served their congregations during a pastoral transition. Pr. Ghislaine Cotnoir took over as the chair of the TMDT in the summer of 2019 with the assistance of Pr. Christian McMullan (Dean of Interims), both of whom are credentialed and experienced Interim Pastors

Through my involvement, I learned that phases 1 through 3 are well developed but phase 4 was not. My focus working with Teri has been to help create "phase 4" which is the phase after a new Pastor comes on

board. This complements what Immanuel is implementing from the work we did in 2016 (the Vision & Mission) plus it fits well with items discussed at the 2017, 2018, & 2019 Council Retreats and the items we wanted to pursue as we move forward:

Immanuel's mission and vision for the future is to:

- 1. Increase our knowledge of, connection with and outreach to our neighbors. In 2019 we expanded use of our facility supporting items such as: Increased NA groups, Cheerleaders gym use, Cardiac Health exercise group, etc.
- 2. Continue being a warm and welcoming place with inspiring, renewing and relevant worship services. In 2019 we were officially recognized as a "Reconciling in Christ" (RIC) congregation meaning we are open to all regardless of Race, ethnic background or sexual orientation
- 3. Provide more opportunities for learning and fellowship for all ages and stages of spiritual development and levels of engagement. In 2019 we continue our Thursday Night Bible Study.
- 4. Build-up the laity for leading and doing ministry within and beyond our walls through the sharing of their treasures, time and talents. (In 2019 our Lay Eucharistic Ministry continues to grow.)

These have been key pieces of Immanuel's "Phase 4" so far. I have supported Immanuel's work, such as attending many of the monthly meetings of several of our committees (Outreach, Worship & Music and Christian Education) this year to support their efforts to bring our "Mission & Vision" into reality. I have been using our experience to add to the phase 4 framework working with Teri for others to use. We presented our work to the Bishop this summer, shared the latest version with the Interims and gained final approval through Synod's Executive committee in early 2019. The revised Transition Guide was officially released on June 15, 2019. You may access the Guide online at:

On the Synod side along with the continued Phase 4 work, I have attended 4 team meetings in 2019, two Interim Consults and a 3-day Interim Ministry Network training session. I am also the connector from TMDT to 2 congregations who are in transition (Saint Timothy's in Aston and Holy Spirit in Secane). Finally, wearing "two hats" (TMDT and Immanuel), I had the privilege to attend the Synod assembly in May.

I plan in 2020 to continue my work on the Synod's TMDT. An effort in 2020 will be to develop "best practices" dealing with "part time" ministries as this trend appears to be growing in our synod. This will also support Immanuel's efforts as we continue in our "phase 4" and at the same time continue to contribute to the process for the Synod which can benefit other congregations (such as St. Matthews).

The plan is to update the Choir Room fixtures first before moving on to other areas of the church.

Property continues to monitor our energy usage and make adjustments/repairs where necessary. For the 2019/2020 heating season Immanuel will continue with a budget plan for oil delivery through WT Galbraith. As in years past property will keep an eye on weather forecasts through the week (summer and winter time) and make appropriate thermostat adjustments throughout the buildings for both heat and air conditioning. At the present time there is only one A/C unit operational to cool the sanctuary.

As in the past, the Property Committee continues to ask for the help of *EVERYONE* when it comes to the use of building for meetings and functions so thermostats can be set accordingly. If you have plans to use a particular room, please contact a member of the property committee in order to set the thermostats (if heating is needed). All thermostats are now covered and locked. When leaving a room be sure the lights are off and doors are closed to help prevent drafts. A BIG "Thank You!" to Frank Martinsen for the time he spends at the church during the week puttering around and performing his daily walkthrough (taking water meter readings, oil tank readings) to be sure everything is in order.

Resource Committee 2019 Annual Report

The Resource committee met throughout the year to monitor accounts and expenses of the congregation. The committee members are: Jean Warner (Treasurer & Co-Chairperson), Karl McClellan (Co-Chairperson), Peg Martinsen, and Carol Henderson.

Each month the committee reviews income and expenses of the General account then recommends action when necessary. The bills for 2019 were paid in a timely fashion. We did have to take funds from our investments and savings to "Pay the bills" in 2019 so that the General Account was in the black. A total of \$2,000.00 was taken from the Memorial Funds to cover expenses in 2019.

In 2019 our goal was to meet a Benevolence commitment to the Synod of \$3,000.00 as set in our budget. As the year progressed, we were not able to remain current with Benevolence payments; however, we were able to meet the full commitment by the end of the year. We are recommending no change for Benevolence in 2020.

The Memorial fund is where memorials are received in memory of loved ones. The Resource committee administers this fund and the Church Council approves any expenditure from this fund. A fireproof cabinet was purchased from this fund in 2019.

The Bequest fund, where people leave funds to the church through their will, had no income in 2019. No expenditures in 2019.

Considerable effort went into trying to control the cost of insurance. We did switch carriers in 2019 to Insurance Board and incurred a savings of \$1328.00 for the year.

This year fortunately was another stable year dealing with T-Mobile who has the use of our bell tower for a cell phone antenna. T-Mobile has been submitting monthly rental fees in 2019 on time and the cash flow has been correct.

In terms of outreach, funds were gathered and forwarded to help people deal with significant issues such as:

In 2011 Thrivent launched a new program and it continued in 2019. It allows members of Thrivent to designate a portion of their proceeds to come to their church. We received \$577.00 in 2019 from this program. If you are a Thrivent member, please select Immanuel to receive Thrivent Choice Dollars.

In 2019 we continued with Amazon Smile where a % of your purchases are sent directly to Immanuel. To date we received \$86.16. Remember to use Amazon Smile when ordering and designate Immanuel Lutheran Norwood to receive funds.

In response to the challenges with balancing income with expenses Immanuel formed a new Fund-Raising committee in 2018 which continued in 2019. The following fundraisers were sponsored in 2019 as follows:

Thank you to the Fund-Raising Committee and look to more fundraisers in 2020!

Significant effort went into seeking ways to maximize the proceeds from our investments in 2019. We stayed with Ameriprise in a managed fund to try and maximize our returns. We are currently invested in a bond fund. Thanks to a generous donation this year we were able to invest \$10,000 into Ameriprise in 2019. The balance of this fund at the end of 2019 was approximately \$44,303.00. We did not have to liquidate any moneys from our investment to cover expenses this year. Good News!

During the last Annual Congregation meeting we passed a 2019 budget of approximately \$118,000.00 with an income projection based on our results for 2018 of \$108,000.00 so a deficit was forecasted at just under (\$10,000.00). To address this, we launched the "ERASE THE DEFICIT" campaign for 2019. "Erase the Deficit" envelopes were placed in the pew racks plus extra envelopes on the Hospitality table. Monthly updates were provided in the bulletins and Newsletters. On a white board in the Hospitality area we tracked progress through the year. As we entered December, we'd made good progress with the deficit reduced to less than \$2500. Then in December we received two generous donations and thankfully we ended the year with the Deficit erased!!! Well done Immanuel!!!

Profit from Acme/Giant/Shoprite food coupons for 2019 was \$1,200.00. This program, which is made possible by the continued efforts of the Narcavage family, is a great way for members to support the church without any added funds coming out of their pockets. Members buy gift cards and the stores give us a percentage of the sales. Our sincere "Thanks" go to all the members of the Narcavage family that make this program possible!

A "Great Big Thank You" goes to our Social Ministry Committee! Throughout the year they have numerous activities such as the Christmas Bazaar (please see their report for a complete list of all the things they do) which not only provides a great social experience but

helps raise significant funds for the church. As we move through 2020 please do your very best to support all the Social Ministry activities!!!!

The annual budget was prepared at the December meeting and approved by Church Council. All areas were asked to look for where to reduce their budget in an effort to close the gap between income and expenses. The proposed budget for 2020 is attached to this annual congregational report along with a projected Income Budget.

We would ask all members of Immanuel to prayerfully consider their many blessings as they evaluate their contributions to the church. If you are not yet using "Simply Giving"...think about it as a convenient, secure way to have your contributions automatically transferred to the Church on the schedule you select. We currently have 8 Simply Giving members.

The Resource Committee meets (generally) on the second Tuesday evening of each month at 6 PM. (Check the bulletin for exact meeting dates and times). All meetings are open to the congregation. If you have any concerns, questions or comments we'd invite you to attend a meeting or speak to anyone of the committee members.

Beyond the Wall: Making All Things New



hen have you discovered newness in life through Christ? Did you have to step out in faith to do so? Perhaps you had to let go of your will and accept God's will. This

is a major turning point in the faith journey of many people. There are examples in Scripture about Job (Job 29-30), Elijah (I Kings 19:4-14), Mary Magdalene (Luke 8:1-2) and the women at the tomb (Luke 23:55 – 24:5). Consider the story of the rich young man (Matthew 19:16-26, Mark 10:17-31, Luke 18:18-30). He approached Jesus with a simple question: "What must I do to inherit eternal life?" Jesus replied, "Go, sell what you own, and give the money to the poor, and you will have treasure in heaven." When the young man heard this, he was very sad and walked away, because he was very rich. Given the choice, he found it difficult to forsake wealth in this world for the promise of God and eternal life.

Sometimes there are barriers or walls that complicate trying something new or stepping out in faith. What walls or barriers have you encountered? Consider the story of Zacchaeus (Luke 19:1-10), who wanted to witness Jesus preaching but was too short to see past the crowd. After Zacchaeus climbed a tree, Jesus called out to him and invited himself to lunch in Zacchaeus' home. We know what Jesus said to Zacchaeus.

and he was a different person afterward. He had changed from wanting wealth and success in this world to desiring significance through a life of faith. When have you, or your congregation, chosen success over significance? Perhaps when using numbers or the size of your facilities as a measure. Moving toward significance usually means sacrificing success. In what areas of ministry is your congregation seeking significance today?

Stepping out in faith may be a personal choice for a short time but usually involves accompanying others. As members in the body of Christ, we are not called to meet our own needs alone. The Great Commission (Matthew 28:16-20) calls us to go beyond our barriers and bring the message of Jesus Christ to others. This helps us grow beyond a Christian enclave to become servants of Christ and a serving community. In what ways has your congregation moved from an enclave to a servant community?

Overcoming barriers and walls to make things new involves stepping out in faith. It means shaking loose from lethargy and moving out from sheltered comfort. In the process we break the chains of sin that hold us back and divide us from making us one in Christ. When we share in the distress of God's heart to do the kingdom's work, we are in tune with God's will, choosing significance over success and becoming a servant community. This is when we feel the vitality of our faith and the power of the Holy Spirit. May you experience this newness in Christ in and through your ministry.
