Immanuel Evangelical Lutheran Church Congregation Meeting Minutes January 26, 2020

The annual Congregational Meeting of Immanuel Evangelical Lutheran Church was held Sunday, January 26, 2020 following the 11:00 am worship service.

Frank Martinsen, Vice-President, called the meeting to order at 12:02 pm

There were 37 voting members present, providing the quorum necessary to hold the meeting.

Secretary's Report – Motion was made, seconded and approved to accept the minutes of the 2019 Annual Meeting as presented.

Financial Report: **Motion** was made, seconded and approved to accept the unaudited financial report for 2019 as presented.

Pastor's Report was reviewed, with no questions. Pastor thanked the congregation for their flexibility and support of the church. He is pleased that the congregation is off to a good start financially for 2020. Immanuel Building Options Team is still working on the options for the Education Wing. Pastor is planning on working more closely with the community and the Interboro Ministerium. Pastor asked that members forward their email addresses to the church office so that we can send announcements and the newsletter via email to save the postage and copy costs.

TMDT Report: Karl McClellan reported on this Synod effort to support the pastoral transition process in congregations. Current efforts are centering on part time ministries: In the Southeastern Pennsylvania Synod there are currently 145 congregations with 30 in transition. It is expected that part time ministries will increase.

Social Ministry – was reviewed, with no questions. Janice Kintsche corrected the report to include Irish Potato candies. She thanked committee members and others for their help and support. Janice thanked the congregation for their participation in events.

Outreach – was reviewed, with no questions. Joyce Morrison apologized for not including committee member, Karl McClellan, in the report

Lay Eucharistic Ministry – Thanks to all who participate. Sylvia Hunsberger invites members to let the committee know of folks who have missed church for several weeks. Pastor - 2020 Annual Report

Things HAVE been happening! Despite all the challenges of 2020, we continued to worship, on average, about 38 people. We celebrated two weddings, and welcomed three baptized members and one returning member for a total of 4 new members. It is with sadness that I report the death of six members. We lost many pillars to the church including: Roy Russell, John Cole, Pauline Wilson, Dawn Gaynor, Erwin Grieb and Gaye Kazmark.

I began this past year with a sermon series called "Letting Go." In which we looked at how God answers our prayers for change but the journey to the Promised Land will not be without challenges. The Israelites had been enslaved for 400 years before Moses would lead the people out of slavery. We talked about wandering in the wilderness (remember the palm) and the fact that there will be challenges even in the Promised Land. 2020 provided fertile ground for change. We also looked at the 5 Love Languages and a sermon series which looked at the movie Field of Dreams.

The most obvious change is our reliance on virtual technology to gather. I am very thankful to Fred and Joyce for their hard work to improve our online presence. Because of this we have been able to reach members who have had to relocate as well as others who have no affiliation.

Despite the fact that we have been limited in our ability to gather this year that does not mean that things were not happening.

We headed into 2020 focusing on our generosity and specifically building a culture of generosity. This was the focus planning for our annual council retreat. This past year we did not have a council retreat due to the pandemic. I am eager to see if it may be possible for a council retreat in (hopefully) late April.

I did hit several goals from last year. The first of which was I had wanted to begin videotaping worship services. I have readjusted the worship format for viewing considerations. I am also mindful that in its current format, worship is a bit passive. I want to transform worship from more of a passive to participatory experience. This is in addition to incorporating sermon series and other services like "brunch church" and making of communion bread during worship.

Worship is our "product" that is competing with sports and sleeping in. We need to do it well! We need every single person united in making Sunday worship and associated ministries amazing. Not adequate, amazing! (Experiential/creative worship, musical concerts, forums, monthly healing service).

Again, Liturgy is the "work of the people" and I want to make it more participatory. That is where you all come in. While we are still focused on generosity, this past year has also challenged us to develop a culture of connection.

I finished teaching a yearlong discipleship course. We started out the year with an experiment called "A Year to Live." We met monthly for a year and talked about different aspects of life and death. This is not an easy class to experience and a year is a long time, especially this year. Those who finished the class found it to be rewarding and life changing in some way.

We changed lives through the Financial Peace University which gave people the opportunity to change their lives financially. While some members took advantage of this opportunity; we did reach several others in the community. Joyce Morrison was my co-facilitator for this outreach endeavor. We found the material very easy to work with. If you are interested in being a co-facilitator please contact me.

My goals from Communication and Outreach remain the same as last year. As we look to commit to quality, I want to look at our communications. I'd like to move to quarterly newsletters. Not only will this help reduce costs, I think this will help us to think ahead to prepare well for upcoming events. I also want to focus on lives being transformed and of opportunities for transformation. In order to maintain communication between newsletters, I would like to move to weekly emails which could include study guides, prayers (including intercessory), and general announcements. Our email list currently includes twenty-three emails representing twenty households, including one non-member (Kathleen), and one non-local, Joanne Fitzpatrick.

I would also like to explore sending direct mailings 2-3 times per year. I'd like to send like 6000 at each mailing. Will this be pricy? Yes! To grow by 100 people, we need to invite 1000 visitors. To make that happen we must focus on sharing stories in preaching about life-change, especially how God is using our worship services to facilitate it. But that is not enough. We must ask each member to bring new people EVERY WEEK and make it easy. Give invite cards for each new series. Create "special days" on Sunday that will intrigue new people and cause them to bring their friends. For example, breakfast church or a sermon series.

I would like to really have some fun with the sign on Chester Pike. IF you see a fun sign take a picture and send it to me. Or if you think of one send me an email.

Lastly, I want to say that none of this would be possible without the help of all of you. Special thanks to Council members, Chairs, and all the volunteers for your ongoing dedication, especially this past year. Again, thank you all.

Synod TMDT Task Team - 2020 Annual Report

I would like to share with you an update on the work that I am doing with the Synod that I believe is also helping Immanuel! It is an extension of our Transition Team work from 2016. At the end of our Transition Team effort at Immanuel, I joined the Synod's Transitional Ministry Development Team (TMDT). This team, which has been working in the Synod for a number of years, has been evolving their process as they go. As you may recall from my 2019 update, TMDT working with the office of the Bishop and the Synod's Executive committee did release a revised Transition Guide in 2019. You may access the Guide on line at:

As with nearly all aspects of 2020, the pandemic had a major impact on TMDT starting in March by curtailing in person activities and driving all those involved with transitional ministries into "Zoom" interactions. Here is a summary of the things I was part of in 2020:

On the "Synod" side in 2020

- Attended 4 TMDT meetings (1 live and 3 Zoom)
- Attended 4 Interim Consultations (1 live and 3 Zoom)
- Facilitated 3 Exit interviews (2 live and 1 Zoom for: Holy Spirit, Secane + St. Tim's, Aston + St. Mark's, Pennsburg)
- Wearing "two hats" (TMDT and Immanuel), I had the privilege to attend the Synod's Generosity workshop in January

On the "Immanuel" side

- I had a chance to work on a plan for what was going to be our 2020 Council Retreat. That was put on hold due to the pandemic. Once we reach a point where the vaccine roll out allows us to safely resume more of our "normal activities", I'd expect that Immanuel will pick back up on the work we did in 2016 (the Vision & Mission) and at the 2017, 2018 & 2019 Council Retreats and plan some type of Council Retreat. Here are Immanuel's mission and vision for the future, from 2016, which we will continue to build upon:
- 1. Increase our knowledge of, connection with and outreach to our neighbors
- 2. Continue being a warm and welcoming place with inspiring, renewing and relevant worship services.
- 3. Provide more opportunities for learning and fellowship for all ages and stages of spiritual development and levels of engagement.
- 4. Build –up the laity for leading and doing ministry within and beyond our walls through the sharing of their treasures, time and talents.

I plan in 2021 to continue my work on the Synod's TMDT. I expect an upcoming effort will be to develop "best practices" dealing with "part time" ministries as this trend appears to be growing in our synod. This will also support Immanuel's efforts and at the same time continue to contribute to the process for the Synod which can benefit other congregations.

Lay Eucharist Ministry 2020 Annual Report

Distribution of communion to those in "special" circumstances is a service which is designed for carrying communion to the sick/homebound, it can be used by any Christian – lay or ordained person.

This ministry has four re-commissioned members. They are re-commissioned every two years. We all find this ministry and connection with the homebound a very meaningful and rewarding experience. Our homebound are all very happy and appreciate that Immanuel has this ministry. Our ministers are very committed.

When Sunday services were cancelled due to COVID19, we met with Pastor Lee to plan on changes. We each made a list of persons to contact who might be interested in Communion. Including those injured or sick in addition to our regular homebound members. Pastor Lee kept us supplied with blessed wafer and juice cups. We delivered these items in a sanitized bag, along with a short service, to members' homes and would celebrate communion over the phone. We have continued with Communion and telephone visits monthly when possible.

This ministry does not replace a Pastor's visit and continues in connection and coordinated with Pastor Lee's visits. We have a meeting every third month, have devotions, discuss and evaluate what we do and share ideas.

The congregation could/should help us by informing the church office promptly when one of our members is hospitalized or becomes homebound. They will be added to our visitations with permission from that person. Also, if anyone is interested in participating in this ministry or if you know of anyone interested, let the church office or Sylvia know.

Immanuel Building Options Team (IBOT) Annual Report for 2020

2020 was the 2nd year for a new committee (that was formed in 2019) called the "Immanuel Building Options Team" or "IBOT" for short.

This came out of the 2019 annual council retreat which Pastor hosts each year to connect to our mission and longer range goals, do visioning for Immanuel and set objectives for the year. Council decided to form a committee to look into our property, all buildings, how we use them now and to see what possible options there might be for the future. The committee consists of Karl McClellan, Joyce Morrison, Fred Warner, Thomas Graham and Pastor Lee. This committee will not be making decisions but explore options and present those options, research and recommendations to the Church Council which would then present them to the congregation for consideration to move forward.

As you may recall in 2019, we began looking at four big possible options:

- 1. Sell education wing/parcel, disconnect property, use funds to modify the church building to have all rooms/facilities we'll need.
- 2. Take down Ed wing and create a parking lot.
- 3. Offer spaces to rent (such as: preschool, other churches, Coffee shop, Modify & rent, YMCA camps, etc.).
- 4. Sell whole property and rent back what we need.

While looking at this the other things to be considered include.

- Redecorate/renew downstairs
- Adaptable worship space

In the first year's work (2019) we:

- Gathered many documents (deeds, drawings, records, etc.).
- We got professional legal and architectural advice (donated time so far).

In 2020, we'd hoped to continue that work but like many things the pandemic impacted and slowed the effort. What we did accomplish in 2020 was:

 Met with a Commercial Realtor (Dominic Bucci) to do a walk through and gather more information. It is clear from that meeting we will need to fully understand the zoning for the property. He also recommended we reach out to the school district for possible pod space.

In the 4th quarter God provided an opportunity for some tenants! Diakon Lutheran Social Ministries and Diakon Child, Family & Community Ministries serve approximately 70,000 children, youths, families, and adults. Their Family and Youth Services needed office space to serve Delaware County. They will be renting two of our classrooms in the Educational building starting in January 2021 for \$500/month. A huge thanks to Fred Warner for making it all happen!

As we eventually emerge from the pandemic and when it makes sense priority wise, we hope to continue to try to fully understand what we have from a property standpoint, what the possible options may be based on the value of the property(s), feasibility of making modifications and the various code requirements and come to a recommendation. As we make progress, we will share any interesting facts or resources with the congregation.

Property Committee 2020 Annual Report

Even though we have gathered to worship intermittently through 2020 due to COVID, Property has continued with the upkeep of the church building and surrounding grounds. The only major project Property undertook was to upgrade the lighting fixtures in the Adult Bible Study Room, Choir Room and Dining Room to energy efficient LED tubes. The light fixtures were rewired and had a total of 43 LED tubes replaced the old fluorescent tubes.

For the 2020/2021 heating season Immanuel will continue with a budget plan for oil delivery through WT Galbraith. Property will continue to monitor the winter weather forecasts and adjust the thermostats accordingly.

Property is a SMALL but very active group in the church. A BIG "Thank You!" to Frank Martinsen for the time he spends at the church during the week puttering around and performing his daily walkthrough (taking water meter readings, oil tank readings) to be sure everything is in order. Another BIG "Thank You" to Steve Russell for his help with the outdoor grounds keeping/grass cutting. With Steve's help a typical grass cutting now only takes about an hour.

The Property Committee meetings are held on the second Sunday of each month at 9:00 am in the Educational Wing Lower Lounge.

Thank You to the following folks that give of their time as members of the Property Committee; Alex Narcavage, Frank Martinsen, and Steve Russell.

Half Century Group Annual 2020 Report

We are a group of folks 50 and older who gather once a month on the third Thursday of every month, September through May at 12 noon. As good Lutherans we gather around tables for food, conversation and stories. Due to COVID19 we were unable to meet from March through the end of the year. We look forward to being able to once again gather together once it's safe to do so. Again, all are welcome to come and share in the food, fun, and fellowship.

Resource Committee 2020 Annual Report

The Resource committee met throughout the year to monitor accounts and expenses of the congregation. The committee members are: Jeanne Warner (Treasurer & Co-Chairperson), Karl McClellan (Co-Chairperson), Peg Martinsen, and Carol Hendrickson.

Each month the committee reviews income and expenses of the General account then recommends action when necessary. The bills for 2020 were paid in a timely fashion. We did have to take funds from our savings to "Pay the bills" in 2020 when Covid hit and the church closed in March. A total of \$4,047.00 was liquidated to cover expenses in 2020.

In 2020 our goal was to meet a Benevolence commitment to the Synod of \$3,000.00 as set in our budget. As the year progressed we were able to remain current with Benevolence payments We are recommending no change for Benevolence in 2021.

As the Covid pandemic was hitting the Government made available funds called the "Payroll Protection Plan (PPP)" through the Small Business Association (SBA). We did apply for the PPP (a small business loan) through our PNC bank and we did receive a loan on May 5th of \$23,600. The original guidelines said the ratio of how the funds could be used was to be 60% for payroll and 40% for utilities. Our intention was to diligently use what we could in a way that we did not turn it into a loan which we'd incur interest on and have to pay back. The guidelines from the Government evolved and by the time we reached October with the latest guidelines, we do believe we have qualified for the loan to be forgiven. At this time, under advisement of the bank and Synod, we have assembled the paperwork but are holding off on submitting it as the Government is still finalizing how they want information to be turned in.

The Memorial fund is where memorials are received in memory of loved ones. The Resource committee administers this fund and the Church Council approves any expenditure from this fund. Funds were approved in December to use Memorial funds to replace front door key mechanism and new keys at an estimated cost of \$972.90. In December an updated policy for the Memorial fund that included appropriate separation of duties language was approved by council.

The Bequest fund, where people leave funds to the church through their will, had no income in 2020. No expenditures in 2020

Considerable effort went into trying to control the cost of insurance. We did switch carriers in 2019 to Insurance Board and incurred a savings of \$1,328.00 for the year.

This year fortunately was another stable year dealing with T-Mobile who has the use of our bell tower for a cell phone antenna. T-Mobile has been submitting monthly rental fees in 2020 on time and the cash flow has been correct.

In terms of outreach, funds were gathered and forwarded to help people deal with significant issues such as:

•	World Hunger	\$ 168.00
•	ELCA Good Gifts (Sunday School Project)	\$ 260.00
•	Holiday Helpers	\$ 545.00

In 2011 Thrivent launched a new program and it continued in 2020. It allows members of Thrivent to designate a portion of their proceeds to come to their church. We received \$340.00 in 2020 from this program. If you are a Thrivent member, please select Immanuel to receive Thrivent Choice Dollars.

In 2020 we continued with Amazon Smile where a % of your purchases are sent directly to Immanuel. To date we received \$66.84. Remember to use Amazon Smile when ordering and designate Immanuel Lutheran Norwood to receive funds.

In response to the challenges with balancing income with expenses Immanuel formed a new "Fund Raising" committee in 2018 which continued in 2020. Due to Covid, only the following fundraisers were sponsored:

Thank you to the Fund Raising Committee and look to more fundraisers in 2021!

Significant effort went into seeking ways to maximize the proceeds from our investments in 2020. We stayed with Ameriprise in a managed fund to try and maximize our returns. We are currently invested in a bond fund. The balance of this fund at the end of 2020 was approximately \$47,455.00 – an increase of approximately \$3000.00. We did not have to liquidate any moneys from our investment to cover expenses this year. Good News!

During the last Annual Congregation meeting we passed a 2020 budget of approximately \$117,180.00 with an income projection based on our results for 2019 of \$116,000.00 so a deficit of \$1158.00 was forecasted.

Profit from Acme/Giant/Shoprite food coupons for 2020 was \$1,200.00. This program, which is made possible by the continued efforts of the Narcavage family is a great way for members to support the church without any added funds coming out of their pockets. Members buy gift cards and the stores give us a percentage of the sales. Our sincere "Thanks" go to all the members of the Narcavage family that make this program possible! Despite the church being closed, this program still ran. Many thanks to all who still were able to participate even during the pandemic.

A special "Thank You" goes to our Social Ministry Committee. Though they had planned numerous activities for 2020, such as the Christmas Bazaar which not only provides a great social experience but helps raise significant funds for the church, the impact of the pandemic put the vast majority of their plans on hold. Social Ministry was able to give the church \$1,931.00 in January 2020 from the 2019 Christmas Bazaar which was greatly appreciated! As we move through 2021 and as we all pray that the pandemic begins to subside and in person activities can begin again, please do your very best to support all the Social Ministry activities.

The annual budget was prepared at the December meeting and approved by Church Council. All areas were asked to look for where to reduce their budget in an effort to close the gap between income and expenses. The proposed budget for 2021 is attached to this annual congregational report along with a projected Income Budget.

We would ask all members of Immanuel to prayerfully consider their many blessings as they evaluate their contributions to the church. If you are not yet using "Simply Giving"...think about it as a convenient, secure way to have your contributions automatically transferred to the Church on the schedule you select. We also established "Give Plus+". You can now download the "GivePlus+" app to your phone (use the app store – Android or iPhone) you can link the app to your bank account for transfers from your account to the church. We currently have 8 Simply Giving members.

The Resource Committee meets (generally) on the second Tuesday evening of each month at 6 PM. Karl and Jeanne have been meeting through a telephone conversation monthly due to the pandemic. (Check the bulletin for exact meeting dates and times). All meetings are open to the congregation. We hope to be back in-person soon. If you have any concerns, questions or comments we'd invite you to attend a meeting or speak to anyone of the committee members.

Our sincere "Thanks" for all who help us with the business side of Immanuel, our Treasurer and Co-Chair of Resource Jeanne Warner, Our Financial Secretaries Peg Martinsen and Carol Hendrickson, our Counters & our Audit committee.
