1) Call to Order by the President:

The regular meeting of the FISO Congress and World Obstacle General Assembly was called to order at 14h00 Central European Summer Time by the President Mr. Ian Adamson.

Ms. Mafalda of the Portuguese Federation suggested that the Congress should be held at the beginning of the year; Mr. Richardson of the Venezuelan Federation suggested the creation of a Sub-Continental Confederation specific to South America, which idea was supported by Mr. Rodolfo of the Costa Rican Federation; Mr. Raul of the Romanian Federation suggested that the calendar of competitions should include the creation of Regional Championships, having been clarified by Mr. Ian that there are already Sub-Continental competitions.

15) Adjournment

The meeting was adjourned at 16h30. The 8th Congress will be scheduled for the date when the 2022 World Championships will take place, on a date to be confirmed in due course.
