In each committee, senators are listed in order of calling priority. Please call the ***\*bold italicized Senators first. \*Senator Glazer*** is on both committees, so please call him first, then the other ***Chair and Vice Chairs***, followed by the other ***\*Members***. Even if you aren't in the senator's district, let the aide know that you'd still like to be heard, and they will relay your comments to the senator. If you're a democrat, let the senators know. Most committee members are democrats. They need to know this is bipartisan issue!
