DO NOT ABBREVIATE ANYWHERE. Only exceptions: Sr., Jr., Apt., CA.

STEP 3 Declaration of Circulator=DC (witness statement) **EVERY FIELD** filled in to be valid.

IF 1 person signing at home, **handwrite your STEP 1 County.**

STEP 2 Write your name, address, city, zip and signature.

STEP 3 Write your name, address 2 times. The date 3 times.

STEP 4 Sign again.

Petition is valid throughout campaign

IF 2-3 persons signing at home, **handwrite your STEP 1 County.**

STEP 2 Each signer must **handwrite their own information.**

STEP 3 One of you will write your name, address 2 times, the date 3 times and **STEP 4** sign again.

IF 1, 2 or 3 persons signing anywhere, **ALL** must live in the **SAME STEP 1 County.**

REPEALS VOTER-ENACTED CHANGES TO PROPERTY TAX RULES FOR TRANSFERS BETWEEN FAMILY MEMBERS. INITIATIVE CONSTITUTIONAL AMENDMENT.

Reinstates property tax reassessment exemptions for certain real property transfers between family members (including by inheritance), which voters eliminated through Proposition 19 in 2020, reducing local property tax revenues and eliminating funding source for Proposition 19's California Fire Response Fund. Allows transfers to children (or grandchildren if parents are deceased) without property tax reassessment of: (1) principal residence, regardless of its current value or continued use as principal residence; and (2) \$1 million in other real property. Properties assessed under Proposition 19 may be reassessed under reinstated rules. Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local governments: Some owners of inherited properties would pay lower property taxes. TO THE HONORABLE SECRETARY OF STATE OF CALIFORNIA

We, the undersigned, registered, qualified voters of California, residents of _____ County (or City and County), hereby propose amendments to the Constitution of California, and petition the Secretary of State to submit the same to the voters of California for their adoption or rejection at the next succeeding general election or at any special statewide election held prior to that general election or as otherwise provided by law. The proposed constitutional amendments read as follows:

Save Our Children's Future Act of 2026

SECTION 1. The people of the State of California find and declare all of the following:

- (a) In 2021, Californians lost the constitutional right they possessed for nearly 35 years to transfer their home and a limited amount of other property between themselves and their children without triggering reassessment to current market value and in a higher property tax bill.
- (b) This act restores that constitutional right and also restores the same constitutional right for transfers between grandparents and qualifying grandchildren.

- (3) A purchase or transfer of real property subject to subdivision (c) of Section 2.1 on or after February 16, 2021, and before January 1, 2027, shall, upon the filing of a claim with the assessor of the county in which the property is located, be reassessed as if subdivision (h) of Section 2 had been operative at the time of the purchase or transfer.
- (b) The Legislature shall provide in statute for the reassessment program described in paragraph (3) of subdivision (a), and shall provide in statute that the availability of reassessment pursuant to paragraph (3) of subdivision (a) be publicized and be publicized in minority communities.
- (c) This section shall be liberally construed to broadly apply the tax benefit under subdivision (h) of Section 2.
- (d) This section supersedes any other provisions of this Constitution that are in conflict with this section, including, but not limited to, Section 2.1 of Article XIII A.

SECTION 2. Section 2.4 is added to Article XIII A of the California Constitution, to read: SECTION 2.4.

- (a) Notwithstanding any law:
 - (1) Subdivisions (c) and (d) of Section 2.1 shall apply only to those purchases or transfers of real property occurring on or after February 16, 2021, and before January 1, 2027.
 - (2) Subdivision (h) of Section 2 shall become operative on January 1, 2027, and shall apply to a purchase or transfer of real property that occurs on or after January 1, 2027.
