

SECTION 25: Statement of Rates & Charges 2024

Annual Administrative Charge

\$208.96

Applies to all parcels within District each year

Domestic Charges

Single residence customers &/or those with less than 3 acres are allotted 1,300 cubic feet (9,724 gallons) per month and will be billed as follows:

5/8" x 3/4" Meter	\$46.68	\$560.16
1" Meter	\$52.55	\$630.60
1 1/2" Meter	\$122.96	\$1,475.52
2" Meter	\$168.11	\$2,017.32

Domestic Water Overage Fees

.96 per 100 cubic feet

Applies to domestic customers who exceed their monthly allotment.

Irrigation Charges

\$133.91 per acre

District customers with 3 or more acres 87,120 cubic feet per acre from April 1st through September 30th. All Irrigation customers will pay the domestic 5/8"x3/4" meter for their domestic water.

Irrigation Water Overage Fees

.96 per 100 cubic feet

Applies to Irrigation customers who exceed their monthly allotment.

Bulk Water Rate

\$1,004.33

Available to all District customers. Must be paid in full prior to April 1st each year and used April through September. The allotment is 435,600 cubic feet.

Out of District Charges

1.5 x "In District" Rates

Applies to parcels NOT within District boundaries AND who have NOT paid equalization.

Statement of Other Fees & Charges

All labor, materials, miscellaneous charges and taxations borne by Moab Irrigation District will likewise be passed onto the customer receiving the service benefit. All rates, charges, and penalties, certified as delinquent, will accrue a service charge at the rate of 1% per month/12% per year, or the highest amount permitted by law. Other charges deemed reasonable by the Board will be applied for services including, but not limited to, the following rate and fee schedules:

Delinquency Notification/Rebiling Fee	\$12	Applied at 30+ days of delinquency
Returned Check or Stop Payments	\$60	Subject to change related to actual charges
Project Administration Fee	3%	of Invoice
Disconnect/Reconnect/Suspension Charge	\$100 - \$200	Subject to business hours of operation

Labor & Equipment Rates

District Personnel	\$95.00	Per hour
Call Out – After Hours	\$150.00	Per hour; 2 hours minimum
Utility Truck	\$85.00	Per hour
Project Administration Fee	3%	of Invoice
Fire Hydrant Use (600 cu. ft. allotment)	\$98.00	Excess water charge at \$1.00 per 100 cu. ft.
Insulation - Installation	\$10.00	Per meter
