STATEMENT BY A CRIME VICTIM

On Sunday April ,6, 2025 Cindy Falco Di Corrado , A Senior woman and her husband Luciano Di Corrado went to go to the Delray Beach Art Show at approximately 10:45 a.m.

Upon entering in the Parking garage on Sunday, April 6, 2025 located at 180 N.W. 1st Street Delray Beach, Florida there was a \$5.00 entry fee which we paid by credit card and received receipt number 08716169. (Please see Credit Card Receipt and receipt number.

Luciano, my husband paid the \$5.00 fee. As he finished paying a car cut in front of us and stopped all the cars from entering even though we all paid for parking (rather than the parking attendant having the car that cut in front pull aside) the parking attendant kept talking and didn't have the young male explorer go and get their \$5.00 to park instead the young man kept getting the cars behind us to pay. I , Cindy tooted the horn **once** after several minutes had passed.

This held up the traffic and caused a backup and a delay for all who had paid. After parking the car, I, Cindy Falco- Di Corrado , a senior woman went to speak to the parking attendant who looked to be the age of my grandson, to help him so that he could make a better way to handle the situation if it should occur again.

As I was beginning to share with the parking attendant, that the next time this situation arises, it would be helpful to have them to move their car to the side out of the main driveway to not to hold up all the traffic. But, I wasn't able to finish

my statement. The parking attendant got up out of his chair and came 1 inch from my face and screamed at me to GET OUT OF HIS FACE and then another person, a bald woman joined in with him screaming at me to GET OUT OF HIS FACE which I felt threaten and intimidated for my life. The male Hispanic attendant then grabbed me constituting battery against the elderly. I told the male Hispanic parking attendant to let me go and to Stop touching me. He twisted my hand up my back as a parking attendant and said I was under arrest, I said Let go of me.

Meanwhile, my husband, Luciano hears me, Cindy scream his name because the parking attendant is attacking I, Cindy, a senior woman. (Please see evidence pictures of bruising my body).

Because they conspired to deny rights and violated the Constitution they gave up their rights and established themselves as criminals impersonating Officers of the Law, therefore any action that followed is purely criminal on their part.

My husband, Luciano says: let me take my wife to come with me and we will leave. Luciano, my husband said that he was going to call the Police because the Hispanic parking attendant kept pushing on him and the Hispanic parking attendant torts back to Luciano and says Luciano is pushing him as he continues to push Luciano. Then the woman behind Luciano said that they were the police.

They did nothing to identify themselves until after the assault, battery and false arrest. Luciano was walking towards Cindy because the female Deputy said to the parking attendant let her go with her husband so, then the parking attendant which we now know is a Male Hispanic Deputy because he asked one of the young male explores to hand him his police vest which he NEVER identified himself as being a Deputy prior to that moment. He also grabs Cindy and throws her on the ground and hand cuffs her dragging her. (Evidence: Please see pictures of bruises)

Luciano said don't worry everything is okay and the now known Hispanic Male Deputy as Carlos Penagos kept saying to Luciano NO she's going to jail and repeated it multiple times. The now known Hispanic Male Deputy said to the female Deputy Now known as Deputy Robertson to take Luciano away from Cindy a Senior woman, his wife. So, the female Deputy put Luciano in Handcuffs (that constituting a second false arrest).

I, Cindy Di Corrado , a Senior woman nor Luciano Di Corrado was ever read the Miranda Rights.

During an arrest, if police wish to ask you questions, they must first provide a Miranda warning. If they fail to do so, your answers may not be used against you in court. Then A Black Male Deputy (known known as Deputy Williams) pulls Cindy by the Police Car and a Large white woman starts to go in my pockets and on my bra and patting me down.

The Black Male Deputy (Williams) begins to also attack/ man handled Cindy, the Senior woman . Cindy, a senior woman asks for her cell phone which is in my husband's name. The Black Male Deputy says its not my phone anymore which is a violation of the Article 4 to the Bill of Rights, unlawful search and seizure. He then proceeds to Mock me as I am a Minister and calling me a hypocrite, which I am a Licensed Minister, this is a violation of article 1 to the Bill of Rights, a felony crime. He was quite verbally abusive, used excessive force on me. (Please see evidence of thumb print on my upper right arm).

This constitutes Police Brutality against the Elderly and based upon religion, constituting Religious HATE Crimes. I had stated to the black male Deputy now known as Williams, that I had urinated when I was screamed at by the now known Two deputies, who I thought were parking attendants because I didn't want to sit in the seat with wet pants in which the black male Deputy mocked me and said a snide remark about urinating in my pants, constituting elderly abuse.

I was not seat belted in by the Male Black Deputy who took me to the Delray Police Station.

It's the Law to Buckle Up and he did not put the seat belt on me and left me in harm's way.

It begs the questions: Why are terrorist allowed to work for the police; Why do the police providers harbor a safe haven to those committing treason; why are police officers out in the public without identifying themselves; why are police officers performing DOT duties; and why were police officers pretending to be parking attendants?

Arriving at the Police Station: A Black female Deputy (Quinn) does another pat down again fondling/patting me and takes the handcuffs off and puts me in a

room. I said this was already done to me in the public with people standing around watching which was quite humiliating.

Because I did not have any Identification on me, the Black Female Deputy and the Male Hispanic Deputy continually tried trickery to get my husband's name and number and would continually ask me my name. So How could I have given False ID in which they are charging me with 901.36.(1)? I DID NOT have any identification on me?

I told the Black Female Deputy that my name is Cindy. They tried to coerce information from me by being deceitful even after I told them I was evoking the fifth amendment and I wanted to speak to a Lawyer.

Violation of my God Given Right protected under the Constitution of the United States of America, the Supreme Law of the Land. Eventually the Hispanic Male Deputy now known as Carlos Penagos, takes me to go to the Palm Beach County Jail on Gun Club Road.

Prior to getting in the police vehicle, I noticed that his body cam was turned off and I asked him to please turn his body camera on, as I feared for my life with what transpired earlier. Because of the assaults, excessive force, false arrest, elder abuse and battery, domestic terrorism, and denial of rights of traitors acting under color of law.

I inquired about protocol about a female to be escorted with a female. I then asked the Hispanic Male Deputy to take me to a Magistrate in which he states there was no magistrate and that I would have to wait till court on Monday, the next morning. The Hispanic male Deputy took me to the Men's side of the holding jail Not the women's. I stated that this is the men's and I am a woman. The Hispanic Male Deputy, eluded to the fact that he could take me where he wanted to because that is what he wanted to do. That is Neo Nazism.

Once I was in the men's Jail, I was terrorized by 5 Officers who stripped me of my clothes, constituting further sexual assault. They put me in a suicide booth having only a concrete floor, dirty toilet that didn't flush, no toilet paper and no privacy. They treated me worse than an animal! They dehumanized, terrorized and treated me as a non-American.

I was denied ALL outside contact for the period of time from 2:00 p.m. Sunday afternoon till I was released appx. 6:30 p.m. Monday. (FYI) When they inquired of me at intake the nurse asked me if I drank or did drugs I told her that I do NOT.

The nurse never took pictures or documented the bruises on my body. She only glanced at me and that was all she did. I was not given an incident Report and did not know my charges.

What Crime was committed? Where is the Probable Cause? The only Public Nuisance Disturbing Peace 823.01 are those Deputies of the Delray Beach Police Office.

Was it because I was of Jewish Heritage? Was it because I was a senior woman? Was it because I was white? Was it political?

Inaccurate Report: NOTE: In accordance with the Federal Constitution defendants only exist in Civil matters. They are trying to either criminally prosecute a civil matter or deny me (again) my Federal Rights as a (falsely) accused American citizen.

The incident report was signed under penalty of perjury which I am rebutting as it is not the truth.

Names of Officers Now known as: (Hispanic Male, Parking Lot Attendant) Carlos Penagos -# 1190 , Bald Female Officer, Robinson -Badge #0976, Black Male Officer- William #1188, Large White woman Police shake down in public Officer Spooner- #1078 ,stand by Officer in the background Perez- #1117, and Quinn the intake female officer helped write the incident report and wasn't at the parking garage she was at the Delray Police holding cell. I do not have a badge number.
