

# beverage service

Our full bar offers a lot of flexibility, and there's an option for everyone. You can choose to pay per drink with a host bar, let guests purchase their own with a cash bar, or a blend of both to fit your event and budget.

## HOSTED BAR

Pay per drink - host guests drinks for a specified amount of hours or dollar amount.  
All hosted drinks subject to 20% added gratuity. Bar minimum \$2,000.

## CASH BAR

We open our full bar, stocked with beer, wine, call and premium liquors; your guests pay their way and tip the bartender directly with cash or card.

## ALA CARTE

Ask for our detailed price list if you're considering hosting certain items for your guests; barrels of beer, bottles of wine, etc.

## SPECIALTY COCKTAILS

Add a signature sip to your wedding with our specialty cocktail menu, designed to make every toast as unique as your love story.

## NOTES:

Fremont River Deck holds a Class B liquor license, and by law we must provide and serve alcoholic beverages. This means no carry-ins of alcoholic beverages of any kind, at any time. If carry-ins are found, they will be confiscated. Our bartenders are licensed servers who reserve the right to refuse guests if they feel they are intoxicated. No one under the age of 21 may consume alcohol on our premises. All prices are subject to change. A bar spend minimum of \$2,000 applies to every event.



# FREQUENTLY ASKED QUESTIONS

- HOW MANY GUESTS CAN YOU ACCOMMODATE?

OUR HALL CAN COMFORTABLY ACCOMMODATE UP TO 275 FOR A SEATED DINNER. ROUND TABLES MAXIMUM: 216 | RECTANGLE TABLES MAXIMUM: 275

- DO YOU OFFER IN-HOUSE CATERING?

ONE OF OUR PARTNERS IS RIGHT ON SITE! WOLF RIVER PIZZA & CATERING IS A GREAT OPTION FOR A BUFFET STYLE DINNER OR LATE NIGHT PIZZA OPTION.

- IF WE PROVIDE OUR OWN CATERER, IS THERE A KITCHEN AND/OR STORAGE/PREP AREA FOR THEM TO USE?

YES! WE HAVE A PREP KITCHEN WITH AN UPPER & LOWER ALTO SHAM, STAND UP COOLER, PREP COUNTER & A DISHWASHER. PLEASE NOTE: THE VENUE DOES NOT SUPPLY STAFF TO CLEAR PLATES/DISHES OFF TABLES.

- CAN WE HAVE OUR CEREMONY HERE?

YES- THE DECK IS AVAILABLE TO HOST YOUR CEREMONY. YOU ARE RESPONSIBLE FOR TABLES/CHAIRS, TENTS & ANY DÉCOR.

- DO YOU HAVE A LIQUOR LICENSE? CAN WE BRING IN OUR OWN ALCOHOL?

WE DO. - NO ALCOHOLIC/NON-ALCOHOLIC DRINKS MAY BE BROUGHT IN.

- CAN WE GET READY AT THE VENUE?

THERE IS NO DESIGNATED SPACE TO GET READY AT THE VENUE.

- WHAT TIME CAN WE ARRIVE ON-SITE?

DAY OF PACKAGES GRANT YOU ACCESS TO THE HALL FROM 8AM-1AM.

- WHAT TIME DO WE HAVE TO GET EVERYTHING OUT OF THE VENUE AFTER THE RECEPTION?

YOUR BELONGINGS NEED TO BE OUT OF THE VENUE NO LATER THAN 1AM FOLLOWING YOUR EVENT. LATE CHARGES WILL APPLY.

- CAN WE SET UP THE DAY BEFORE? OR CLEAN UP THE MORNING AFTER?

WE DO NOT GUARANTEE ACCESS TO THE HALL THE DAY BEFORE OR AFTER UNTIL ONE MONTH FROM THE EVENT. IF AVAILABLE, THERE IS A \$500 CHARGE. MORNING AFTER CLEAN UP MUST BE CONCLUDED BY 11AM.

# FREQUENTLY ASKED QUESTIONS

- WILL THERE BE A PERSON FROM THE VENUE ON SITE ALL DAY/NIGHT?

YES. BUT WE ASK THAT YOU PROVIDE US WITH A TIMELINE OF VENDOR SET UPS/DROP OFFS IN ADVANCE.

- DOES ANYONE FROM THE VENUE HELP WITH MOVING DECORATIONS TO/FROM THE CEREMONY AND RECEPTION LOCATIONS?

NO. MOVING YOUR ITEMS IS YOUR RESPONSIBILITY.

- ARE WE ALLOWED TO USE ANY VENDORS THAT WE WANT?
- YES. ALTHOUGH, CATERERS MUST BE LICENSED. WE ASK FOR A LIST OF CONTACT INFORMATION FOR ALL VENDORS.

- CAN WE BRING IN OUR OWN CAKE/DESSERTS?

YES! IT DOESN'T HAVE TO COME FROM A LICENSED BAKERY.

- DOES YOUR VENUE OFFER DAY-OF-COORDINATION?

NO. OUR STAFF IS SOLELY RESPONSIBLE FOR COORDINATION OF THE VENUE- NOT OUTSIDE VENDORS OR DAY OF TIMELINES.

- ARE THERE ANY DÉCOR RESTRICTIONS?

ALL DÉCOR MUST BE APPROVED BY THE VENUE. NO GLITTER, CONFETTI, BUBBLES, NO COMMAND STRIPS.

- DOES YOUR WEDDING VENUE ALLOW REAL CANDLES?

WE HAVE A NO OPEN FLAME POLICY- REAL CANDLES MUST BE IN A GLASS CONTAINER OF SOME SORT- WITH AT LEAST 3 INCHES OF GLASS ABOVE THE FLAME.

- DO YOU ALLOW FIREWORKS?

NO FIREWORKS WILL BE TOLERATED. THIS INCLUDES SPARKLERS & SMOKE BOMBS.

## PAYMENT SCHEDULE

NON-REFUNDABLE DEPOSIT OF \$1,500 AND SIGNED CONTRACT IS DUE TO HOLD DATE. REMAINING BALANCE PLUS ANY AND ALL RENTAL ITEM FEES MUST BE PAID ONE WEEK FROM EVENT.
