Navigating Housing Density: The Case of Rancho Palos Verdes

As urban landscapes evolve and populations grow, cities face the complex challenge of balancing housing needs with sustainable development. In Rancho Palos Verdes (RPV), this challenge takes center stage as the community undergoes the final stages of its Housing Element update, a crucial process mandated by the state every eight years to address housing.

For the current cycle, RPV has been tasked with accommodating 647 potential new housing units across various income levels by 2029. The Housing Element serves as a roadmap for identifying parcels within RPV that could potentially accommodate these new units. It also outlines necessary rezoning measures to facilitate their construction.

The current sixth cycle Housing Element process has proven to be more rigorous than previous iterations. RPV, along with many other cities, has had to resubmit its Housing Elements multiple times to the California Department of Housing and Community Development (HCD) to ensure compliance with state regulations.

To meet the Regional Housing Needs Assessment (RHNA) targets,

RPV is considering innovative approaches, including creating Mixed-Use Overlay Districts (MUOD) and Residential Overlay Districts (ROD). The MUOD would enable property owners to develop residential-only or mixed-use developments, while the ROD would allow for residential development with limited commercial, institutional, or recreational uses.

As RPV navigates the complexities of housing, it stands at the forefront of

innovation, leveraging strategic planning and community input to shape a vibrant future for its residents. Through collaborative efforts and initiatives, RPV embodies the spirit of thoughtful urban planning, ensuring a sustainable and prosperous tomorrow for generations to come. *

NEW EXCISE TAX PROPOSED IN CALIFORNIA ON FIREARMS AND AMMUNITION

AB 28 is a new proposed excise tax of II% on the retail sale of firearms, firearms precursor parts, and ammunition in the state, starting July I, 2024. The tax aims to fund various gun violence prevention, education, research, response, and investigation programs. The bill requires registration and permits for licensed firearms dealers, manufacturers, and ammunition vendors, and it includes provisions for the transfer of funds and implementation of these measures.

THE TIKTOK BILL

H.R. 7521: Protecting Americans from Foreign Adversary-Controlled

Applications. sponsored by Rep. Mike Gallagher (R-WI-8) this bill is designed to mitigate national security risks associated with TikTok. To prevent the Chinese government from accessing the data of American users, the bill forces the Chinese parent company, ByteDance, to either sell the app or prohibit it from being available in the U.S.

Senator Rand Paul has noted that TikTok's ownership is globally diversified, with 60% held by international investors, 20% by the app's Chinese co-founders, and 20% by its employees, including 7,000 Americans.

TikTok's data is stored within Oracle's cloud infrastructure in Texas, which is part of an effort to safeguard U.S. user information.

Despite being a bipartisan initiative, the bill faces opposition from both Democratic and Republican lawmakers, with 65 members of Congress voting against it.

Critics argue that the bill threatens First Amendment rights, suggesting that the government's role should not extend to regulating app availability in the market. They also point to the shifting media landscape, where social media platforms are supplanting traditional media as the primary news source for many, particularly younger demographics unfamiliar with networks like MSNBC, Fox News, or CNN. This shift prompts the question of who will shape public narratives in the absence of legacy media outlets.

There is considerable debate regarding the true intent behind this bill. Those who oppose the bill imply that the government's stance on national security seems

Legislation to know about, continues here selective, citing instances such as the tolerated presence of a Chinese spy balloon in Montana skies, Chinese purchases of U.S. agricultural land, and America's dependence on China for essential medical supplies like vitamins and antibiotics. These critics argue that if the administration were truly committed to protecting U.S. citizens from international dangers, it should address a wider array of significant threats originating from China, beyond just a social media app. The implications of this bill could extend beyond TikTok, potentially setting a precedent for future regulatory action against other platforms, such as X/Twitter.

This ongoing conversation raises critical questions about the balance between free speech, governmental oversight, and the strategic response to national security concerns. ★
