### VII.New Business:

A) Northfield's Paramedic Licensure Application LT Digital Paperwork was sent out. Reached a decision to submit service application to paramedic. 5 Paramedic affiliates. Will keep intercept contracts for back up? LT has had conversations with the local Selectboard, Vt EMS, and local leadership. LT is confident this is a sustainable program.

AFG Grant application is going to be submitted as well. How is the program going to be sustained? Staffing and advancement of staffing. Effectiveness, supply. So far the community has budgeted very minimal, but anticipates future budget support. This decision for the program was after the next budget was approved. What is the steps moving forward for the board? It needs Marks signature, and that won't happen with out a vote. Mark would like to see numbers to show sustainability. Fear that if we keep spreading the current Medics too thin, we are going to risk patient safety. Who is paying for training, who is supporting, what will the program look. These expectations have not been required for other services in the past. These are same service medics. They have affiliated for a reason. This was not asked of Montpelier or East Montpelier. We as a district board need to evaluate the feasible and sustainability. Jimmy agrees with Scott about holding Northfield accountable to things that other services that have not been held to. Joe has experience with being Chair and service upgrade States position is we can't stand in the way of a service expansion of service level. We could discuss with Ray Walker if we need further clarification. If they could cover, their own medic calls this would alleviate some of the medic shortages for intercepts.

Past practice doesn't automatically guarantee forward practice.

Chris is not in support BTEMS will be supplementing their paramedic needs, we need better coverage guarantees to really improve the system as a whole. Matt feels that the classes needing to produce budgets, but the can't request to see a service budget. They are not the same thing. Matt would be one of the Medics providing services.
