Medical Advisor - Sarah Sliva

- Email from UVM for FAST ED training -Joint Triage App. Waterbury and Mad River divert, but they are interested in Montpelier as well.
- Scott has concern, expectation that services SHALL go to UVM, that may not be as appropriate for Montpelier as they are closer to CVMC if patient is stable.
- Mad River Operationally consulting with CVMC, about transport destination decisions.
- The APP allows notifications to be sent directly to UVM.
- UVM or DHMC are the destinations that can be selected.
- Based on travel time

A) Training Coordinator - Scott Bagg

- Emailed documentation on last 2 course and 1 exam.
- Favorable result.

- Howie and Bob made the AEMT course possible. 20 people successfully have passed.
- Howie McCausland has made an "In -Kind" donation of hundreds of hours of instruction; his "In Kind" donation to the district is nearly \$5400. The result is that the money not used for the expense is free to be used for the equipment purchases as requested by the donor.
- 100 % AEMT psychomotor skills testing pass rate
- Some students need to complete ride time before they can take they cognitive test
- Over 1000 in profit on top of Howie's donation
- Online EMT course skills labs.
- Started with 13 down to 9- all 9 passed psychomotor- no significant financial exam.
- Exam held at Spaulding. 47 testing candidates
- 998.91 in profits for the district.
- CVCC course in progress, would like to test in May. Test May 22 @ Spaulding.
- Motion to assist in testing/ Second by Howie. Motion Carries.
- Instructors did well in overcoming the challenges that were before them in the AEMT class.
- Upcoming Courses. CTERT EMR course- looking for an IC. Scott has committed to assisting them. The paperwork has not yet been completed. May online cognitive, and skills lab more centralized. Paperwork forth coming.
- Potential Fall EMT Class: Bob and Howie would like to hold an in person EMT course in person this fall. Paperwork for June Meeting
