- A) Medical Advisor Ellen Stein Messages sent to heads of services for meeting and trainings so she can get out and meet the squads. Going to be starting monthly online QA. 1 hr. per month, online options will be available. Scott and Ellen are putting together a training schedule. Please send Dr. Stein what we are doing for PPE standards with COVID case increase. New service: secure.peer.org is a peer mentorship to assist first responders in resilience, and PTSD etc. One person per service to be trained.
- B) Training Coordinator Scott Bagg CTERT class down to 7. Expanding course past Labor Day for more practical experience before testing. Mad River EMT class so far 4 students signed up to start right after Labor Day. Recommendation that we Approve CVCC-EMT Class Lights application has been submitted. Joe Motion, second by Gordon. Motion Carries. Currently 13-14 already signed up for this class. Recommend October Exam Location TBD. Jenn Motion, Howie Second. Motion Carries. Vt 1st Responder Certification class, high energy about this course. There are still some pending questions around the course. Even people that take the course likely won't be able to practice until 1/22 because of the unanswered questions. District Training to be held Tuesday of odd months opposite District Board Meeting. Paramedic training will be scheduled on even months but are open to all certified providers.

C) CVMC Update- Jess Cullen Back to stricter guidelines for PPE surgical mask for patients, N95, gloves, and goggles for all providers. \$190 per case, at Waterbury. Joe is getting them a lot cheaper. Jess hasn't heard of any N95 shortage. Uptick in patient volumes in the ER, so patience is appreciated. Epic upgrade this fall, and unclear if "blue tops" will return. Working on plans for other high usage patients' w/ ER and EMS.
