EXCERPTS FROM LAWS OF THE ORDER

The Lodge Dues are per annum and may be paid semi-annually in advance of April 1st and October 1st of each year or annually in advance on April 1st of each year. An Applicant rejected, must wait six months before reapplying for membership.

Rejected Applicants shall have their Application Fees returned to them by the Lodge.

No Lodge can receive an Application from any person residing or being in the jurisdiction of another Lodge, except as otherwise provided for in the Statutes.

Should a Candidate fail, without good cause, to appear for Initiation within four months from the date of the Candidate's election, the Exalted Ruler shall declare the Candidate's right to Initiation (under such application and ballot) and also the Candidate's proposition fee forfeited.
