Our mission is to provide support and hope to individuals and families who are living with severe and permanent brain injury.


PURPOSE

Granite House offers a support network for families and advocates for people who cannot speak for themselves. Granite House is proud to have a strong connection to our community. Gifts of labor, materials, and donations from our contractors and neighbors helped to build this special place for our residents, their families, and our staff. We opened our doors in 2018 to families and continue to benefit as a nonprofit with donor-supported programs and volunteers.



Granite House is a licensed provider for the Minnesota Department of Human Services. Residents receive benefits from waivers, either the Community Access for Disability Inclusion (CADI) or the Developmental Disability (DD) waiver. These programs are designed to allow people who require nursing-level care to live in the community rather than in an institution.



ADVOCACY

Reality: younger adults who survive severe brain injuries have few choices for long-term care if families cannot care for them in their home.

- There is a lack of available housing
- Traditional long-term care may not meet the needs of those with brain injury
- Full care can be difficult for families
- Families need to heal, receive support and spend time with their loved one



ADMISSIONS CRITERIA

- Age 18 to 54 at admission
- Severe and permanent brain injury
- Medically stable, not requiring 24 hr RN
- Admissions process may begin as early as six months post-injury

PROGRAM LIMITATIONS

Granite House is not a rehabilitation facility but provides passive range of motion and weight-bearing therapy. We do not provide 24-hour Registered Nurse care.

24-HOUR COMPASSIONATE CARE

Granite House is a 4-bed community residence, a real home for the long-term care of people whose recovery after brain injury has plateaued at a low level of consciousness. Our residents are medically stable, needing full care due to a traumatic or acquired brain injury.

LOCATION

Granite House is located near Stillwater, Minnesota, convenient to services in the Twin Cities metro area. Massive oaks and maples surround the house, providing a peaceful and beautiful setting.

PURPOSE-BUILT FEATURES

- Open floor plan for wheelchair access
- Great room and family gathering areas
- Hydrotherapy room with roll-in shower
- Inviting outdoor spaces for residents
- Large, private bedrooms with ceiling lifts and built-in maple cabinets



SERVICES

- Full assist with all activities of daily living
- Staff to resident ratio of 1:2
- Brain injury-specific model of care, including music and sensory therapy
- Physician-directed weight-bearing and range of motion exercise in therapy suite

ACCESSIBILITY & SAFETY

- Zero clearance entries
- Ceiling lifts in all resident areas
- Elevator to therapy level
- Backup generator
- Fire sprinkler system
