Frequently Asked Questions:

- ? Do I really have to wear my mask during the entire show?
 - Yes, everyone must wear some type of facial covering while inside the building. The
 exception is for children under the age of two and anyone who has trouble breathing.
 Masks may removed only when eating or drinking.
- ? Do I have to have my temperature taken each day?
 - Yes If your temperature is 100.4 or higher, you will not be permitted to enter the show and will need to make arrangements for someone else to manage and/or break down your booth. Their temperature will be taken as well.
- ? Do I have to have a sanitizing station at my booth?
 - No, but we encourage use of hand sanitizer and will be placing six sanitizing areas around the facility. (Onefoot square.) We will provide signage, the hand sanitizer and wipes for you and the customers to use. If your booth is on a corner, we may ask you to place one in your area.



- ? Should I sign in on the Contract Tracing form each day?
 - Yes, with either an email or phone number.
- ? When a customer is ready to pay for their items, how do I make that a "no-contact payment"?
 - o If you are using a square or a credit card machine allow them to insert or scan their own card. If you need/want to scan it, consider sanitizing your hands before and after accepting their card. Some systems also allow for no signature required. If signature is required, it is recommended you wipe the screen or pen before and after each use.
 - Cash sales could be exchanged by using a bowl or a tray. Taking these sanitizing steps demonstrates care and concern for everyone's health.

- ? Do I have to change the arrangement of my booth to provide social distancing between me and adjacent vendors?
 - No, but a single booth is still ten feet long and eight feet deep. So, for your health and that of your neighboring vendor, we will ask that you try to arrange your position within your booth to limit your contact with them. Many vendors already have panels, screens or displays separating their booth from the next, so this may not be an issue. We ask that you try to place a social barrier where needed.
- ? Do I really have to watch the COVID-19 Safe Practices Video online?
 - Yes. Please follow the below link or copy and paste the attached link into your website browser. It's nine minutes long and it will ensure that you are informed and we are following the rules to be an ArtSafe event.

We understand these steps will require a different way of doing business, but it is important for your health and safety as well as the health and safety of our community. Taking personal responsibility is paramount to an ArtSafe event. We are all in this new way of life together. Thank you for your cooperation.


