This form documents your understanding of our warranties. Georgia Diesel Garage, L.L.C. must receive the Customer's agreement to these terms and conditions before we will begin work on any vehicle. By accepting the estimate via signature or electronic signature and providing Georgia Diesel Garage, L.L.C with a deposit, the Customer is authorizing Georgia Diesel Garage, L.L.C. to conduct repairs on the vehicle and agrees to the following warranty Terms and Conditions:

## *Labor Warranty Overview*

Georgia Diesel Garage, L.L.C.'s Warranty will cover **ONLY** the labor for which we performed during the repairs which will be listed on the invoice sheet.

- Any warranty work will be scheduled according to how busy the workload is. For example: This means it may be one day or two weeks before Georgia Diesel Garage LLC can look at your vehicle. If the customer can not wait then the warranty will be voided and the customer can go somewhere else and Georgia Diesel Garage LLC will **NOT** help with the payment for the repair.
- The Parts Manufacturer(s) are responsible for supplying new parts if parts fail as well as covering the labor cost to perform said repair.
- If the parts manufacturer does not supply the warranty parts, Georgia Diesel Garage, L.L.C. is **NOT** responsible for purchasing and supplying the parts needed unless the customer pays for them.
- If the manufacturer warranty does not cover labor, the Customer is 100% responsible for the labor on the bill.
- Warranty is not transferable from owner to owner.
- Georgia Diesel Garage, L.L.C. has the right to revoke Warranty Coverage for due cause.
- No warranty repairs shall be performed at any other shop or even by the customer themselves.

### *Warranty Times Overview*

1 month or 500-mile warranty for all labor under \$1,500

1 year or 8,000-mile warranty for all labor between \$1,500-\$2,500

2 year or 16,000-mile warranty for all labor over \$2,500+

Additional labor warranty can be purchased from Georgia Diesel Garage LLC

6 Month or 4,000 mile \$500

1 Year or 8,000 mile - \$1,000

### *Warranty Void:*

- Improper preventative maintenance.
- Failure due to overheating.
- Customer self-diagnosis/self-repair on part of the vehicle Georgia Diesel Garage, L.L.C. listed on "Invoice" sheet.
- Transferring ownership or selling the vehicle
- Failure due to fuel contamination, fuel wash, off-road diesel, or lack of lubrication.
- Accident, neglect, abuse, abusive driving.
- Unauthorized disassembly of the engine.
- Operating the vehicle when a known issue is present.
- Utilizing services from a competitor, without Georgia Diesel Garage, L.L.C.'s approval (unless more than 150 miles away. But still must verify through Georgia Diesel Garage LLC first)
- Warranty repairs not performed at Georgia Diesel Garage LLC will not be covered by Georgia Diesel Garage LLC.

**THIS INCLUDES; IF WE QUOTE ANY PARTS THAT WE SAY IS NEEDED FOR THE REPAIR OR MANUFACTURER WARRANTY GUIDELINES. IF THE CUSTOMER DECLINES TO REPLACE THAT PART OR PARTS, GEORGIA DIESEL GARAGE WILL NOT WARRANTY ANYTHING RELATED TO THOSE PART(S) FAILING, NOT WORKING OR ANY RELATED DAMAGE CAUSED BY TO THOSE PARTS.**
