## **Engine Rebuild Warranty:**

**Georgia Diesel Garage LLC 6 month or 5,000-mile warranty covers the work performed by our shop for head gasket repairs. And 1 year or 10,000-mile warranty any engine rebuild.**

1. Georgia Diesel Garage, L.L.C.'s Warranty covers ONLY the labor for which we performed during the repairs which will be stated in the "Work Performed" invoice sheet.
2. The "Work Performed" sheet Notes all of the technician's activities & work to ensure warranty compliance. If "Work Performed" sheet is not filled out correctly, Georgia Diesel Garage, L.L.C. is responsible for issues not noted correctly.
3. Parts Manufacturers must provide the specific and extends for the notated time (1 year or 2 year with milage) on invoice.
4. Georgia Diesel Garage, L.L.C. is not responsible for parts failure nor are they responsible for supplying the parts to fix the issue.
5. The parts manufacturer must replace the part, and cover labor repair cost.
6. Georgia Diesel Garage, L.L.C. has the right to inspect any component suspected of failure.
7. Georgia Diesel Garage, L.L.C. has the right to deny Warranty Coverage for any issue on this form, suspected issue, or untruthful customer issues.
8. This warranty does NOT cover any cracked blocks, cracked housings, cracked heads. All manufacturers or customers of said parts are responsible.

### **THE FOLLOWING WILL VOID THIS WARRANTY:**

1. Improper preventative maintenance; (failure to change oil and filters)
2. Failure due to overheating.
3. Failure due to fuel contamination, fuel wash, off-road diesel, or lack of lubrication.
4. Racing or any form of competition.
5. If damage is the result from accident or misuse.
6. Damage due to turbo charger failure.
7. Failure to have heads checked and resurfaced at machine shop.
8. Accident, abuse, abusive driving, or an operation for which it was not designed, or alteration from the original manufacturer's specifications.

## **Engine Rebuild Warranty Continued:**

9. Unauthorized disassembly of the engine.
10. Operating the vehicle when a known issue is present.
11. Failure due to the installation of a device not original to the vehicle, non-OEM
12. improper installation of any parts.
13. Improper break in procedure.
14. Failure to install a new Oil Cooler.
15. Failure to install new LPOP and housing
16. Utilizing services from a competitor, without Georgia Diesel Garage, L.L.C.'s approval (unless more than 150 miles away.) We stand behind our work and pride ourselves on honesty and integrity).
14. Failure to pay any money due to Georgia Diesel Garage LLC
15. Transfer Of Ownership.

**The Customer agrees that Georgia Diesel Garage LLC will NOT be responsible**

**for:**

1. Incidental or consequential damages
2. Lost profits, sales or income
3. Injury to person or property, oil, antifreeze, fluids or other substances
4. Lift, dock, storage, or shipping fees
5. Telephone calls
6. Substitute transportation, lodging, etc.
7. Unauthorized repairs
8. Towing charges or roadside assistance

\*\* If the Customer has STOCK head bolts and does any performance upgrades or anything to jeopardize the integrity of the head gaskets, the warranty is VOID.

\*\*\* If the Customer has ARP head studs level 1, he must not install any performance upgrades that are subject to jeopardize the integrity of the head gaskets or engine internals, or the warranty is VOID.

This Warranty form Becomes active when the Customer Signs this form. Form Must BE signed within 14 Days of Work Completed.
