Greetings from the West



Thoughts on increasing Lodge Attendance by Jordan S. Levitan, P.M. Norfolk Lodge No. 1 from the February 1987 Short Talk Bulletin of the Masonic Service Association.

The Lodge Investigating Committee:

The Masonic life of the prospective candidate begins with the Lodge Investigating Committee. A committee that consists of one Past Master, one line officer, and one member at large represents a cross section of the lodge.

The Master who dispatches the committee to the candidate's home with clearly defined directives takes the first step in laying a solid and dependable foundation. In its visit with the petitioner and his family, the committee should emphasize what Freemasonry is and what it is not. Their discussion should include the following:

- 1. The purpose of our Ancient Order is to build temples in the hearts of men;
- 2. The pursuit of excellence is one of Freemasonry's noblest aims;
- 3. Freemasonry is religious in nature, but it has no creed or theology, and it is not incompatible with one's religious beliefs;
- 4. Freemasonry has an obligation to the community, but it is not a service club;
- 5. Freemasonry stands for citizenship of the highest caliber, but it does not engage in political activity;
- 6. Freemasonry emphasizes one's obligations to assist the needy, but it is not a welfare organization;
- 7. Freemasonry is not a benevolent society providing insurance benefits; a Mason must make proper provisions for the protection of his family in the event of illness or death.

These and many other points are proper for the Lodge Investigating Committee to discuss with the petitioner and his family. This approach enables the petitioner to gain a better understanding of our principles and purpose, and the lodge can better judge his motives in seeking membership.

Resolution as to Eligibility of Junior Warden of Particular Lodges	NOW THEREFORE BE IT RESOLVED that in the Digest of the Masonic Law of Florida, Chapter 19, under Eligibility, Regulation 19.03.2 (page 183) be added to read as follows: 19.03.2 Every Brother who is nominated and elected to the office of Junior Warden of any Particular Lodge shall have completed Master Mason Exam I, Master Mason Exam II, and Master Mason Exam III before his installation to that office.	PASSED
Resolution to Increase Membership Retention and Participation by Allowing Entered Apprentice and Fellow Craft Participation in Conferring Degrees		WITHDRAWN
Resolution Regarding Committee on Work Members	NOW THEREFORE BE IT RESOLVED that the wording in Article IX, Section 7, of the Constitution be amended in part to read "The Committee on Work shall be composed of not fewer than ten nor more than eighteen members, of which one shall be the State Chairman, another may be a Vice Chairman, and at least one of which must be Spanish speaking." Resolution to Amend Chapter 48 Masonic Home, Trustees of Masonic Home and Emergency Relief Admission of Non-Masons to the Masonic Home under the Private Pay Plan	NOW THEREFORE BE IT RESOLVED that Chapter 48 of the Digest of the Masonic Law of Florida be amended to allow the Board of Trustees, with continued oversight from the Corporate Board, to allow admission to the Masonic Home of Florida to be extended to qualified non-Masons on a Private Pay basis, always reserving beds for Florida Masons	<u>PASSED</u>

Legislation		Grand Lodge Vote
Resolution to Change the Election of Lodge Officers	THEREFORE BE IT RESOLVED that By-Law Section 7.02 of Regulation 24.05 of the Digest of the Masonic Law of Florida, Uniform Code of By-Laws, be amended as follows: 7.02 Manner and Method of Election. – In the election of Officers, nominations shall be made in writing to the Lodge Secretary prior to no later than the opening of the first Stated Communication in December November and no other nominations will be accepted thereafter. The written nomination shall also include a statement from the Brother making the nomination that the nominee has agreed to accept the position if elected. The nominee shall also make a statement in writing stating that he will accept the position if elected no later than the opening of the first Stated Communication in November and no other acceptance letters will be accepted thereafter. Discussions regarding nominees for office may take place among Brethren, but not in open Lodge. A majority of all votes cast, respectively, shall determine. In each succeeding ballot for the same office, when more than two (2) members are voted for, the name or names of the Brother or Brethren having the lowest number of votes, shall, by order of the Master, be dropped; and all votes cast in derogation of said order shall not be counted. Resolution on Dual Members Qualifying for a Lodge U.D.	THEREFORE BE IT RESOLVED that inasmuch as dual members enjoy all the rights and privileges of regular members, that dual members be added to the list of eligible members to sign a petition for a Lodge U.D. and Regulation 42.07 of the Digest of the Masonic Law of Florida be amended to reflect such change.	PASSED
Resolution on Requirements of Amending Lodge By-Laws	THEREFORE BE IT RESOLVED that Regulation 24.04 of the Digest of the Masonic Law of Florida be amended to reflect the requirement of only one copy of amendments or new sets of By-Laws. 24.04 A Lodge adopting, revising, or amending By-Laws shall forward an original and three copies signed by the Worshipful Master and Secretary under the Seal of the Lodge, with date of approval and date of adoption shown thereon to the Grand Secretary who shall forthwith examine the same as to form, regularity of procedure, and compliance with Masonic Law	PASSED
Resolution on Emeritus Status of Masonic Home Residents	THEREFORE BE IT RESOLVED that Regulation 26.09 be amended to reflect the fact that a resident guest should not be placed on the Emeritus List of a Lodge if he is otherwise exempt from dues and per capita and that only resident guests of the Masonic Home who are admitted under the Life Care Plan will be automatically placed on the Emeritus List of the Lodge of which he is a member unless otherwise exempt from dues.	PASSED
Resolution on Dues Card	THEREFORE BE IT RESOLVED that the Digest of the Masonic Law of Florida be amended to allow for a printed facsimile or graphic of the Seal of the Lodge on the plastic dues cards, amend the requirement of the signature of the Lodge Secretary, and require the signature or printed signature of the Grand Secretary on the plastic dues cards. BE IT FURTHER RESOLVED that the Digest of the Masonic Law of Florida be amended to rescind the requirement for the Lodge Secretary to	PASSED
Resolution for Lodge Co-Ownership of Property	THEREFORE BE IT RESOLVED that we allow co-ownership of a property or building by two or more Lodges in the form of a Masonic Center Association. BE IT FURTHER RESOLVED that Chapter 28 LODGE PROPERTY, LODGE BUILDING, AND LODGE ROOM of the Digest of the Masonic Law of Florida reflect the underlined changes in Regulation 28.01 to include the new language. 28.01 WHEREAS, each Particular Lodge of this Grand Jurisdiction is by Act of Legislature incorporated as a separate and independent body, politic, and corporate, and as such has all corporate powers, including the right to acquire, own, hold, and convey real and personal property under its Masonic name as set out in its Charter. THEREFORE, all Particular Lodges within this Grand Jurisdiction are instructed that title to any property hereafter acquired by such Particular Lodge, either by gift, purchase, or other means, shall be held in the name of a Masonic Center Association. All Particular Lodges are prohibited hereafter from placing the title to any of their Masonic buildings in any name other than their own unless they are organized for co-ownership in the form of a Masonic Center Association. All property ownership transactions involving a Masonic Center Association must be pre-approved by the Grand Master.	PASSED
Resolution for Masonic Center Association	THEREFORE BE IT RESOLVED that we allow Masonic Associations to be formed consisting of two or more Lodges for the purpose of co- ownership of a property or building.	REJECTED
Proposed Resolution to Amend Regulation 5.02	NOW THEREFORE BE IT RESOLVED that the Digest of the Masonic Law of Florida, Regulation 5.02 be amended to encompass background checks. BE IT FURTHER RESOLVED that each candidate for election in the Grand Lodge Line sign a statement that he does not object to having his background check information being distributed to the Craft.	REJECTED


