College Application Counseling:

College application counseling focuses primarily on brainstorming, structuring, editing, and proof-reading college essays.

Academic Tutoring:

Academic tutoring may be used to assist students through academic classes.

Group Tutoring:

Groups must be put together by students and families.

2-person group tutoring: each student charged 67% of the individual rate.

3-person or 4-person group tutoring: each student charged 50% of the individual rate.



Educational Services

Conditions:

- *Standard SAT and/or ACT Tutoring Program clients:* payment will be divided into four pieces. A retainer to cover the first two tutoring sessions must be made once a tutoring schedule is in place to secure the schedule. The remaining payments are due by the 4th, 8th and 11th sessions.
- *Expedited SAT or ACT Tutoring Program clients:* payment will be divided into three pieces. A retainer to cover the first two tutoring sessions must be made once a tutoring schedule is in place to secure the schedule. The remaining payments are due by the 4th, 6th sessions.
- *Standard College Application Assistance Program clients:* payment will be divided into three pieces. A retainer to cover the first counseling session must be made once a counseling schedule is in place to secure the schedule. The remaining payments are due by the 2nd and 4th sessions.
- *Academic Tutoring Set clients:* payment is due by the beginning of the 2nd session.
- *Single session clients:* payment is due at each session.
- *Remote college counseling clients:* payment is due upon completion of each two hours of counseling and/or upon completion of the counseling.

- A parent, guardian, or legal adult 18 years of age or older must be present in the household at which a tutoring or counseling session is held for the duration of the session.
- If a client cancels a session within 48 hours of the session or does not arrive at a scheduled session, the client will be charged for half of the prorated cost of the session. Flexibility in this regard will be offered in cases of illness or emergency.
- If a tutor or counselor cancels a session within 48 hours of the session or does not arrive at a scheduled session, the session will be rescheduled and the client will be reimbursed or credited for half of the prorated cost of a session. Flexibility in this regard may be asked in cases of illness or emergency.
