**Setup /Tear down Times:** you will have plenty of space to unload your items, double gates lead to the walled garden area. Vendors to provide their own tents/tables. Chairs will be provided.( If you need to rent 6' banquet table check below.)

Please arrive and get **set up fully** by 5:00pm. Parking is in back of the brewery. You can start setting up as early as 1:00PM

All boxes, bags, carts or anything else not in keeping with the gypsy village look need to be removed before doors open to public, or hidden underneath tables with table coverings.

All food items, drinks etc. need to be off your tables before start of event.

**Electricity:** There is a \$20.00 added fee if you are needing electric at your tent. Please provide an extension cord of at least 50'. We will do our best to locate you near a power source, space available. The extension cords need to run along the walls, no cords can pose tripping hazard to guests.
