- Results of e-vote on 10.0 Nominating Policy Nine e-votes out of 12 agreed in changing the police (the biggest change was eliminating the 3 month waiting period for new Board members to vote.)

- Principal's Report (20 min)
 - Watershed Data Project, ELA, and MCAP including areas of growth and improvement
 - PBL Schoolwide Projects and writing
 - Watershed ESSA Star Ratings various ways to collect data
 - ELA proficiency discussed by grade level
 - ELA MCAP proficiency by grade and race were looked at. Next steps were discussed to impact continued growth.
 - Math MCAP WPCS uses the Bridges curriculum. Proficiency by grade level, race, and next steps was discussed.
 - Kelley suggested as a board we take a deeper dive into the numbers, check counterparts, and help support forward progress.
 - Eric- Commented we should be looking at trends regarding race and how to close gaps.
 - Lori would like to address more questions regarding these results next month as we look at how to further support students.

• Executive Director's Report (10 min)

- o First 100 days Plan update
- Current Grants Summary
 - Initial round of work on the playground through the Baltimore County Community Improvement grant
 - DOE Renew America's Schools Grant RFP for first two budget periods of grant is complete. HVAC upgrades, exterior door replacements, electrical upgrades, and replacing some lighting with LEDs can begin. The bulk of the work would be throughout Summer 2025. Various reports are coming up. There are monthly check-in meetings occuring. Additional proposals are due January 3, 2025.
 - Potential Grants were explored.
- Modular Classroom Units and Temporary Trailers New Edge received permit stamps.
 The temporary use permit is still pending- hoping to get it Friday or early next week. The signed lease amendments from the archdiocese still need to be returned. There are hopes that the installation process will begin in the next 2-3 weeks.
- Modular classrooms- process is continuing
- Facilities updates Waiting for final elevator repairs scheduling and replacing 2 broken windows. WPCS is enlisting help from PTO and community for playground repairs and hoping to do an upgrade by next school year for the playground.
- Lori sends a morning memo regarding weather for plan classroom rearrangement daily.

 - September 3rd PTO meeting had 60 people logged into the virtual meeting.

about pending or potential litigation"; (9) "To conduct collective bargaining negotiations or consider matters that relate to the negotiations"; (10) "To discuss public security, if the public body determines that public discussion would constitute a rick to the public security including (i) the deployment of fire and police.
discussion would constitute a risk to the public or to public security, including: (i) the deployment of fire and police services and staff; and (ii) the development and implementation of emergency plans"; (11) "To prepare, administer, or grade a scholastic, licensing, or qualifying examination"; (12) "To conduct or discuss an
investigative proceeding on actual or possible criminal conduct"; (13) "To comply with a specific constitutional, statutory, or judicially imposed requirement that prevents public disclosures about a particular proceeding or
matter"; (14) "Before a contract is awarded or bids are opened, to discuss a matter directly related to a negotiating strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process"; (15) "To discuss
cybersecurity, if the public body determines that public discussion would constitute a risk to" (i) "security assessments or deployments relating to information resources technology"; (ii) "network security information,"
such as information that is related to passwords, personal ID numbers, access codes, encryption, security devices, or vulnerability assessments or that a governmental entity collects or maintains to prevent, detect, or investigate
criminal activity; or (iii) "deployments or implementation of security personnel, critical infrastructure, or security devices."
