Watershed Public Charter School, Inc is a nonprofit, tax-exempt organization. Maintenance of its tax-exempt status is important both for its continued financial stability and for public support. Therefore, the IRS as well as state regulatory and tax officials view the operations of WPCS as a public trust, which is subject to scrutiny by and accountable to such governmental authorities as well as to members of the public.
