Indemnification.

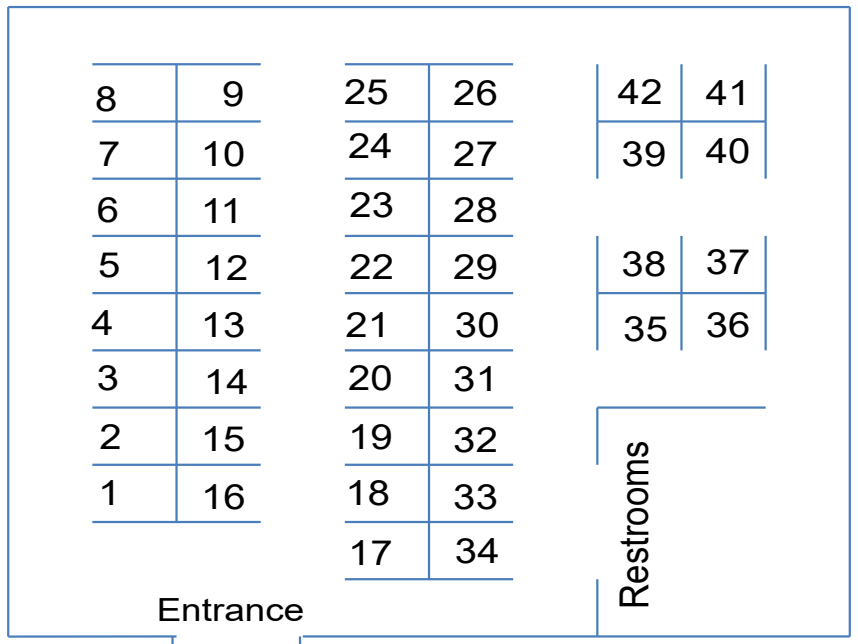

Must provide certificate of insurance with Tradeshow Promotions LLC as additional insured with application, or by December 1st, 2018.

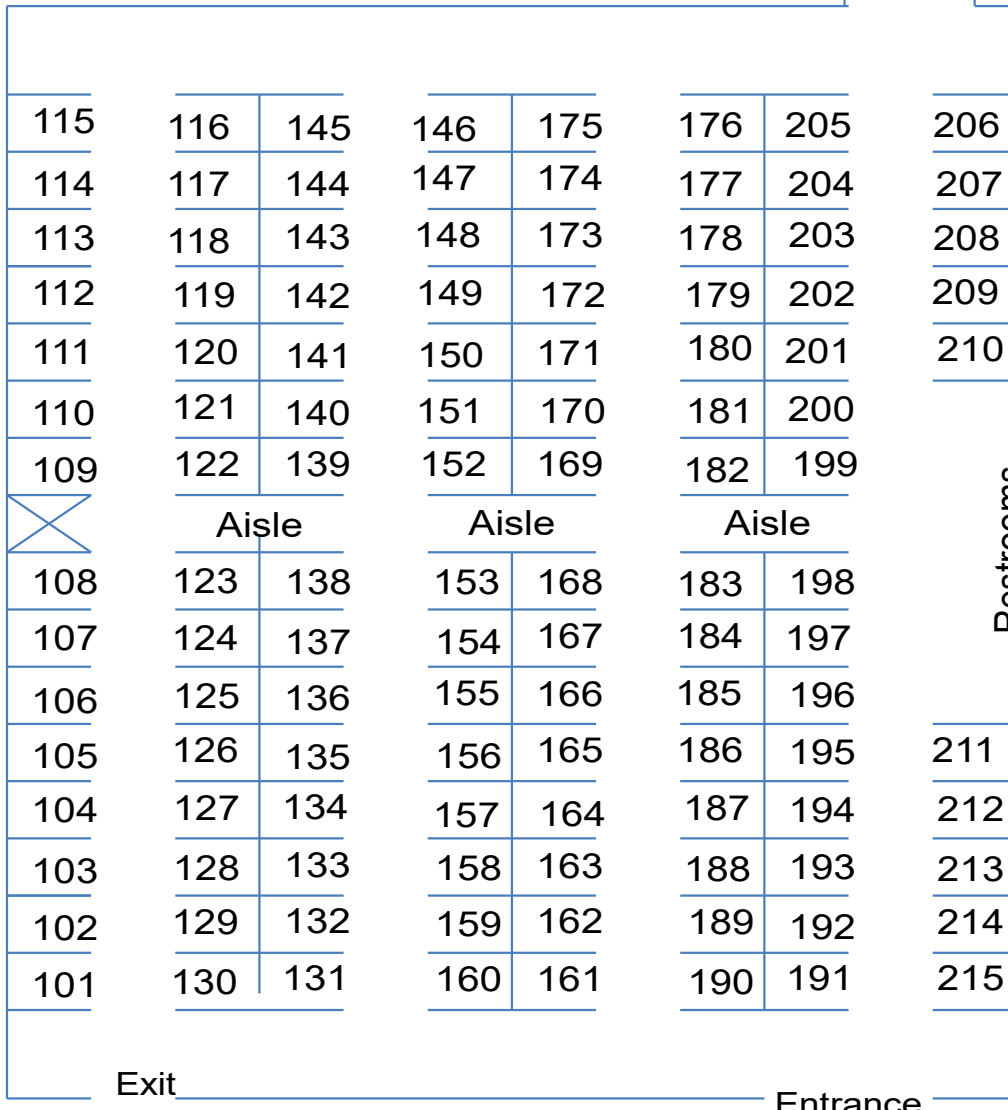
