PETITION DEMANDING RELIEF FOR KANSAS DRIVERS WHO'S LICENSE HAS BEEN SUSPENDED DUE TO NONPAYMENT OF TRAFFIC FINES AND FEES

WE the PEOPLE of the state of Kansas, do hereby request that our legislators *introduce and pass legislation* that addresses and provides Kansas motorists with *statutory relief by reducing and/or eliminating* the monetary fees, fines and penalties related to Driver's License Suspensions. These statutory amendments must also provide an *alternate method of payment* such as community service and/or completing a Driver's Education Safety Course at the rate of \$10.00 an hour as opposed to the \$5.00 an hour as dictated in KSA 8-1567 (f) and KSA 21-6604 (q).

WE the PEOPLE also request that our legislators introduce and pass legislation that directs Kansas county and municipal courts to implement an annual Traffic Amnesty Week to allow Kansas motorist who have had their license suspended due to nonpayment of a traffic fine with an opportunity to get their license reinstated. The 90 day waiting period, plus extra Driving on Suspended and \$100 per charge additional fines in KSA 8-262 must also be able to be waived by the Court so the Department of Revenue can reinstate the driver's license.
