### **Community Service In Lieu of Fines**

By order of the Chief Judge of the City of Wichita Municipal Court, persons assessed a fine may perform community service at an agency approved by the City of Wichita Municipal Court in lieu of paying a fine ordered by the court. Unless otherwise specified, community service hours will first be applied to traffic cases wherein the defendant's driver's license is suspended. Hours will be applied to the oldest case first. Community service cannot be applied to court costs or State mandated assessments.

#### INSTRUCTIONS

It is your responsibility to arrange and document community service hours. Follow these steps to have community service hours applied to your fines.

- Contact an agency pre-approved by Municipal Court and arrange community service hours. An approved agency list is attached.
- Authorization is required prior to performing community service at an agency that hasn't been pre-approved by the Court. Please contact the Municipal Court Community Service Coordinator, 268-4367 to determine if a worksite that hasn't be pre-approved is acceptable.
- Community service will be credited at the rate of \$8.00 per hour. Timesheets provided
  by the Court must be used to record the dates, time and total hours worked at each visit.
  The timesheet must be certified by an authorized person at the agency where hours are
  completed. Use a separate timesheet for each agency.
- Turn in the time sheet at the Customer Service window in the Municipal Court Clerk's Office within two weeks of completing the hours. The time sheet is the only proof that you are doing community service and it MUST be returned. Updates of your court case balance will be sent to you monthly by email.
  - \*\*\*If you have cases on a payment plan, community service hours must be submitted no later than the 1st of each month.\*\*\*
