Subscription for Emergency Services Agreement

This agreement is in effect for 12 months from this designated date,

EFFECTIVE DATES: _____ thru June 30, 2025

IT IS THEREFORE MUTUALLY UNDERSTOOD AND AGREED AS FOLLOWS:

1. **Purpose:** Concho Fire District shall provide emergency services to the individual property owner signing (Signer) this agreement under the following terms and conditions.
 - a. The sole purpose of this agreement is to provide Emergency services to individuals who reside outside of the Concho Fire District boundaries at a reduced cost.
 - b. The parties expressly agree that this contract shall not affect the standard of care exercised by the Concho Fire District in providing Emergency Services.
2. **Duration/Scope:** This agreement shall run for 12 months, and is binding upon all signatory parties, and their assigned and successors interest.
3. **Service provided:** The Concho Fire District shall provide an appropriate response to **Fire/Medical and Motor Vehicle Accidents (MVA's)** they are dispatched to.
 - a. The parties herein agree that Concho Fire District may respond with fewer units or personnel on the occurrence of any presently unforeseen circumstances, such as a major fire or several concurrent fires, or emergency, reduction in force, road closure or other situation in which there is a shortage of personnel or equipment
 - b. If all fire units are busy or attending other calls or circumstances the Concho Fire District will make every effort to extricate from preceding incident in order to attend to and respond to each succeeding fire suppression/emergency call from the individual. What this means is that if emergency resources are not available or unable to extricate from a preceding incident the Concho Fire District will not be responding to your incident, although every effort will be made to contact mutual aid resources from neighboring Fire Districts to respond to your emergency incident.
4. **Response Time:** The Concho Fire Department shall respond to each individual emergency call in the most responsible and expeditious time possible. The Concho Fire District and the individual hereby acknowledges that response times are subject to variations due to existing weather conditions, travel distances, traffic conditions, property and road identifications, lack of adequate maps and familiarity with the out of district areas, and provisions of standard access to individual residences as defined in section 6.
5. **Signer Obligations:**
 - a. The signer shall provide the Concho Fire District with current routing information of their residence at the time of the emergency call.
 - b. If the signer leases the subject real property, the signer shall provide a copy of this agreement which shall be executed by any tenant who leases said property subsequent to the execution of this agreement. Failure to do this shall cause signer(s) to indemnify and

hold the Concho Fire District harmless for any and all claims asserted by the Property Owner or the Tenant and hereby agrees to absorb all liability therein for said nondisclosure.

6. **Standard Access:** The Concho Fire District and the individual hereby specifically acknowledge that standard access roads sufficient to allow the Concho Fire Department fire equipment to reach the scenes of emergency calls are significant factors in the Concho Fire Department's ability to respond to emergency calls within a reasonable and expeditious time.
7. **Finance:** As consideration and payment for Emergency services to be provided by the Concho Fire District's undertaking to make all reasonable attempts to respond to Fire/Medical/MVA emergency call even in cases of substandard access to the scene, the individual Expressly waives claim, expressly disclaims, and hold harmless the Concho Fire District from any and all liability against the Concho Fire District (jointly and severally) for any cause of action, controversy or claim by the signer, or an invitee, licensee, or other party operating signer's real property, arising out of a Fire/Medical/MVA/emergency related incident and the Concho Fire District response thereto.

I _____ (printed name), elect to receive Emergency Services from the Concho Fire District by subscription. I understand that an annual fee of \$165.00 will be collected from the signer before this document is deemed effective.

I further understand that the Concho Fire District may respond in the absence of a subscription, and I may be billed for those services at non-subscriber rates.
