She introduced her guest speaker; Kamm Howard, Co-Chair of the National Coalition of Blacks for Reparations in America (N'Cobra); a Member of the National Reparations, Commission. Robin Simmons, Alderwoman of Evanston, Illinois of the 5 <sup>Th</sup> Ward.

Mr. Kamm Howard presented his PowerPoint on Reparations and stated that Dr. Willie Wilson started conversations on reparations with legislators and activists. He stated that Richard Boykin took the initiative to create a resolution and the importance of reparations. Chairman Sawyer introduced the resolution and passed City Council on September 19, 2019.

Mr. Kamm Howard stated that the Committee on Health and Human Relations held a meeting on June 4th, 2020. The meeting that took place was to have a further discussion on reparations and to speak of the three foundations of genocide, plunder, and apartheid. The first speaker was Cecile Johnson, who spoke on genocide, obesity, heart disease, and homicidal deaths. Mr. Jack McNamara spoke on plunder in which a 3-4 billion contract buying scheme lead people to be taken advantage in paying higher interest rates.

The next speaker was Robbin Rue Simmons, Alderman of the 5 <sup>th</sup> Ward, from Evanston, Illinois. She thanked Chairman Sawyer and Kamm Howard for their leadership in Reparations. Alderwoman Robbin Rue Simmons became Alderwoman in 2017 for Evanston. She was passionate about receiving fairness and equity in her community. Simmons served as the alderwoman of the 5 <sup>th</sup> ward. As alderwoman, she led the passage of the United States' first government-funded reparations legislation the local reparations initiative is being funded by the first \$10 million of adult-use cannabis sales tax revenue collected by the City. The first stage of the reparations program is focused on homeownership. She suggested that to achieve reparations with other local governments, you must partner with other organizations, businesses, and entities and that you will need proper funding to provide financing.

Chairman Sawyer asked Kamm Howard to explain in detail what exactly reparations are; Kamm responded with the 5 components; Non-repetition if it is still ongoing, restitution paid back what is owed, compensation, satisfaction, and rehabilitation.

Vice-Chairman Vasquez stated that he is honored to be part of this Subcommittee.

Alderman Brookins, Alderwoman Smith, Alderwoman Mitts, Alderwoman Rodriguez Sanchez, Alderwoman Austin, and Alderwoman King all spoke on the reparations and thanked Chairwoman Coleman and Chairman Sawyer for their leadership.
