

Shared Use of Venue Policy and Risk Management.

Summer Adventure Camp (SAC) delivers Ofsted registered childcare during the Easter and Summer holidays at a number of locations in West Sussex and Brighton & Hove.

In 2024 we are operating at:

- The Mill Primary Academy in Crawely
- East Grinstead Sports Club
- Cardinal Newman School in Hove

Our venues are chosen based on a number of criteria that includes:

- Location
- Accessibility
- Suitability

Meeting these criteria means that at times we are using venues that have shared use, this could be from organised school or youth group users, individual users or building works that are happening at the time. In order to ensure we meet our safeguarding duties it is important that we acknowledge and understand this use. This will be through a number of steps:

- 1. Agreeing with the venue where we have sole or shard use. This might be a mixture of arrangements such as sole use of the toilets but shared use of a playing field.
- 2. Understanding where there is shared use who the other users are, when they will be on site and what usage they have.
- 3. Identify any issues or problems.
- 4. Where needed discuss with other users to set clear boundaries / usage.

Inherent within this process will be Generic / Specific / Dynamic Risk Assessments.
