STATE OF LOUISIANA ARTICLES OF INCORPORATION OF

BELLINGRATH LAKES PROPERTY OWNER'S ASSOCIATION, INC.

PARISH OF EAST BATON ROUGE 

BE IT KNOWN, that on this 23rd day of August, 2000, before me, the undersigned Notary Public, in and for the Parish and State aforesaid, personally came and appeared the undersigned, who, declaring himself to be of full age of majority and a resident of the Parish of East Balon Rouge, State of Louisiana, in the presence of the undersigned competent witnesses, who, availing himself of the provisions of the Louisiana Nonprofit Corporation Law, LSA-R.S. 12:201, ct seq., as amended, does hereby organize a non-profit corporation in accordance with these Articles of Incorporation, to-wit:

#### ARTICLE I

The name of this non-profit corporation is Bellingrath Lakes Property Owner's Association, Inc.

#### ARTICLE II

The purpose for which this non-profit corporation is formed is to engage in any lawful activity for which non-profit corporations may be formed in the State of Louisiana.

# ARTICLE III

This non-profit corporation shall enjoy perpetual corporate existence unless sooner dissolved in accordance with law.

#### ARTICLE IV

This corporation is a non-profit corporation under the laws of the State of Louisiana. The conduct of its business is to be such as to entitle it to secure a nonprofit designation by the Internal Revenue Service, consistent with the Internal Revenue Code of 1954, as amended, and the regulations pursuant thereto, and thereafter to maintain such designation.
