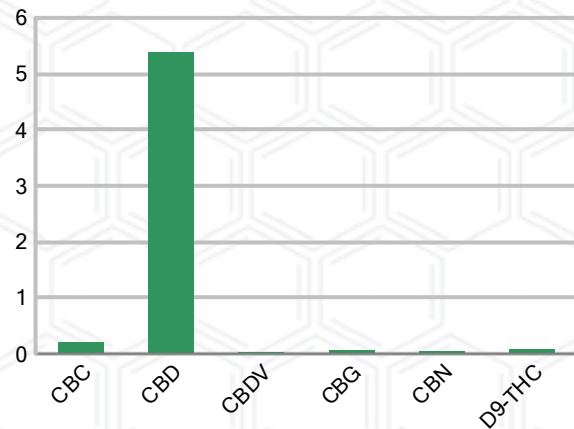
Ratio of Total Potential CBD to Total Potential THC **70.05 : 1**
