- 1. Call to Order Facilitator: Kevin Gaeddert
- 2. Quorum: (Membership majority must be persons with disabilities, family members, and guardians). We have a quorum. There were 6 persons with disabilities/family members/guardians out of 10 members present.
- 3. HMCDDO Community Council Roles and Responsibilities
  - Capacity Building & Dispute Resolution
  - This Council is also the voice and plays a role in the passage and or the amending of HMCDDO policies and procedures.
- 4. National/State/Local Updates: National:
  - HCBS Relief Act of 2023
  - October is National Disability Employment Awareness Month.
  - SSI Savings Penalty Elimination Act: (S 2767 / HR 5408) The SSI Savings Penalty Elimination Act would raise the resource limits, which have not been changed since 1984, to \$10,000 for individuals (currently @ \$2,000) and \$20,000 for married couples (currently @ \$3000), and index them to inflation moving forward.
  - Rehabilitation Act 50: At the Department of Labor, our North Star is building a more accessible and equitable workplace for all, including workers with disabilities. While we have made substantial progress towards fulfilling the promise of access and equity, there's still room to go. We know that many workers with disabilities are still being paid wages far below the federal minimum wage under section 14(c) certificates. We have been urged by not just advocates but also by numerous oversight entities and advisory groups, ranging from the Government Accountability Office, the National Council on Disability, the U.S. Commission on Civil Rights, to the DOL's own Advisory Committee on Increasing Competitive Integrated Employment, to carefully review the 14(c) program and prioritize competitive integrated employment.

- 6. HMCDDO Capacity Report:
  - There is an effort within the InterHab groups to assist in establishing fiscal stability for the IDD system via annual funding adjustments based on inflationary indexes. Push for a funding adjustment based on an average of the previous two years' CPI increases (6% est.) Advocate with KDADS for completion of a biennial IDD funding study consistent with legislative direction from the 2023 Legislative Session.

- Our service area currently has 0 available providers for residential services, 2 providers for day services and 2 available providers for TCM services. Our service area also has 6 fiscal management providers (assists individuals/guardians with self-directed Personal Care Services).
- ResCare began providing Shared Living in our service area beginning 07/2023.
  - Shared Living is a nationally recognized model for habilitation or residential services for individuals with Intellectual and/or Developmental Disabilities (IDD). In Shared Living, one to two Participants share a home with a family or single adult's family (the Contractor). The Contractor lives with the Participant and provides supports to them in accordance with the Participant's person-centered support plan and in compliance with Article 63. A Residential Licensed Provider trains and provides ongoing support for the Contractor. The Contractor and the Participant can utilize Relief Coverage with mutual agreement on where and with whom the Participant will be staying, along with Residential Licensed Provider support.
