Harvey-Marion CDDO: Adverse Incident Report Protocol

Intended outcome: Individuals supported through the home and community-based intellectual/developmental disability service system, who experience adverse incidents, receive immediate safeguards and responsive follow-up/resolution, reported in the statewide adverse incident reporting system for individual and systemic quality assurance monitoring.

Compliance Expectation: Harvey-Marion County CDDO and all affiliated providers will comply with KDADS policy regarding reporting Adverse Incidents in the KDADS web-based Adverse Incident Reporting System within 24-hours of knowledge of the adverse incident.

Who reports: Any affiliated provider or case manager or Harvey-Marion County CDDO staff upon knowledge of an adverse incident.

HMCCDDO Notification Expectations:

- 1) Reporter will access KDADS AIR reporting web link to enter report information.
- 2) Reporter will print report, or copy and paste content to a new document, before electronic submission to KDADS.
- 3) Reporter will email scan or copy of AIR report to: KDADS Quality Management Specialist (QMS), Harvey-Marion County CDDO, MCO Care Coordinator, and contacts for all service providers serving the individual, including the case manager if the reporter is not the case manager.
- 4) As applicable - Reporter will notify family/legally responsible party of an involved minor child, and guardian/legally responsible party of an involved adult.

Self-directed services: Harvey-Marion County CDDO director/designee will inform individuals choosing to self-direct of the responsibility to report critical/adverse incidents to the individual's case manager, using the Self-Direction Checklist.

Replacement: This revised protocol REPLACES previous versions of the Harvey-Marion County CDDO Adverse Incident Report Protocol.
