HMCDDO Notice of Information/Privacy Practices for Webforms

This "Notice of Information/Privacy Practices" is used to inform website/webform visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Webform Service. If you choose to use our Webform Service, then you agree to the collection and use of information in relation with this policy. The Personal Information that we collect are used for providing and improving the Webform Service. We will not use or share your information with anyone except as described in this Privacy Policy.

Information Collection and Use

For a better experience while using our Webform Service, we may require you to provide us with certain personally identifiable information, including but not limited to your name, phone number, and postal address. The information that we collect will be used to contact or identify you.

Log Data
