

## NOTICE OF ELIGIBILITY REQUIREMENTS AND ELECTION PROCESS

### CSEA STATEWIDE OFFICERS

Persons running for office may petition and appear on a ballot individually or as a slate. To constitute a slate for Statewide office, the slate must contain a candidate for each of the Statewide offices: ***President, Executive Vice President, Secretary and Treasurer.***

To be eligible to seek office, a candidate must be at least 18 years of age, a member in good standing of CSEA since January 1, 2019, shall not have been a member of a competing labor association or union since January 1, 2019, shall not currently be serving a disciplinary penalty imposed by the Judicial Board of CSEA, and must not have been the subject of a bonding claim by the Association or disqualified from being covered by the Association's surety bond.

In addition to meeting the above eligibility requirements, Individual and Slate Nominating Petitions, carrying the original signatures, along with the 10-digit CSEA ID numbers or the last four digits of Social Security numbers, of not less than 1,000 members in good standing eligible to vote in the election, must be submitted to CSEA Headquarters in a timely fashion. \*Please take note that Social Security numbers not on file cannot be verified.\*

Nominating Petition Request forms may be obtained from Local Presidents, CSEA Region offices, and CSEA Headquarters beginning August 5, 2019. **A request form may be filled out and returned to Headquarters and/or the Region offices ahead of time, but Nominating Petitions will not be released until Tuesday, September 3, 2019, the first day of the petitioning period.**

**After obtaining the required number of signatures, along with CSEA ID numbers or last four digits of Social Security numbers, the original Nominating Petitions must be received no later than 5:00 p.m. on Thursday, October 3, 2019, by the CSEA Membership Department, 143 Washington Avenue, Albany, New York 12210.** The submission of completed nominating petition forms is the responsibility of the person seeking to become a qualified candidate. Only original forms will be accepted. Candidates may make and retain a copy of the petitions for their own records.

**Ballots will be mailed on Wednesday, January 22, 2020, based on the membership records of CSEA Local 1000, AFSCME, AFL-CIO as of December 1, 2019.**

Any member believing himself or herself aggrieved by any aspect of the nomination or election process may file a written protest with the Statewide Election Committee, CSEA, Inc., 143 Washington Avenue, Albany, New York 12210. Such written protest must be postmarked or electronically filed within ten (10) calendar days after the member knew or should have known of the act or omission complained of.

# NOTICE OF ELIGIBILITY REQUIREMENTS AND ELECTION PROCESS

## CSEA REGION OFFICERS

Persons running for office may petition and appear on a ballot individually or as a slate. To constitute a slate for Region office, the slate must contain a candidate running for the following Region offices: ***President, at least three (3) Vice Presidents, Secretary and Treasurer.*** The slate also may include candidates for such other offices as have been created pursuant to Article IV of the mandated Region Constitution and described in the particular Region's By-Laws.

To be eligible to seek office, a candidate must be at least 18 years of age, a member in good standing of the Region since January 1, 2019, shall not have been a member of a competing labor association or union since January 1, 2019, shall not currently be serving a disciplinary penalty imposed by the Judicial Board of CSEA, and must not have been the subject of a bonding claim by the Association or disqualified from being covered by the Association's surety bond.

In addition to meeting the above eligibility requirements, Individual and Slate Nominating Petitions, carrying the original signatures with the 10-digit CSEA ID numbers of not less than 500 members in good standing eligible to vote in the election, must be submitted to CSEA Headquarters in a timely fashion.

Nominating Petition Request forms may be obtained from Local Presidents, CSEA Region offices, and CSEA Headquarters beginning August 5, 2019. **A request form may be filled out and returned to Headquarters and/or the Region offices ahead of time, but Nominating Petitions will not be released until Tuesday, September 3, 2019, the first day of the petitioning period.**

**After obtaining the required number of signatures, along with CSEA ID numbers, the original Nominating Petitions must be received no later than 5:00 p.m. on Thursday, October 3, 2019, by the CSEA Membership Department, 143 Washington Avenue, Albany, New York 12210.** The submission of completed nominating petition forms is the responsibility of the person seeking to become a qualified candidate. # NOTICE OF ELIGIBILITY REQUIREMENTS AND ELECTION PROCESS

## **CSEA STATEWIDE BOARD OF DIRECTORS** ***(State and Local Government Representatives)***

Persons running for a Board seat may petition and appear on a ballot individually or as a slate. To constitute a slate, there must be a candidate for each of the Board seats to which the voting jurisdiction within the Division or political subdivision is entitled in that election.

### **State Departmental Representatives:**

To be eligible to seek office, a candidate must be at least 18 years of age, a member in good standing of the applicable voting jurisdiction for the Board seat being sought since January 1, 2019, shall not have been a member of a competing labor association or union since January 1, 2019, shall not currently be serving a disciplinary penalty imposed by the Judicial Board of CSEA, and must not have been the subject of a bonding claim by the Association or disqualified from being covered by the Association's surety bond.

### **Local Government Representatives:**

To be eligible to seek office, a candidate must be at least 18 years of age, a member in good standing of the applicable voting jurisdiction of that county or, in the case of Educational Representatives, of the Region, since January 1, 2019, shall not have been a member of a competing labor association or union since January 1, 2019, shall not currently be serving a disciplinary penalty imposed by the Judicial Board of CSEA, and must not have been the subject of a bonding claim by the Association or disqualified from being covered by the Association's surety bond.

In addition to meeting the above eligibility requirements, Individual and Slate Nominating Petitions, carrying the original signatures with the 10-digit CSEA ID numbers of not less than ten percent (10%) and no more than 300 signatures, of the members in good standing eligible to vote in the election, must be submitted to CSEA Headquarters in a timely fashion.

Nominating Petition Request forms may be obtained from Local Presidents, CSEA Region offices, and CSEA Headquarters beginning August 5, 2019. **A request form may be filled out and returned to Headquarters and/or the Region offices ahead of time, but Nominating Petitions will not be released until Tuesday, September 3, 2019, the first day of the petitioning period.**
