Limit Nuisance and Disturbance

Control dust, vibration, smoke, and noise emissions
Respect neighbouring communities and wildlife habitats
Schedule high-impact works sensibly (e.g. during permitted hours)

Roles and Responsibilities

Directors & Senior Management: Provide leadership, funding, and oversight
Site Managers: Implement environmental controls on-site and supervise subcontractors
All Employees: Follow environmental procedures and report concerns or incidents
Subcontractors & Suppliers: Must comply with our environmental standards as a condition of working with us

Training and Awareness

Environmental awareness is included in all staff inductions and toolbox talks
Site teams are trained in:

- Spill response
- Waste segregation
- Pollution prevention
- Environmental responsibilities are embedded in our site rules, risk assessments, and method statements

Monitoring and Continuous Improvement

Environmental performance is monitored through site inspections, audits, and incident reports
Non-compliance will be recorded and addressed
Improvement opportunities are reviewed annually as part of our policy review
We aim to align with ISO 14001 standards for continual improvement
