



**Life & Liberty Party Platform (2020 - 2022)**  
**Adopted June 27, 2020**

The Life and Liberty Party's core principles are founded upon a strict adherence to the original intent of America's founding documents: U.S. Constitution, Bill of Rights and the Declaration of Independence.

Our party is a constitutionally-centered party upholding the rule of law and due process under the law. No one is above the law! We advocate for the return to equal justice for all, true freedom for the American people, accountability and transparency from our public servants and an informed and civically-involved citizenry.

Whereas, recognizing the lack of a viable political home and witnessing the growing number of the disenfranchised, the need to build a real option became paramount. We, therefore, realized the need to establish a serious vehicle that would fill the void for activists who currently identify as: **pro-life Libertarians, isolated liberty-loving Independents and faith-based Constitutionists** who share no intention of establishing an unconstitutional theocracy.

We have taken the following positions on key issues of our time.

Right to Life

In accordance with the intent of the Declaration of Independence, we fully support the right to life, liberty and the pursuit of happiness. This includes the right to life from conception to a natural death.

Due to the current lack of equal justice for all, we oppose the use of capital punishment.

We oppose euthanasia as an unethical and immoral act.

All people should have the right to choose whether to be resuscitated or be kept alive on artificial means.

## Gun Control

The natural right of the people to keep and bear arms shall not be infringed. All gun control measures are unconstitutional and therefore, unlawful.

## Healthcare Freedom

We believe in the freedom to choose or refuse what goes into one's body.

Everyone shall have the right to seek alternative medicines and treatments.

No medical procedure or intervention shall be forced against an individual's will IE: forced vaccinations or specific medical treatments. Patients have the right to full disclosure of known risks verses benefits in order to give well-informed consent.

Patients have the right to know specific costs prior to receiving treatment so they can shop prices like any other product or services.

## Foreign Policy

We believe, as did our founders, in fair trade with all nations but entangling alliances with none. We support bringing our troops home from all foreign nations. Our military should be used in defense of the American people in the event of a direct, verifiable and an actual imminent threat to our nation's people. All wars must be declared by Congress, per the U.S. Constitution.

## Free and Fair Elections

We are the only national political party committed to the return of free and fair elections.

There must be transparency in the counting of our votes. We must prohibit the use of all private entities supplying secretive/proprietary software, hardware and the printing of America's ballots.

Voters must be able to witness the actual tallying of their votes. We strongly advocate for the return to local precinct hand counts in public view of voters. Vote count totals and tallies must be displayed at local precincts prior to ballot boxes ever being removed from public view which would include any removal from room and/or building.

A willingness to explore new technologies if they can guarantee full transparency and security such as possibly block-chain technology.

We believe in equal and reasonable access to vote for all American citizens without exception. ALL American citizens have the fundamental right to vote, therefore, reasonable and realistic accommodations must be made.

We advocate for free and fair ballot access for all political parties, candidates and ballot issues.

Media outlets must demonstrate free and fair treatment of candidates, regardless of political affiliation. This shall include fair and reasonable inclusion in debates and other public events.

### Border Security & Protection of Sovereignty

All nations have the right and duty to protect its nation's borders.

We must withdraw from the United Nations and any other global authorities.

We The People are only represented and governed by our duly-elected representatives which are subject to our continued consent.

### Protection of real and personal property rights

Government exists to protect personal property rights, not to infringe upon them. This would include the illegal seizure of land, wages, resources and personal effects.

### States' lands

There must be a return of individual state's lands from unconstitutional seizure by central government. The land and resources rightfully belong to the citizens of each state.

### War on Drugs

The unconstitutional War on Drugs has given an excuse to all levels of government for many violations of our civil liberties. This would include violations of the 4<sup>th</sup> Amendment (unlawful search & seizure), civil asset forfeiture laws which incentivize law enforcement corruption and a usurpation of sovereignty over one's own body.

### Article V Convention

We strongly oppose an Article V Convention, Constitutional Convention (Con-Con) and Convention of States.
