

Terms and Conditions

1. Acceptance of Terms

These Terms and Conditions ("Terms") govern your access to and use of CreateList (the "App"), a mobile application provided by Start Technologies LLC ("we," "us," or "our"). By downloading, accessing, or using the App, you agree to be bound by these Terms. If you do not agree, do not use the App.

- Other group members will be able to view and edit shared lists
- Your phone number may be visible to or discoverable by other group members for the purpose of group invitations
- We are not responsible for disputes arising between users over shared content

You agree not to:

- Use the App for any unlawful purpose
