1. Florida Department of Transportation (FDOT) Updates, Victoria Peters

Ms. Victoria Peters had no particular update. She said that she did reach out to get more information on the corner of SR29 and Oil Well Road but has received no response. The County is working with FDOT Traffic Ops on this matter. There is a possibility of signage or signaling for this road. She also informed board and public members on the TIP Amendments for the Moving Florida Forward funding. This was approved by the BCC meeting last month. 1. Advisory Board

i. Board Vacancy Update (Enclosure 9)

Staff informed board and public members on Enclosure 9. The information presented is in the County website on the Advisory Board Vacancies. Staff informed everyone that there are other board vacancies but have decided to only show the vacancy for the Immokalee MSTU Advisory Committee. Staff went over the requirements to join the Immokalee MSTU Advisory Committee and how to apply.

2. Streetlight Pole Replacement (Enclosure 10)

Staff provided a background on a couple of streetlight poles that were knocked down a couple of times a few years ago. Staff decided not to replace them due to the many occurrences of individuals knocking them down. Reimbursement was received for the knockdown of the poles. The County provided feedback to Staff and said that the area where both poles were knocked down is too dark. Staff agreed that the area needs lighting, but they would like to have approval from the MSTU Committee members on the expense for the replacement. Since reimbursement was received for both Streetlight poles, Staff would need to pay the difference on replacing both poles.



Ms. Andrea Halman asked for an update on the flickering lights on Main Street. Staff said that Traffic Ops replaced a part, but they will check on Friday night to see if everything is operational. Staff will follow up for any updates.

Ms. Lupita Vazquez Reyes informed members on a notice that was sent to residents on the changes of lights to LED lighting. She would like to know if this consists of all the lights in the community or just certain residential areas. Staff informed Ms. Vazquez Reyes on the changes that LCEC plan on doing with the lights they have. Ms. Christie Betancourt would like to change the current MSTU light poles LED. Staff is currently waiting on a map; a big project is coming up and the Immokalee MSTU will be paying the utility light bill (not maintenance) for all 406 poles. This will be brought up as soon as staff receives a map. The map will show LCEC, MSTU, and County poles. The map will also show which lights are LED. Staff will be awaiting on the cost to present to the Board.

Mr. Mark Lemke provided a suggestion on having the poles replaced much sooner so that the cost is minimal. Staff discussed a few reasons as to why they waited for the reimbursement instead of replacing the two poles knocked down. Staff also discussed on the number of poles located on First Street.

After much discussion board agreed to replace pole #38 and #52.

MSTU Action: Ms. Andrea Halman made a motion to authorize Staff to proceed with Simmonds Electrical of Naples to furnish and install two (2) 27' Lumec Poles as replacement for poles #38 and #52 on N 15th Street SR29 based on the current quote of \$43, 022.26. Ms. Norma Garcia seconded the motion, and it passed by unanimous vote. 3-0.

3. Nomination for Chair and Vice Chair

Ms. Anne Goodnight discussed on her decision to have Mr. Mark Lemke be Chair for the Immokalee Local Redevelopment Advisory (CRA) Board. She is willing to help anybody to understand how to conduct the meeting. She said it's important to teach the individual in the Chair position on understanding their role as well as the Chair procedures.

Staff and Board members had a discussion on the idea to have the Vice-Chair be the Chair in waiting, so that the Vice-Chair is able to learn from the Chair. Ms. Anne Goodnight provided her opinion on having the Chair serve for 2 years helps not only strengthen the Board but also help strengthen the Chairman. She said that this can be an opportunity for the Vice-Chair to learn the procedures

Board Members discussed on having Ms. Anne Goodnight as Vice-Chair. After much discussion on the term for the current Chair to serve as Vice-Chair, the CRA Board made a Nomination and a motion.

xii. Vision

CRA Director, Greg Oravec, went over a few key points of the Immokalee Community Redevelopment Plan. He went over the goals, objectives, and strategies of the plan.

Mr. Mike Facundo provided feedback on the importance of the Vision Statement and said the current Vision Statement is too long, and he would like the board members to consider changing it. Mr. Oravec agreed with Mr. Mike Facundo and said that the Vision Statement should fit in within the context of the County's vision and values because Immokalee is part of the County. After much discussion with the board members providing feedback on what Immokalee is really about and why the vision is important to review and make a change that best describes Immokalee. The Board and Public members were grouped into 3 groups, the groups had 25 minutes to discuss with each other and provide a Vision Statement.

All three groups presented the Vision Statement they came up with.

Mr. Mark Lemke explained on the reasoning of Group 1 Vision Statement. He elaborated on the idea that there is no real expectation to meet other than to be the best in the nation. He said this statement is simple, short and sweet. Group 1 believes that this Vision Statement best describes Immokalee.

Mr. Mike Facundo elaborated on Group 2 Vision Statement. He elaborated on the idea of keeping the vision statement open ended. Ms. Christie Betancourt elaborated on Group 3 vision statement.

Group 1: "To Be the Best Rural Community in The Nation to Work, Live, and Play!"

Group 2: "Develop a thriving Community."

L. Citizen Comments

Ms. Christie Betancourt thanked Mr. Armando Yzaguirre for decorating the Zocalo Plaza. Mr. Armando Yzaguirre provided a brief rundown on the decorations done at the Zocalo Plaza. Ms. Betancourt also thanked Parks and Recreation staff for fixing the trip hazard at the Zocalo Plaza and for staying the whole time during the Christmas Tree Lighting Event. She also recognized Ramon Arce for helping with the electoral issues at Zocalo Plaza. It was a great community effort.

Commissioner McDaniel gave a public service announcement. He said that in the last Collier County Commissioner's board meeting, the ordinance which would create the unpaved road emergency repair was approved. He said that he wanted this to cover county-wide but because of some legal matters an assessment was done to see which roads were in the worst conditions. There are approximately 14 miles of road that were deemed to be in the worst condition. Commissioner McDaniel asked Ms. Betancourt to send a note to his office so that the list of roads can be provided. Ms. Betancourt said she had the list at her disposal, and she would provide to community members.

Mr. Frank Nappo asked the difference between county-wide for unpaved road and what is currently occurring. Commissioner McDaniel said that county-wide would have encompassed all the roads in the County but what is occurring is specifically naming miles of roads. The cost is estimated to be about \$12,000 per mile with an estimated date of 3 years to have them all completed. Discussion was made on how there is no opt out and the goal of safety is the main goal for this Ordinance. Ms. Christie Betancourt said that she will add this item to her report.

Commissioner McDaniel said that the MSTU created for this Unpaved Private Road Emergency Repair will consist of all county staff, but they will have 3rd party committee that consist of Fire, EMS, and the Sherriff's office to help with the decision in the initial grade of the roads.



Rev. Jean C. Paul provided a brief history on himself and the experiences he has endeavored and what others have experienced as well. He provided suggestions on what he would like to see happen in the Immokalee Community. Information was also given on the education classes he is proctoring. Commissioner McDaniel provided information to Pastor Paul.

Ms. Andrea Halman thanked Mr. Greg Oravec for all that he has done in the past 6 months. Mr. Oravec said he is grateful for the time he had with each board member and is sorry that he is going.

1. Immokalee Area Master Plan (IAMP) Restudy

(PL201880002258) Approved by BCC for final adoption on 12/10/2019.

Copy of IAMP as amended by Ordinance 2019-47 can be found at www.ImmokaleeCRA.com website.

• Implementation schedule was provided at the November 2020 Meeting. No update.

2. <u>Immokalee Area Overlay District LDC Updates</u>

- County staff discussed IAMP Policy 6.1.3 Downtown Ped Amenities and 3.1.4 Central Business District at the March 17, 2021, CRA Meeting.
- First LDC Workshop was held on May 19, 2021, following the CRA meeting.
- County staff held Kick off meeting on June 16, 2022, with consultant The Neighborhood Company (TNCo).
- TNCo held a Site Visit with CRA staff on August 12, 2022.
- An onsite meeting was held with TNCo and ICRA staff on September 14, 2022. TNCo provided staff with upcoming schedule/timeline.
- TNCo presented at the CRA Advisory Board Meeting on February 15, 2023.
- Staff provided updates at the May 17, 2023, CRA Advisory board meeting.
- TNCo finalized evaluations on the overlay and development patterns. They held one-on-one meetings with local stakeholders.
- TNCo presented at the June 21st Joint CRA & MSTU meeting.
- TNCo provided the Immokalee Land Development Code "White Paper" update to County staff on September 1st
- TNCo held a workshop on October 4th. TNCo staff is now working on LDC draft language with ICRA staff and county staff. Adoption process will be after the LDC draft is completed.
- TNCo provided a brief update and an updated time at the January 17, 2024, CRA Advisory Board meeting.



3. CRA Office

Job Bank Assistant – staff is continuing to use KeyStaff temp service until further action is taken. CRA Director Position – Interviews to be conducted.

4. Redevelopment Plan

On May 10, 2022, the of Collier County Board of County Commissioner (BCC), acting as the Community Redevelopment Agency Board (CRA), approved a Resolution recommending approval to the BCC an amendment to the Collier County Community Redevelopment Area Plan. Fourth quarter implementation schedule was provided in September.

5. Infrastructure Projects (County) in Immokalee (Not funded by CRA/MSTU)

1) Carson Road Project-Eden Park Elementary Safe Routes to School

- 6' Sidewalk on the south and west side of the road.
- Construction costs is estimated at \$663,000.
- Funded with Safe Routes to School funds in FY 21/22.
- Construction to start in FY 23/24.
- Design 100% complete.
- Project is out for bid.



2) Lake Trafford Road


Design of bicycle and pedestrian features on Lake Trafford Road from Little League Road to Laurel Street. The project length is approximately 1.850 miles. Specifically, the design will provide for bicycle lanes on each side of the roadway within the project limits and design of a 6' sidewalk on the south side of the roadway from Carson Road to Krystal Lane and from North 18th Street to Laurel Street.

Includes adjustment or relocation of the existing signalization at the intersection of Carson Road and 19th Street, if required. Constrained right-of-way at 19th Street intersection may require bike lane tapers to sidewalks and minor incidental intersection improvement at this location. Project 3 is discussed under Stormwater projects. No update



3) Stormwater Improvements

The original Immokalee Stormwater Master Plan (ISWMP) was prepared by H.W. Lochner (2005). Camp Dresser & McKee (CDM) was contracted in 2010 to prepare construction plans for the Downtown Immokalee and Immokalee Drive projects plus update the ISWMP. A draft update document was prepared but not finalized. On November 28, 2018, county staff presented the follow-up analysis.



Immokalee Stormwater Project updates: North 3^{rd.} Street Stormwater Improvements:

The North 3rd Street Drainage proposed project is located on North 3rd. Street between 2nd Avenue and Roberts Avenue West. The project would include roadside swales, installation of inlets on 3rd. Street, construction of a storm drainpipe system to alleviate ponding and allow conveyance southward to the storm drain system on West Main Street. Cost for repairs is estimated at \$900,000. The grant funding contract is now finalized, and the project is ending the contractor bidding phase. Bids received awaiting budget amendment. The project manager is Brittany Lazo with Collier County Stormwater Management.

Madison Avenue Channel project:

On the northeastern side of Immokalee, county staff obtained Board of County Commissioners approval to purchase a 6-acre parcel just to the east of the Immokalee Foundation Career Path Learning Lab site. That site will provide a pond site to improve stormwater quality from the outfalls along Madison Ave. Additionally, county staff is working with FDOT's design firms to coordinate the alignment of the SR-29 bypass loop so they can avoid having to route the stormwater from the Madison Avenue channel all the way around the north and east sides of the airport.

Eden Gardens project:

The Eden Garden Bypass Drainage Improvement proposed project is located in the south area of Westclox St., east of Boxwood Dr., west of Carson Rd., and generally north and northeast of Eden Gardens. The project would construct a new ditch along the northern boundary of Eden Gardens, install a 24" pipe under Boxwood Dr. to tie into the existing ditch along the northwest boundary of Eden Gardens to convey flows further west. Cost for repairs is estimated at \$602,786.32. The county applied for CDBG-DR grant funding for this project. Project is 100% design and has been put on hold due to staffing resource shortage.





Lake Trafford Road Area:

The single negotiated contract for designing both a stormwater treatment facility in the SE corner (Tract 3) of Arrowhead Reserve and drainage improvements along Lake Trafford Road from Little League Road to Tippins Terrace was applied for by the Board of County Commissioners in 2021. County staff is looking at phasing the construction, with Phase 1 being the Arrowhead Tract 3 site and Phase 2 being the pathway and drainage west of Little League Road. Design for Phase 1 was completed in 2021 and construction is tentatively scheduled to begin in 2024. Phase 2 design began in 2022 and was split into Phase 2a, roadway & sidewalk scope with Phase 2b Pond design. Phase 2a road drainage/sidewalk design to be completed in 2023 and scheduled for construction bid in 2024.

6. Commercial Façade Grant Program

In accordance with objective 1.2 in the Immokalee Area Master Plan, the CRA continues to provide financial incentives to business in Immokalee via the Commercial Facade Improvement grant program. The CRA initiated the Program in October 2008.

Since that time, 17 façade grants have been awarded to local businesses for a total of \$294,621.67.

Eligible applicants may receive grant funding up to \$20,000 as reimbursement, using a one-half (1/2) to 1 match with equal applicant funding for funding for façade improvements to commercial structures. Program is in place and being reviewed for revisions.

7. FHERO – Florida Heartland Economic Region of Opportunity
Staff attends monthly FHERO board meetings via Zoom or in person. The
next FHERO board meeting is scheduled for February 6, 2024.

8. Immokalee Unmet Needs Coalition

The Immokalee Unmet Needs Coalition (IUNC) is a long-term recovery group that formed in the fall of 2017 as the result of Hurricane Irma. This group is composed of non-profits, faith based, local, state, or national organizations who work together to meet the unmet of Immokalee residents impacted by disaster. At the February IUNC Housing meeting it was announced that the coalition received a Voluntary Organizations Active in Disaster (VOAD) grant for \$100,000 for the Immokalee area to assist the community with disaster improvements due to Hurricane Ian.



The Housing Committee is updating the Immokalee Disaster Recover Resiliency Plan and funding options for future projects on a quarterly basis. The Housing committee meetings are held the second Friday of every month via zoom at 10:00 a.m. The next meeting is scheduled for January 12th @ 10:00 a.m. via Zoom.

9. <u>Development in Immokalee</u>

1) Immokalee Foundation Learning Lab 18-home subdivision

The Immokalee Foundation Learning Lab 18-home subdivision is currently under construction. Collier Enterprises donated the 8.3 acres of land for a housing subdivision that will serve as a hands-on learning laboratory for student in the foundation's program., Career Pathways: Empowering Students to Succeed. BCB Homes, is serving as the general contractor.

On July 13, 2021, BCC board meeting (Agenda item 16.F.10) board approved a recommendation to direct staff to develop a workforce development grant agreement with The Immokalee Foundation, to offset development costs on the housing subdivision for the Career Pathways Learning Lab, in the amount of \$500,000.

The Immokalee Foundation sold its first home in December 2021 and closed on the 7th home in August 2023.

2) Immokalee Fair Housing Alliance (IFHA)

The Immokalee Fair Housing Alliance proposed housing development consist of 8 buildings with 16 apartments each or 128 Units in all. Construction will progress in phases. Housing units will be two- and three-bedroom apartments ranging in size from about 750 to 950 square feet. For more information, please visit http://www.ifha.info/. Revised rendering will be provided at a future meeting. IFHA received final county approval of Site Development Plan (SDP) and they are currently out for bid. Land clearing started in September 2021.

Groundbreaking was held on November 10, 2021. Construction is under way. The infrastructure work which also include utility work is complete. The asphalt was laid in the construction access areas. Heatherwood Construction has started on the first of eight 16-unit apartment buildings for low income and workforce Immokalee families. The GC, Heatherwood Construction has reported that the construction of the footers and slab for the first building was completed in January and the first lift of concrete block was laid mid-February.

IFHA held the Signature Moment Wall Raising Ceremony on March 1, 2023. The event was attended by over 100 community and business leaders. The first walls were signed by the attendees and will go into the apartments. Construction continues to progress on the first building. They are on target to start the next two building, but they are currently in the process of paperwork and finding funds. IFHA plan to partner with the Shelter for Abused Woman & Children to allocate 16 apartments for those who have completed the program.

3) Habitat for Humanity of Collier County Kaicasa Housing Development

Kaicasa will be located at the Southeast corner of Immokalee, on state road 29 as you enter the agricultural village from the south. The new affordable community will sit adjacent to the existing Farm Workers Village: subsidized housing built in the 1970s for local and migrant farm workers that is often criticized for its conditions. Many Habitat Collier partner families have lived there prior to purchasing their homes. Once complete, this neighborhood will boast nearly 280 homes, making it the largest Habitat subdivision in the country.



Construction started in August 2022. Habitat is taking in applications for this development. The first phase may be reduced to 65 homes due to supply shortage. On Saturday, January 14, 2023, an Esperanza Home Dedication was held at Esperanza Place. They are hoping to have 20 homes built by June 2023. She said they have the families, just not the houses yet. They have 3 families have been assigned to the first 3 units and 25 families have been approved, they are just waiting on the homes.

4) Redlands Christian Migrant Association (RCMA) Childcare Development Center and Community Hub

The RCMA proposed childcare center and community hub consist of Childcare classrooms, Area office, and playground. The development will accommodate 234 children and 30 employees. Approximately 8 acres will be designation for housing. Q. Grady Minor presented updated plan for the RCMA Immokalee MPUD (PL20200001827) at the CRA June 16, 2021, Board Meeting. CRA Board supported the proposed development. At the February 16, 2022, Parks & Recreation Meeting, H&F Architects provided updated renderings of the proposed development. A charter school is in the expansion plans, but it is currently planned as a development center. RCMA is reviewing partnership options for the development of the recreational fields with Collier County. Construction started in March 2023.

Lipman Family Farms, a long-time supporter of RCMA, made a \$3 million donation to the organization; the largest donation Lipman has ever made to any one organization. The groundbreaking for the new campus was held on May 25, 2023. When completed, the \$16.4 million campus will feature two new child development centers, a community center, two soccer fields and a new charter school. The campus is scheduled to open in

July 2025.



5) Casa San Juan Diego PL20230018133 SDP – 133 Hancock Street

The proposed Casa San Juan Diego Multi-Family affordable housing development in Immokalee is a partnership between the National Development of America, Inc., and the Diocese of Venice to develop 80 affordable rental units on 9.6 acres of land adjacent to Our Lady of Guadalupe Church. National Development of America, Inc. applied for grant funding but didn't receive. They will continue to look for other funding to build Casa San Juan Diego development in Immokalee. At the September IUNC Housing meeting staff provided committee a project update. Casa San Juan Diego has received recommendation for funding from Florida Housing. They will now enter the protest process. Final results are expected early 2024.

On January 3, 2024, a pre-app meeting was held to rezone the property. They held a pre application meeting to rezone property. The project consists of two buildings, a club house, a multi-use play field, and a multi-use court. The developer will present project updates at the February 21, 2024, CRA Advisory Board Meeting.







6) Casa Amigos – Farmworker units at Esperanza Place

Rural Neighborhoods will open its new Casa Amigos apartments in Immokalee in October. Centered around a courtyard, the new development has 24 units, each with 2 bedrooms and 2 baths. The apartments are located at 2687 Amigo Way and serve both non-farmworker and farmworker families. Rents range from \$674 to \$1,123 per month including water, sewer and electric.

Beginning September 18th, prospective tenants can call 239-657-2009 to schedule an appointment to submit their application. Applications can be downloaded here or picked up at 2693 Marianna Way during business hours. Additional information about income and eligibility is available here.



7) LGI Homes

LGI is offering new homes for sale in Immokalee at Arrowhead Reserve. They are one of the largest new home builders in Immokalee. CRA staff has reached out to local manager for updates. They will be attending a future CRA meeting.



8) Pulte Foundation PL20220004087 - PFCF/NSV Immokalee PUD (PUDZ)

The Nuestra Señora de la Vivienda Community Foundation and the Pulte Family Charitable Foundation is proposing up to 250 single-family homes, built to rent, and an early education center for roughly 250 students. The foundation first presented at the CRA September 21st meeting and then again at the CRA January 18, 2023, meeting. The foundation presented at the April Chamber of Commerce meeting. They held a Neighborhood Information Meeting (NIM) on Wednesday, June 7, 2023.

The Local Redevelopment Advisory Board requested that the Foundation comeback to the CRA after they receive comments from the county. The Foundation Presented to the Collier County Planning Commission on August 17, 2023. On October 10, 2023, the Board of County Commissioner approved a rezoning ordinance for the PFCF/NSV Immokalee MPUD to allow up to 250 horizontal multifamily dwelling units, 170 of which will be restricted as affordable, and a 250-student early childhood education center, on 50± acres located northeast of the intersection of Westclox Street and Carson Road in Immokalee, in Section 29, Township 46 South, Range 29 East, Collier County, Florida.





9) Williams Farms of Immokalee (James E Williams Jr. Trust) RPUD (PUDZ) PL20210001434

Lake Trafford Road near Arrowhead 00113600106 (Property ID# 0011360009) Current Zoning is A-MHO. 171 acres +/-. Williams Farms applied for a residential community on the south side of Lake Trafford Road. The consultant Daniel Delisi held information meeting on August 30, 2022. They presented to the CRA on September 21, 2022. Staff will follow up with consultant for status of application. The application was approved by the Collier County Planning Commission in April 2023. On May 23, 2023, the Collier County Board of County Commissioner approved Agenda items 17.A. (Ordinance #2023-23).



10) Seminole Tribe medical and public safety facility
On April 26, 2022, a groundbreaking ceremony was held
for a medical and public safety building on the
Immokalee Reservation. The ceremony featured current

Immokalee Reservation. The ceremony featured current and past tribal leaders as well as one of the founding mothers of the Immokalee reservation, Nancy Motlow. The 41,000-square foot building that will house the clinic, Center for Behavioral Health, and public safety departments on 9.7 acres on Seminole Crossing Trail. Construction is underway.



11) Immokalee Fire Control District

Groundbreaking was held on September 27, 2021, for Fire Station 30 located at 510 New Market Road. The state-of-the-art firehouse features three apparatus bays and is equipped with bunker gear storage and a shop area. The building also features a lobby, conference room and two offices. Fire Station No. 30 replaces the existing firehouse located at 502 New Market Road. Construction started in December 2021 and a temporary certificate of occupancy was provided at the end of August 2023. Ribbon Cutting ceremony hasn't been announced yet.



12) Budget Inn (PL20220001199 CU)

On March 16, 2022, a Pre-Application meeting was held with county for a proposed conditional use for the Budget Inn located at 504 E Main Street. Owners are proposing to demolish the existing hotel and potentially do a two or 3 story hotel. The architect for the business owner provided staff a rendering of the new hotel concept plan. Representatives for the Budget Inn will present at the Joint CRA & MSTU March 15, 2023, board meeting to request support for the project. No update.






13) Florida Army National Guard Readiness Center Project

This is a new construction project being proposed at the Immokalee airport. This project will include a General-Purpose Training Bay (GPTB), all utility services, information systems, roads, walkways, curbs, gutters, storm drainage, parking areas, and site improvements. Physical security measures for anti-terrorism and force protection will be incorporated into the design to include maximum feasible standoff distances. Energy conservation measures will also be incorporated into design where feasible. Estimated project \$20 million.





14) Mosquito Control

This is a new construction project being proposed at the Immokalee airport. This project will consist of building a 2-story administration building (37,000 sf), 25,000 sf hangar, rotorcraft hangar (25,000 sf), maintenance building and a chemical storage building and associated Site Development at the Immokalee Regional Airport. The tenant and developer is the Collier Mosquito Control District. The Rotorcraft hangar (26,060 sf) will be built as Phase I and other buildings will be built as Phase II.





9. The Face of Immokalee

On December 12, 2018, Michelle Tricca, a local Artist, presented The Face of Immokalee, a proposed outdoor photography installation celebrating the soul of Immokalee. CRA board supported the project and have formed a subcommittee to move the project forward. The subcommittee last met on December 9, 2019, to discuss the art wall options for the old McCrory's building (S&O Grocery), Lipman Produce (trucks/building), site on 1st Street (Gadsden blue building), and the Zocalo plaza. Committee supported rendering provided by artist with minor changes.

On October 22, 2020, CRA staff and Lipman staff met with Michelle Tricca to discuss project status. On October 29, 2020, WGCU did a story on Ms. Tricca's public art installation for the Phase 1 portion of the project.

On November 18, 2020, both the CRA and MSTU board supported The Face of Immokalee project and made a motion to allow the use of Zocalo Plaza Art Wall as a canvas for the project.

In May 2021 Ms. Tricca provided project updates to staff and announced that the project has started to receive donations via her fiscal sponsorship with ASMP Foundation. She also noted that the project was featured in Florida Weekly.

On April 16, 2023, "The Face of Immokalee" public art launch event was held at the Lipman property located at 200 E. Main Street. Ms. Tricca was awarded a \$25,000 grant from Florida Dept. of State, Division of Arts & Culture, and the National Endowment for the Arts.

On November 2, 2023, Ms. Tricca was a speaker at the Blue Zone Project Year in Review - The Art of Connection event held at Artis-Naples. The event introduced the Face of Immokalee: Public Art for a Social Change film.

It was announced at that time that The Face of Immokalee: Public Art for Social Change won the Florida Film Award and the International Film Festival (NIFF) Awards Ceremony held on Sunday, October 29. The event, attended by industry professionals and film enthusiasts, featured the announcement of winners who excelled in various categories.

11. Impact Fee Installment Payment Program

Program details:

- Pay your impact fees in installments over a 30-year term.
- Available for single-family, multi-family and commercial projects.
- Non-ad valorem special assessment on property tax bill.
- 5% fixed interest rate (2023 applicants). No interests for registered Charitable Organizations and Non-Profits.
- An approved agreement must be executed and recorded prior to issuance of a Certificate of Occupancy or payment of impact fees.
- Assessment is superior to all other liens, titles, and claims, except state, county, and municipal taxes.
- Call or email for complete program requirements.

12. Adopt A Road Program

Adopt a Road – dormant for the past two years due to COVID and staffing changes. In August 2021, Rich Koenigsknecht was assigned the program and Road Maintenance began the assessment. Samantha Roe is assisting and is the first point of contact if anyone would like to participate in the program. The first task was to reach out to see what organizations were active and still wanted to participate. The second task was to complete an inspection of the signage. A photo was taken of every sign. The complete list will be sent to Traffic Operations who will make the signs. New signs are scheduled for the FY23 budget.



Immokalee is within Area 4. Area 4 is larger than the Immokalee CRA boundaries. There are currently 13 road segments in Immokalee CRA boundary identified for the program, covering 8.75 miles. 10 of those segments at one point in time had sponsors. No sponsors are active today based on the recent assessment. Staff provided updates at the March 15, 2023, Joint CRA & MSTU advisory board meeting.

13. Unpaved Private Road Emergency Repair MSTU (Municipal Service Taxing Unit)

At the March 28, 2023, Board of County Commissioners meeting the Board considered an Ordinance to create a municipal service taxing unit to handle the unpaved private roads.

At the December 12, 2023, Board of County Commissioner meet the Board approved an Ordinance which would create the unpaved private road emergency repair municipal service taxing unit by authorizing a levy of not to exceed one (1.0000) mil of ad valorem taxes per year.

There are approximately 25 roads that contain approximately 13.694 miles of unpaved private road considered impassable for emergency vehicles. The taxable value of the 625 properties benefitting from these roads is estimated to be \$61,452,001. A millage rate of 1.0000 will generate \$61,452 annually. With the average repair cost of \$12,000 per mile, approximately four (4) miles of impassable private lime rock road per year can be repaired.

They enhance the ability to attract businesses, developers, and financial institutions to invest in these targeted areas — distressed communities — by allowing investors to defer capital gains taxes through investments Low Tax Opportunity Zones, established by the federal Tax Cut and Jobs Act of 2017, encourage long-term investment and job creation in targeted communities by reducing taxes for many job creators.

The zones enhance local communities' ability to attract businesses, developers, and financial institutions to invest in targeted areas by allowing investors to defer capital gains taxes through investments in federally established Opportunity Funds.

It's an economic and community development tax incentive program that provides a new impetus for private investors to support distressed communities through private equity investments in businesses and real estate ventures. The incentive is deferral, reduction, and potential elimination of certain federal capital gains taxes. To become a Qualified Opportunity Fund, an eligible corporation or partnership self-certifies by filing Form 8996, Qualified Opportunity Fund, with its federal income tax return.

<u>Holiday</u> – A Scope of Work for Holiday Decorations was prepared to combine the Christmas decoration scopes for Immokalee, Bayshore and Pelican Bay. A Solicitation was processed for a three (3) year term with two (2) one-year renewals. The BCC/CRA awarded a contract to Lite Er Up (LEU) with an estimated budget of \$25,500 per year for Immokalee. Staff provided a Purchase Order to Light Er Up on 10/31. On 12/1 LEU cancelled. A&M provided immediate services to timely decorate Zocalo Plaza for the Tree Lighting Event.

Staff are recommending to the Board of County Commissioners at the 1/23/24 meeting that the Board approves terminating LEU's Agreement No. 22-7953, as permitted under Section 10 of the Agreement with an effective date of 2/22/24. A 30-day written termination notice was sent by Procurement Services to LEU, subject to the Board's approval. Staff will prepare the scope of work for the Request for Quotes for tree and holiday decorating services in 2024. Staff will also prepare a Request for Quotes for the replacement of the bell street light pole decorations for next year's holiday season.

3. Immokalee Complete Street (TIGER Grant) Project

The overall project will create a network of Complete Streets including approximately 20 miles of new sidewalks, improved walkability by filling in sidewalk gaps, a bicycle boulevard network, additional street lighting, landscaping, drainage improvements, and improved bus stops. These improvements will increase safety for the community.

Area 1 is the construction of sidewalks along the south side of East Delaware Avenue from South 1st Street to School Drive and multi-use trail construction on the east side of School Drive from Rose Avenue to E. Eustis Avenue. Crews completed the multi-use trail on School Drive. Roberts Avenue, 9th Street, 1st Street, Monroe Street, Lee Street, N 11th Street and the bus transfer station at the Collier County Health Department on Immokalee Drive are under construction. Estimated substantial competion is Mid-2024.

5. Panther Crossing Welcome Sign

FDOT's Approved Utility Permit #2022-H-192-00303 dated 12/14/22 was utilized for the water service tap and directional bore under State Road 29. The purpose of the directional bore is to allow for a tap and drill into the existing 10" portable water main located west of SR29 for irrigation to the sign location east of SR 29. Boring work commenced and was completed on 5/4/23. The permit for the signage was finalized on 6/6 and construction on the sign commenced on 6/14.

The Artist, Martha Cantu, provided a quote of \$2,280 to paint the mural on the sign. This is the same mural that is on the S 1st St/Eustis Immokalee Welcome Sign. Q. Grady Minor (QGM) completed revisions to the Plans on 6/1 to modify the lettering on the sign as recommended by the subcontracted sign vendor. The original letter specifications could not be fabricated at the size specified. The electrical permit was received on 8/2. The electrical meter main inspection was completed 8/17 and LCEC completed pulling power to the site on 11/9.

IWSD approved the certified backflow test on 11/13. A start work notice was issued to QGM and walk-through inspection was completed on 12/1 with QGM, CRA and Vetor. QGM provided a seven-item punch list to Vetor. Progress has been made on the punch list and the last remaining items are anticipated to be completed by 1/26. Vetor extended the permit which now expires 3/6/24 to complete the project. The electrical inspection passed on 1/16/24 and the final inspection is scheduled for 1/18/24. Staff will investigate the surrounding areas to identify sightline improvements.

6. Historic Cemetery Preservation

The historic cemetery property was being maintained by Parks and Recreation and A&M Property Maintenance LLC assumed the maintenance on the site on 8/13. The Seminole Tribe, Christ Episcopal Church and Parks & Recreation will assist in identifying the individuals interred at the cemetery.

Staff met Jennifer Wolfe, a Preservation Planning Specialist with PDP Architects, Philadelphia, PA, at the Florida Redevelopment Association Convention in Ponte Verda, Florida in November 2023. Staff emailed Ms. Wolfe on 11/28 for preservation guidelines and recommendations.

Ms. Wolfe recommended connecting with the Florida Public Archaeology Network (FPAN) that offers training programs and education. Natalie De La Torre Salas, Public Archaeology Coordinator of the SW Region, FL Public Archaeology Network (FPAN) and Mike Cosden, President of the Florida Trust for Historic Preservation, have been contacted. Ms. De La Torre Salas advised Staff needs to research boundaries and identify individuals interned and their descendants. She may meet with Staff to create a Management Plan and she recommended Staff attend the Cemetery Resource Protection Training on 3/6/24 at Palm Harbor, FL.

Staff have been unsuccessful in locating a survey and will continue research with the Seminole Tribe and the Council of Episcopal Diocese of Southwest Florida. A meeting with the Tribe and County Staff is scheduled for 1/24. The Collier County Government Surveyor and the Real Property Management Department do not have a survey or plot plan.

Staff have been in contact with The Very Rev Edward Gleason of Trinty-by-the-Cove Episcopal Church in Naples, Florida and he is researching the cemetery with the Dioceses.



William Crane Gray was born in Lambertville NJ on 9/6/1835. He was ordained on 6/26/1859 in Christ Church, Nashville, TN and to the priesthood in 1860. He served two decades in Nashville and was elected in 1892 bishop of the new Missionary Jurisdiction of Southern Florida. Bishop Gray found 5 parishes, 40 missions and 11 mission stations. Among other churches established during his episcopate was the mission to the Seminoles in Immokalee in 1898. Bishop Gray served for over 21 years in Florida before submitting his resignation on grounds of ill health in October 1913 and went to live with his son in Nashville where he died on November 14, 1919. The WWII war ship SS William Crane Gray was named in his honor. His son, Campbell Gray later became Bishop of the Episcopal Diocese of Northern Indiana.

Cemetery:

As of 8.13.23, A&M assumed the maintenance of the cemetery under their new MSTU Landscape Contract #23-8084. Staff drafted a scope for a plan for the preservation of the historical cemetery.

The primary objective of this plan is to prioritize the work and features needed to upgrade the existing condition of the site and complete an assessment of the irrigation. The tasks include repairs to the signage and gate, installation of proper vegetation along the right-of-way, repair the chain linked fence, paint the decorative fence, assess gravesite condition and cleaning of headstones in the gentlest manner possible.

A&M is to provide a quote after determining the condition of the water line from the median in the ROW to the cemetery. Staff have been unsuccessful in locating a survey or plot plan for the cemetery.

While the MSTU is managing the maintenance of the cemetery, the Museum and the Tribe will take the lead on the research to determine the number of individuals interred there and the identity of the individuals. Staff have been in contact with the Florida Public Archaeology Network to coordinate an in-person Cemetery Resource Preservation Training (CRPT) Workshop for Staff, MSTU, Museum, Tribe and Division of Historical Resources. The Public Archaeology Coordinator is researching if the cemetery is registered with the State as a historical site. County Staff has a meeting with the Tribe on 1.24.24.

Date: January 10, 2024

<u>Project Status:</u> Staff processed a Solicitation Worksheet with Procurement Services to proceed with the Invitation to Bid (ITB) for the construction of the project upon receipt of Authorization to Use Funds (SF-7015.16) issued by HUD.

Background & Analysis: This project is part of the comprehensive sidewalk plan for the southern area of the Immokalee Community. Phases 1 and 2 were completed in 2018 and 2021. This phase will further the goal to provide an interconnected sidewalk network to improve pedestrian and bicycle safety, connecting residential areas to community facilities and commercial services.

Phase 3 will consist of constructing 6-foot-wide concrete sidewalks as well as drainage improvements associated with the sidewalks, along Eustis Avenue and W. Delaware from South 5th Street to South 1st Street (approximately 2500 linear feet). The total cost for the Eustis & Delaware Project (design and construction) was estimated at \$1.14M.

Agnoli, Barber and Brundage (ABB) had been selected to complete the design and permitting for this project. A Notice to Proceed was issued to ABB on August 16, 2021. ABB finalized their 100% design plans on September 8, 2022, and provided an Engineer's Opinion of Probable Costs in the amount of \$1,007,822.50.

The CRA had tentatively been awarded federal appropriations grant funds for the construction portion of the project. On September 21, 2022, at the Joint Meeting of the Community Redevelopment Agency and the Immokalee Beautification MSTU Advisory Committee, Staff obtained authorization for the submittal of HUD Grant #B-22-CP-FL-0233 Application in the amount of \$987,000.00. The MSTU shall pay \$114,763 for the design portion. The estimated probable construction costs are \$1,007,822.50. The Immokalee Beautification MSTU and the Immokalee CRA will partner on this project.

On the December 13, 2022, Board of County Commissioner's (BCC) Agenda, item 16B1, the BCC approved the Application and executed the federal forms for the Application.

The Application was submitted on December 21, 2022, to the U.S. Department of Housing and Urban Development (HUD). The Application package included the Key Contacts Form, Project Narrative, Project Budget, and three (3) Federal Forms (Standard Form SF-424, SF-424D and SF-LLL).



Total Municipal Solutions, Inc. (TMS) is the Project's Certified Engineer & Inspector (CEI). TMS Proposal for CEI Services is estimated to be \$100,000.00 and is on hold until the Grant Agreement requirements are finalized and the solicitation for a General Contractor is completed so the work may commence.

The Environmental Review was completed reflecting no significant impact and the County Manager's letters were sent by the Community Human Services Division to the tribal leaders for comment. The Tribal 30-day comments period expired on May 24, 2023. Staff prepared the required Notices for the Environmental Review Report for publication on August 22, 2023, with a 15-day public comments period. The Request for Release of Funds and Certificate (RROF) was submitted to the Office of Management and Budget (OMB) for review on September 12, 2023. On October 16, 2023, Community Health Services' Director requested additional environmental review steps. An 8-step process review was determined not warranted; however, staff secured a 5-step process review from Tetra Tech on November 27, 2023. Staff received the 5-step process review and attached it to the Environmental Review Report. OMB approved the RROF, and it was forwarded to the County Manager for execution as the Responsible Entity for the County on December 5, 2023. The executed RROF was sent to HUD's Regional Field Officer in Miami, Florida for approval on December 14, 2023. The environmental review process is completed when the Responsible Entity certifies the review and the RROF is approved by HUD's CPF Field Office Director through the issuance of the Standard Form 7015.16 Authority to Use Grant Funds.

The County cannot commit or spend funds (HUD or non-HUD funds) on hard costs or take any choice limiting actions until the project completes an Environmental Review. Examples of choice limiting action include, but are not limited to, entering a contract for construction or physical work on the project. Failure to comply with the prohibition of choice limiting actions can result in forfeiture of grant funds.

HUD provided Collier County with a corrected Grant Agreement on May 31, 2023. The Grant Agreement was reviewed by the County Attorney's Office. On September 27, 2023, the Immokalee MSTU Advisory Committee Board and the Immokalee Local Redevelopment Advisory Board recommend authorization of Staff to proceed with the execution of the Grant Agreement and authorize the gap funding expenses for the project shortages based on the current estimate of \$1,232,085.50 as depicted below. An Executive Summary was prepared for the execution of the Grant Agreement and the authorization for the necessary budget amendments for this grant on the November 14, 2023, BCC Agenda. On November 16, 2023, the Clerk of Courts sent the Grant Agreement to HUD for execution, and Staff is waiting on the fully executed Agreement. Staff sent HUD the direct deposit materials on November 29, 2023.


In December 2023, CHS assigned Grants Coordinators Parker Smith and Vanessa Collier to assist Staff on the project. They had applied for access to HUD's HEROS platform to upload the Environmental Review Report into HUD's system. They are also working on the setup in HUD's Disaster Recovery Grant Reporting (DRGR) System. Staff updated the Key Contacts with HUD to remove Greg Oravec from the list on December 27, 2023.



Staff prepared a draft Scope of Work for the Invitation to Bid for Contractors to bid on the project. The Scope of Work and Solicitation Worksheet are being reviewed by Procurement Services. On January 4, 2024, ABB provided a Bid Schedule for the ITB, and Staff provided the signed and sealed construction plans, the ABB Cost Estimate and Bid Schedule to Procurement for the Solicitation Worksheet. Only upon approval of the environmental review process by HUD with the issuance of the SF 7015.16 Authorization to Use Grant Funds may Procurement Services proceed with the advertisement for bids. The estimated date for the award of the construction contract is April/May 2024 with eight (8) months for construction of the project.

Subject: Staff Report for Panther Crossing Welcome Sign (Project Status)

Date: January 17, 2024

Project Status: Staff are monitoring the County Contractor's activities on their steps for a final inspection to close the permit and complete the project.

Background & Analysis: In August 2018, Q. Grady Minor (QGM) completed the final initial Bird of Paradise design for a welcome sign; however, the construction of the welcome monument sign was on hold until the completion of the donation of the Sign Easement which was approved by the Board of County Commissioners on May 24, 2022.

In September 2020, the MSTU approved the "Field of Dreams" mural proposal, which received over 60% of the community's votes in a survey. This new sign design reflects the culture of the community.

On June 29, 2022, QGM prepared a Proposal of \$10,195 and 90-day Schedule for engineer/landscape drawings to rework the existing plans to reflect the new mural and to add new lettering "Welcome to" and "Immokalee My Home" for the Welcome Sign to reflect the new community supported design.

A Notice to Proceed was issued on August 4, 2022. There was no water at the site. A Change Order in the amount of \$2,622 was processed as additional services QGM to secure a FDOT permit for a directional bore crossing SR29 to bring water to an irrigation meter at the site. Change Order #2 for an additional 90 days was approved due to the upcoming holiday and uncertainty of how much longer Immokalee Water & Sewer District and FDOT may need to process and release the utility permit for the FDOT directional bore application submitted by QGM on October 28, 2022. QGM incorporated FDOT and Immokalee Water and Sewer District's comments into the final plan.

On January 20, 2023 Staff issued a Request for Quotes for the construction of the monument sign. An on-site, Pre-Bid Meeting was conducted on February 10, 2023. QGM provided written responses to the bidder's questions on February 14, 2023. The quotes were received on February 20, 2023. Additional documentation was provided to the County's Procurement Services Division, and they authorized Staff to proceed with the lowest bidder, Vetor Contracting, to award the contract after the Cost Reasonableness study was accepted.



The Purchase Order for the Contractor was issued on March 22, 2023. The Contractor coordinated with Lee County Electric Cooperative (LCEC) to locate the power source and QGM staked the sign location on April 26, 2023.


Approved Utility Permit was utilized for the water service tap and directional bore under State Road 29. The purpose of the directional bore is to allow for a tap and drill into the existing 10" portable water main located west of SR29 for irrigation to the sign location east of SR29. The bore work commenced and was completed on May 4, 2023. Vetor Contracting received a permit for the construction of the welcome sign. Construction commenced on June 4, 2023 with work on the footers. The inspection for the shear wall, linter beam and filled cells was completed on June 28, 2023. The stucco work and painting were completed on July 7, 2023.

An Artist Agreement with Martha M. Cantu was executed for her artwork. This was for the same mural as displayed at the Welcome Signs at South 1st Street/Eustis Avenue. Ms. Cantu started her mural on July 8, 2023 and completed the mural on July 12, 2023.

On August 14, 2023, the pole post and water lines were installed. The electrical meter main inspection was completed on August 17, 2023; and Vetor notified LCEC of the inspection approval for the installation of the power loop and electrical tie-in. The rip rap was completed on August 18, 2023. On September 12, 2023, the County provided LCEC the permit. LCEC completed their work for power hook up on October 17, 2023; and on November 9, 2023 LCEC provided access to the breaker switch for the irrigation system.

On August 29, 2023, Immokalee Water & Sewer District (IWSD) was contacted to connect the water line. The backflow was installed on September 12, 2023, and IWSD hooked up the water line to their 10" water main. On November 13, 2023 IWSD approved the certified backflow test. On November 21, 2023, Vetor, QGM and the CRA performed a Walk-Through Inspection, and a punch list was provided to Vetor. The electrical inspection passed January 16, 2023 and the final is scheduled January 18, 2023.

Subject: Staff Report for Holiday Decorations

Date: January 17, 2024

Project Status: Staff is seeking to obtain quotes from qualified contractor/vendor for the upcoming 2024 Holiday season to furnish, install maintain, and remove holiday lights and decorations in Immokalee.

Background & Analysis: In June 2023 Solicitation #23-8144 for Holiday Lights and Decoration Rental and Installation Services was sent for a contract of 3 years, 2 annual renewals for a Contractor/Vendor to furnish, install maintain, and remove holiday lights and decorations in the Bayshore and Immokalee Community Redevelopment Areas (CRAs) and Pelican Bay.

On September 27, 2023, the Immokalee Beautification Advisory Committee approved a not-to-exceed amount of \$25,500 for Holiday Lights and Decorations Rental and Installation Services.

On October 24, 2023 (Agenda 16.L.1), the Board approved the contract with Light 'Er Up LLC to provide holiday light and decoration rental and installation services.

On December 1, 2023, Light 'Er Up LLC informed County staff that they were canceling all planned rentals and installation for the 2023 holiday season due to inventory damage and staffing issues. This left County staff very little time to find alternative solutions to provide holiday lights and decorations to our residents.

On December 4, 2023, staff was able to find a workable path by securing a 14-foot natural tree from a local vendor and having A&M Property maintenance complete the decorations prior to the 10th Annual Christmas Tree Lighting Event.

On January 23, 2024, staff is requesting Board approval to terminate the agreement for cause as per Section 10. "Termination" of the contract which provides that the County may terminate the contract for cause should the contractor be found to have failed to perform his services in a manner satisfactory to the County.

<u>Project Area:</u> Immokalee area which includes Zocalo Plaza (107 North 1st Street), SR29 (Main Street) and South First Street.



<u>Fiscal:</u> The cost for the installation and breakdown of holiday decorations at Zocalo Plaza was \$16,450. This included the purchase of a 14-foot natural tree, the installation and breakdown of CRA owned decoration. The project was funded through the Immokalee Beautification Municipal Services Taxing Unit (MSTU) Fund (1629) as shown in the table below:

Early Years 2000-2006, activities focused on public safety, adding lighting to various areas in the community, roadway improvements and supporting the establishment of the Weed and Seed program, a national initiative to weed out criminal activities and seed the community with resources.

In **2007**, the Immokalee CRA allocated \$250,000 in TIF funds to assist with the establishment of a Florida State University (FSU) School of Medicine rural health training center in Immokalee. Much of the cost of the \$1.5 million project was borne by FSU and private donors. TIF funds were used to support the upgrade and improvements on the Isabel Collier Read Medical Campus Building located on Heritage Boulevard in Immokalee. The \$4.5 million building was transferred to FSU from Naples Community Hospital. The facility opened in August of 2007.

In 2008, the Immokalee CRA allocated \$600,000 for the development of Esperanza Place. The funds were distributed in increments of \$200,000 per year for three years, beginning in FY 2009 and ending in FY 2011. This affordable housing development was built jointly by two not-for-profit developers, the Empowerment Alliance of Southwest Florida and Florida Non-Profit Services, Inc. and provided 176 rental units for Farmworker families and 60 single family homeownership units. The Tax Increment Funds (TIF) were used toward the infrastructure of the development.

In late 2008, the Immokalee CRA implemented the Commercial Façade Grant Program. Eligible applicants may receive grant funding up to \$20,000 as reimbursement, using a one-half (1/2) to 1 match with equal applicant funding for funding for façade improvements to commercial structures. In 2009 ten façade grants were awarded to local businesses in Immokalee for a total of \$158,331.00. A landmark restaurant installed a new colorful sign; five Handy Stores had significant face lifts to include awnings and landscaping; a laundry mat, a clothing store and an office business center received the award.

On May 20, 2010, the Board of County Commissioners adopted Interim Land Development Code to facilitate development until new land development codes are in place for Immokalee.

In 2010, four more Commercial Façade Grants were awarded totaling \$76,290.67.





On June 11, 2010, the Immokalee CRA won the Award of Merit for a Public Study for the Public Realm and Town Design with Form Based Guidelines from the Florida Planning and Zoning Association at the 58th Annual Conference in Sarasota, Fl. These documents define the vision of Immokalee in the 21st Century.





The Public Realm/Town Design included two plazas, an intermediate and long-range conceptual design plan for the landscaping on Main Street, a design for the downtown commercial district and form-based guidelines to aid in the development of Land Development Codes. The CRA acquired the land for the plaza with TIF funds at the corner of 9th and Main Streets and is proceeding with the creation of the first plaza.

In 2010, the Immokalee CRA was awarded \$3.5 million in Disaster Recovery Initiative (DRI) funds from Collier County Community & Human Services for Phase I of the project. The land (11.25 acres) was purchased for Phase 1. The 39.93-acre project area lies within the Immokalee Urban Area, which encompasses an area of approximately 35 square miles in north central Collier County. Each of the partnership entities committed \$200,000 of their 2010 budget toward getting the projects listed in the Immokalee Stormwater Master Plan "shovel ready".



A very definitive effort in the housing area was accomplished via a partnership with the Housing Collaborative in Immokalee in 2011. A \$20,000 grant from the CRA and the Community Foundation and in partnership with the Collier County Housing Authority, the Empowerment Alliance of Southwest Florida, I HOPE, and Immokalee Housing and Family Services provided funding to conduct an Immokalee Housing Condition Inventory - 2011. The first since 2004, the study has provided the basis to define both the housing needs and the need for a housing rehabilitation program.

The Downtown Immokalee Stormwater Improvement Project was completed in 2012 and consists of approximately 17,000 linear feet of new concrete drainage pipe, 200 drainage structures, 1100 square yards of asphalt restoration, 52,000 square yards of sod and a 6.5-acre stormwater retention pond.

In 2012, the CRA was awarded \$994,000 in Community Development Block Grant from Collier County Community and Human Services to purchase land at the corner of 1st Street and Main Street and establish an entry way into the Immokalee Community.

In 2013, two businesses were awarded the Commercial Façade Grant Program The businesses were Paralegal & Notary Services (\$20,000) and Kountry Kitchen (\$20,000). Since 2008 the program has funded 16 façade grants to local business in Immokalee for a total of \$274,621.67.

In 2014, the CRA completed construction of the First Street "Zocalo" Public Plaza. The CRA, MSTU and County Parks & Recreation share maintenance responsibility of the facility which is open to the public. The plaza received many awards.

In 2014, the Immokalee CRA awarded two construction contracts related to the continued implementation of the Immokalee Stormwater Master Plan. Construction for the two sites began in March 2015 and was completed in August 2015.

The Immokalee Drive & North 16th Street Project included the installation of a series of drainage structures connected via a piped conveyance system that meets current design standards. As a pedestrian safety measure, the scope also included the installation of concrete sidewalks on both sides of the roadway.

The CRA also installed a comprehensive asphalt overlay, constructed new driveway aprons, and replaced all effected right-of-way features. The South Florida Water Management District contributed \$200,000 for the design and the CRA used a combination of local CRA Tax Revenue and Florida Department of Opportunity grant funds totaling approximately 3 million.

The Colorado Avenue Project included concrete sidewalks, grading & new sod on both sides of Colorado Avenue from South First to South Ninth Streets in the densely populated downtown Immokalee area. Prior to installing the sidewalks, the CRA filled the open drainage ditches with concrete drainage pipe and fill dirt to create a level area for the sidewalks along the roadway. The CRA funded the project using a combination of local CRA Tax Revenue and Florida Department of Economic Opportunity grant funds totaling approximately \$500,000.







On July 12, 2016, the Board of County Commissioners adopted an ordinance to amend the Land Development Code Section 2.03.07 Overlay Zoning Districts: Main Street Overlay Subdistrict (MSOSD).

The approved amendment amended the conditional and prohibited uses within the Immokalee MSOSD.

On November 18, 2015, the Immokalee Local Redevelopment Advisory Board voted unanimously to seek relief from the prohibitive uses through the conditional use process rather than alter the existing MSOSD boundary. Relief through a conditional use would be provided for properties with frontage on N. First St., S. First St., and N. Ninth St. The conditional uses would not apply to properties with frontage on Main St. located in between First St. and Ninth St. The principal reason for this exception is to preserve these streets as a pedestrian oriented district and to support public safety.

In 2016, the CRA was awarded \$475,000 in Community Development Block Grant (CDBG) funds from Collier County Humans Services to construct sidewalk and stormwater improvements along South Ninth Street, West Eustis Avenue, and a portion on South Fifth Street. In 2017 the CRA was awarded an additional \$125,00 of CDBG funds bringing total award to \$600,000. The overall Immokalee Sidewalk Improvement Project cost was \$741,498. The remainder of the project funds were paid from the CRA and MSTU funds. The construction was completed in May 2018.



In 2016, a Commercial Façade Grant was awarded to Lozano's Restaurant. Since 2008 the program has funded 17 façade grants to local business in Immokalee for a total of \$294,621.67. Construction was completed in 2017.





In 2017, Marketing Alliance was hired by FHERO to develop a marketing plan for the region. In April, they toured, videoed, and photographed the community of Immokalee. The tour efforts included the Immokalee Regional Airport, Pepper Ranch Preserve, Immokalee Pioneer Museum at Roberts Ranch, the Immokalee Produce Center and Lake Trafford.

In 2018, Marketing Alliance was hired by FHERO to develop an economic development overview of the region. On December 14, 2018, they toured, videoed, and photographed the community of Immokalee. The tour efforts included the Immokalee Regional Airport, iTECH (Immokalee Technical College), Seminole Casino Hotel, the Immokalee Culinary Accelerator, and Ann Olesky Park at Lake Trafford.



In 2018, the CRA awarded a reimbursement grant totaling \$30,000 to Residential Options of Florida (ROOF) for renovations to a single-family home to establish Independence Place located in Immokalee. ROOF is a 501(c)(3) corporation founded in 2014 to promote safe, inclusive, affordable housing opportunities for individuals with developmental disabilities. The single-family home was transferred to the ROOF Housing Trust whose sole mission is to acquire, create, and preserve affordable housing in perpetuity to Floridians with intellectual and developmental disabilities.

In **2018**, the Immokalee CRA coordinated with Collier County Transportation Department to connect a portion of sidewalk on North 19th Street and Immokalee Drive. The CRA constructed sidewalks on Immokalee Drive in 2015 with grant funds. A private business owner constructed the sidewalk along North 19th Street in 2017. The CRA coordinated with Collier County Transportation Department to connect the gapped section that was left on the county right-of way. In October 2018, transportation planning staff completed the sidewalk connection.

In January 2018, the Immokalee CRA partnered with Collier County Growth Management Stormwater Department to fund Corrective Action Projects in Immokalee totally \$95,000. The CRA partnered with the Stormwater Department to share the cost of four Corrective Action Projects within the Immokalee area. Growth Management Department covered half the cost and the CRA & MSTU split the remainder cost. This project included both minor improvements to culverts and swales along North 9th Street and Lake Trafford Memorial Gardens and design, permitting and construction review for new pipe and swales for Eden Gardens and North 3rd St. areas. Future funding will need to be allocated to complete the construction of these two projects.



In **November 2018**, A final copy of the Immokalee Stormwater Improvement Program (ISIP) was provided to ICRA staff. This plan was completed by the Collier County Stormwater Department and provides a comprehensive approach to improving stormwater in the community. This plan was an updated document from the ISWMP that was prepared by CDM, but never finalized. By 2015, due to staffing changes and reorganizations, the Collier County Stormwater Management Section staff resumed responsibility for completing the updating of the ISWMP that had been started by CDM.

In June 2019, through a competitive process, the Immokalee CRA was selected and awarded grant funds for additional sidewalk improvements along the southside of Immokalee. The CRA received a total of \$676,365 of HUD funding allocation for CDBG projects. In August 2020, Coastal Concrete was awarded the contract of \$821,756 to construct sidewalks and drainage along both sides of Carver Street and a portion of South 5th Street. Construction began in September 2020 and was completed on April 7, 2021, under construction budget of \$744,590.99.

On **December 10, 2019**, the Immokalee Area Master Plan (IAMP) was approved for final adoption by the Board of County Commissioner. The IAMP is a component of the Collier County Comprehensive Plan. Originally adopted in 1987, the IAMP provides the guiding goals, objectives, and policies for land use in the community. The Board of County Commissioners (BCC) directed staff to update the IAMP and the process began in January 2018. The review focused on complementary land uses, economic vitality, mobility, and environmental sustainability.

In 2019, FHERO was awarded a Regional Rural Development Grant in the amount of \$97,500 which included \$22,000 for the development of a Strategic Economic Development Plan for the Immokalee community. The consultant, VisionFirst, conducted the site tour on March 13, 2020, and developed an overview of their findings that will be incorporated into the redevelopment plan update. Immokalee was also included in the 2020 FHERO guide.

In **2019**, Florida Department of Transportation (FDOT) partnered with the Community Redevelopment Agency (CRA) and the Municipal Service Taxing Unit (MSTU) to program a project on SR 29 in Immokalee due to a history of high bicycle and pedestrian crashes and activity. Construction began in **May 2020** and was completed in **March 2021**.

The purpose of the project is to increase pedestrian and bicyclist safety and consists of installing two Rectangular Rapid Flashing Beacons (RRFB), signing and pavement marking improvements, reconstruction of the lighting system, constructing a new signal at 3rd Street, drainage improvements, and sidewalk enhancements. The project cost was \$1.85 Million. FDOT paid the cost to install 30 standard LED light poles. The MSTU provided \$125,342 to FDOT for installation of holiday attachments on 30 light poles and all efforts associated with adding the attachments, including banner arms, GFCI outlets, additional conductors, mobilization, and maintenance of traffic. The contractor removed 52 of the existing blue light poles for storage.

In 2020, Q. Grady Minor & Associates, P.A (Grady Minor) was hired to provide professional services for future street lighting and pedestrian safety improvements along South First Street (from Main Street to School Road/Seminole Crossing Trail). This work included feasibility studies and conceptual plans for the purpose of relocating existing decorative light poles, considering the future street lighting and pedestrian safety improvements. In 2021, Grady Minor provided the final Conceptual Plan Report that recommends the installation of Rectangular Rapid Flashing Beacons at the three crosswalks and 11 additional Collier County Traffic Operations light poles.

In 2021, two Welcome signs were completed. The sign on the corner of State Road 29 (Westclox and New Market Road Triangle Area) and on 1st and Eustis Avenue. In 2018, the MSTU board approved two monument designs from Q. Grady Minor & Associates, P.A. for monuments located at the Farm Workers Village entrance (Panther Crossing) on SR 29 and on the corner of South 1st and East Eustis Avenue located across from the Seminole Casino Hotel Immokalee. In late 2019, Lykins Signtek was awarded the construction contract to do repairs to the monument located on SR29 and New Market Road and to replace the monument located on South 1st Street and East Eustis Avenue. Artist, Ms. Cantu completed the mural on the sign located downtown on First Street and Eustis Avenue. Currently, construction on the Panther Crossing sign is on hold until the needed easement acquisition is finalized.

In **2021**, the CRA was awarded through FHERO a Department of Economic Opportunity (DEO) Grant totaling \$13,540 for Professional Services to develop a site improvement plan for a parcel on Airpark Blvd. The proposed scope of work includes general consulting, engineering, planning, and survey services to evaluate the subject site for commercial development.

The CRA was also awarded through FHERO a DEO Grant totaling \$7,700 for Professional Services for assessment of retail demand in the Immokalee Community.

On June 28, 2021, Governor DeSantis issued Executive Order Number 21-149 which re-designated the South- Central Rural Area of Opportunity (RAO) for another five-year term with an expiration date of June 28, 2026.


In October 2021 work was completed on eleven mast arm poles at three intersections in Immokalee. In early 2021 staff identified 3 intersections that needed eleven mast arms to be refurbished. The intersections were Main Street/9th Street, Main Street/1st Street, and New Market Road/Charlotte Street. The MSTU board approved to fund the project. The total project cost was \$97,634.04.



On May 10, 2022, the Collier County Board of County Commissioners acting as the Community Redevelopment Agency (CRA), approved a Resolution recommending approval to the BCC an amendment to the Collier County Community Redevelopment Plan. In April 2019, the first amendment of the plan update focused on the Bayshore Gateway Triangle Redevelopment Area. The Board directed staff to update the plan to reflect the changes and needs in the Immokalee Community Redevelopment Area (ICRA). On December 1, 2020, staff issued NTP to Johnson Engineering to provide planning support services for the Immokalee Community Redevelopment Plan. This effort is specific to Section 4 of the Collier Community Redevelopment Agency County Community Redevelopment Plan. Staff is currently working on an implementation schedule. Areas of Celebrating Culture, Focus are Economic Development, Housing, and Infrastructure.

On August 29, 2023, the CRA owned property located at 107 S. 9th St. was sold to Catholic Charities. The CRA had owned the 9th Street property since 2010. The property is approximately 1.96 acres of land at the corner of South 9th Street and W. Main Street in the Immokalee Community Redevelopment Area.

At the end of **November 2023**, the Welcome Sign project on SR29 along the Panther Crossing/Farmworker's Village will be competed. In August 2018, construction of the welcome monument sign was put on hold until the acquisition of the sign easement was acquired. The easement was approved by the Board of County Commissioners on May 24, 2022. After some design rework a Request for Quote (RFQ) for the construction of the monument was issued in January 2023. Vetor Contracting was awarded the contract. Estimated cost is \$195,612.

Status:

To review selected Vision Statement for the Immokalee Community Redevelopment Area to be incorporated into the Immokalee Community Redevelopment Plan.

Background & Analysis:

During the Strategic Planning Session held on December 13, 2023, staff reviewed the current vision statement with County staff, CRA & MSTU board members present, and the public. Discussion was held regarding a need to update current Vision Statement.

Participants were separated into 3 groups and were asked to come up with a Vision Statement for Immokalee.

Below are the suggested Vision Statements.

- Group 1: "To be the best rural community in the nation to live, work, and play!"
- Group 2: "Develop a thriving community"
- Group 3: "A small community that provides safe and affordable living with a diverse culture."

Current Vision Statement:

A rural community that provides safe and affordable multigenerational living opportunities, interconnected pedestrian and transportation connections, a pristine environment, and a thriving economy that celebrates a diverse culture.

Vision Statement from the Immokalee Area Master Plan adopted in 2019:

Immokalee is a family-oriented community that supports a healthy lifestyle. It is attractive, environmentally sustainable and offers a full range of housing, recreation, and education opportunities to meet all residents' needs. Immokalee has a safe, well-connected network to walk and bicycle about town, as well as a roadway network needed to support the transport of goods and services. Business and job opportunities flourish in trade and distribution, agri-business, and ecotourism.

Past Statement excerpted from Annual Reports:

Those of us who live and work in Immokalee envision a future for our town. We see new business and job opportunities in international trade and distribution, Agri business, ecotourism, recreation and entertainment, and the construction industry.

We see Immokalee as an attractive, sustainable community with affordable workforce housing, parks and outstanding schools a place where people walk and bicycle to do their errands, and where parents are returning to school to finish their education and master new job skills Main Street will have a Latin flavor colorful plazas, outdoor cafes, shops and entertainment attracting both the local community and the tourists who come to explore our unique ecology or entertainment at the Casino.

On December 19, 2023, a follow up email was sent to board members and participants of the Strategic Planning Session requesting comments on the three options. Group 3 vision statement was the most selected. Please see the follow up of options.

- 1. "A small community that provides safe and affordable living with a diverse culture."
- 2. "A rural community that provides safe and affordable living with a diverse culture."
- 3. "To be a thriving small community, to live, work and play."

On January 17, 2024, the CRA Advisory Board recommended option 3 with a small revision.

The Collier County Community and Human Services Division (CHS) announces the opening of the FY2024-2025 grant application cycle. During FY2024-2025, Collier County is scheduled to receive federal funds from the U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), Emergency Solutions Grants (ESG), and State Housing Initiatives Partnership (SHIP) funds.

The pre-application period for local, State and Federal grant funds will begin on Tuesday, January 9, 2024, and will continue until 12:00 p.m. noon on Friday, January 19, 2024. Those invited to complete a full application will be notified prior to January 31, 2024. The full application portal will be opened to invitees Wednesday, January 31, 2024 and will close at 12:00 p.m. noon, Wednesday, February 21, 2024. The pre-applications will be available through the CHS website at www.colliercountyfl.gov under the CHS Main page link and paper copies of the application may also be obtained at our offices at 3339 Tamiami Trail East, Suite 211, Naples, FL 34112.

All pre-applications must be consistent with the Collier County's Consolidated Plan and/or SHIP Local Housing Assistance Plan (LHAP). Pre-application and full application details are provided in the FY2024-2025 Grant Application guidance.

Application Guidance:

Administered by the U.S. Department of Housing and Urban Development (HUD), the federal programs projects must meet one or more of three national objectives:

- Benefits low- and moderate-income persons or households who earn at or below 80% of the median income
- Aids in the prevention or elimination of slums or blight
- Qualifies as a certified urgent need

Collier County, along with its entitlement city, Naples, will receive approximately \$2,574,633 in CDBG funds, \$844,948 in HOME funds and \$211,534 in ESG funds for the 2024-2025 grant cycle. State SHIP funds totaling approximately \$3,000,000, if allocated, will also be included in this grant application cycle. Funding amounts are subject to change based on actual amounts awarded from grantor agencies and availability of funds. Awards made under SHIP may only be used to support homeowner strategies such as Purchase Assistance, Housing Rehabilitation, Demolition & Replacement of Manufactured Homes and New Construction Assistance and other identified strategies.

One-on-one technical assistance meetings are mandatory in order to be considered to be invited to submit a full application. Those interested in applying in the FY2024-2025 funding cycle should contact CHS by calling 239-252-2339 to schedule a meeting between January 25, 2024, and January 30, 2024. No applications will be accepted unless a pre-application and a one-on-one technical assistance meeting have occurred.

Any questions, comments, clarifications, or changes made during the technical assistance period and/or with individuals will be made public on or about January 31, 2024, on the CHS website and through an email blast.
