FY2025 Continuum of Care Program Local Grant Competition Timeline Updated: 06.18.25

The FY2024 and FY2025 Continuum of Care Competition and Renewal or Replacement of Youth Homeless Demonstration Program Grants Notice of Funding Opportunity (NOFO FR-6800-N-25), released by the U.S. Department of Housing and Urban Development (HUD) in July 2024, provided an overview of the FY2025 Continuum of Care grant competition process with a due date of August 29, 2025.

However, HUD has recently indicated that the FY2025 competition may have a revised process and timeline. When the PA-502 CoC receives updated guidance from HUD, the local grant competition timeline of activities will be revised. June – July 2025	<ul style="list-style-type: none">CoC grantees conduct a quality review of HMIS program and client data for accuracy and correct any errors or omissions.CoC Governing Board and Collaborative Applicant set priorities for New Projects.Grant Inventory Worksheet (GIW) reviewed, revised (if necessary), and submitted to HUD (TBD).CoC Governing Board and Collaborative Applicant assess current renewal grant projects for possible reallocation based on system performance measures and HUD spending reports.CoC Project Review Committee composed of non-conflicted CoC members is recruited.
July 2025	<ul style="list-style-type: none">CoC Governing Board and Collaborative Applicant issue request for New and Renewal Project Letters of Intent (LOIs).CoC Governing Board and Collaborative Applicant review FY2024 New and Renewal Project Scorecards.
July – August 2025	<ul style="list-style-type: none">HUD releases amended FY2025 NOFO (TBD).CoC Governing Board and Collaborative Applicant finalize New and Renewal Project Scorecards and post online for public review.CoC Project Review Committee reviews and recommends New Project LOIs to the Governing Board.
August – September 2025	<ul style="list-style-type: none">CoC Governing Board invites applicants to apply for New Projects in HUD e-snaps.Renewal project applicants submit applications in HUD e-snaps.
