Labor Department Hiring 100 Investigators

US DEPARTMENT OF LABOR ANNOUNCES PLANS TO HIRE 100 INVESTIGATORS TO SUPPORT ITS WAGE AND HOUR DIVISION'S COMPLIANCE EFFORTS

Division seeks to build out enforcement team nationwide

WASHINGTON – The U.S. Department of Labor today announced that its Wage and Hour Division is seeking to add 100 investigators to its team to support its enforcement efforts including the protection of workers' wages, migrant and seasonal workers, rights to family and medical leave and prevailing wage requirements for workers on federal contracts.

In fiscal year 2021, the Wage and Hour Division collected \$230 million in wages owed to 190,000 workers. Division representatives also conducted 4,700 outreach events to educate employers and workers alike about their workplace rights and responsibilities.

New Overtime Threshold Increase Expected

Re: Request for Stakeholder Meetings Prior to Development and Release of Proposed New Overtime Regulations under the Fair Labor Standards Act

The 110 undersigned organizations, which represent a wide range of employers from private industry, states, municipalities, universities, colleges, k-12 schools and non-profits, write to request the U.S. Department of Labor ("DOL") hold stakeholder meetings prior to the development and issuance of its anticipated Notice of Proposed Rulemaking ("NPRM") on the "exemption of bona fide executive, administrative, and professional employees from the Fair Labor Standards Act's minimum wage and overtime requirements" (also known as the "white-collar" exemptions). In the Fall 2021 Regulatory Agenda, DOL's Wage and Hour Division announced its plans to issue an NPRM modifying the white-collar overtime exemptions in April 2022. This will be a significant rulemaking with respect to cost, difficulty in implementation and impact on the workforce, particularly given the current acute labor shortages. Our organizations urge DOL to follow past precedents and hold meetings with the regulated community to obtain input on the potential impact of any changes to the overtime exemption requirements.

- Currently \$35,568
- Proposal likely to raise to at least \$50k
- Some want over \$80k threshold
- Also looking at Highly Compensated Employees

Form 300A Filing Due Electronically March 2

ANNOUNCEMENTS

March 2, 2022, is the deadline for electronically reporting your OSHA Form 300A data for calendar year 2021. Collection began January 2, 2022.


Does OSHA notify employers that they need to report their Form 300A data? And if not, where do I get my Username and Password to login and provide my data?

OSHA does not send out notifications to report the Form 300A data. If your establishment meets the industry and size reporting criteria, you must create an account in the Injury Tracking Application (ITA). During the account creation process, you will create your own username and password. Once you create your account, you can login and report your Form 300A data on an annual basis. Each year the data is due by March 2nd. To create an ITA account, go to https://www.osha.gov/injuryreporting/ita/ and click the *Create an account* link that is right below the Injury Tracking Application banner. Follow the instructions from there.



- \$10 billion for State Small Business Credit Initiative
- Convene 16 Manufacturing USA institutes to develop proposals to strengthen supply chains; Create SBA Committee of Industry leaders
- Open \$450 million Port Infrastructure Development Grant program
- Invest in sustainable domestic production, processing of critical minerals
- New Buy American category allows Government to pay more for domestic

Supply Chains and Legislation on Capitol Hill House Bill Formally Sent to U.S. Senate

U.S. China, Supply Chain Bill Moves to Conference

- Bipartisan Senate bill passed 68-32; House bill: one GOP yes, one Dem no
- House, Senate must reconcile differences in a Conference Committee process
- Legislation creates regional manufacturing and technology hubs
- Both bills have \$52 billion to incentivize U.S. semiconductor manufacturing
- Senate has \$81 billion to create a new directorate of technology, innovation
- House included extraneous items including PRO Act union expansion
- Goal is to reconcile differences by Memorial Day and pass a bipartisan bill

Efforts to Include Workforce Training in Supply Bill

- House bill includes \$5.2 billion for STEM workforce and education
- House added National Apprenticeship Act update, likely removed in final bill
- House added JOBS Act, allowing short term Pell Grants for 8-week programs
- House bill includes College Transparency Act
- Senate Education Committee does not want major policy included
- Congress unlikely to move on Higher Education Act this year
- If Congress passes spending bill, will include increases for apprenticeships



China Fell Short of 2020 Phase I Deal Purchases


US manufacturing exports to China covered by the phase one deal, billions USD

We write to express our concerns about the threat posed to domestic production of grain-oriented electrical steel (GOES). Since the United States has only one remaining producer of GOES, we urge you to revisit the findings of the Department of Commerce's report from October 15, 2020, on "The Effect of Imports of Transformers and Transformer Components on the National Security" and take appropriate action before there is further damage to our domestic production.

Right Steel Industry Problem: Wrong Solution

We are writing to you as a follow-up to the letter that you have received from Senators Brown and Portman regarding imported core components of grain oriented electrical steel (GOES) for use in the manufacture of transformers in the USA. This issue was the subject of a Section 232 investigation by the Department of Commerce (DoC) during 2019, with the final report not released until 2021.

Senators Brown and Portman identify that imports "threaten the security of the US", which is the finding of the DoC report, but also threaten jobs in the US, specifically 1,400 steelworker jobs at the Butler, PA and Zanesville, OH plants of Cleveland-Cliffs (Cliffs), the only manufacturer of GOES in North America. However, the Senators do not identify that the total capacity for production of GOES by Cliffs, currently operating at 100% capacity, is far below the normal consumption of GOES in the US, as shown by the following:
