

## CDC When to Quarantine Calculator Released



#### New Guidance on Access to Federal Facilities

**UPDATED** Q: Should agencies require documentation from visitors to verify their attestation of vaccination status?

A: When the <u>COVID-19 Community Level</u> is MEDIUM or HIGH in a county where a Federal facility is located, visitors to that facility (except those visitors seeking a public benefit or service, who do not need to attest to or otherwise document vaccination status) should attest to their vaccination status using the <u>Certification of Vaccination form</u>, but agencies should not ask those visitors for documentation to verify their attestation.



NEW Q: Should visitors to Federal facilities provide proof of a negative COVID-19 test?

A: When the <u>COVID-19 Community Level</u> is MEDIUM or HIGH in a county where a Federal facility is located, visitors who are not fully vaccinated or who decline to provide information about their vaccination status should be able to provide proof of a negative COVID-19 test from within the previous 3 days when in that facility. At GSA-controlled facilities, it is the responsibility of the occupant agency associated with the visitor to ensure that individuals accessing the facility have the appropriate documentation given their COVID-19 vaccination status.



## EEOC COVID FAQ: Religious Objections

- L.1. Do employees who have a religious objection to receiving a COVID-19 vaccination need to tell their employer? If so, is there specific language that must be used under Title VII? (3/1/22)
- L.2. Does an employer have to accept an employee's assertion of a religious objection to a COVID-19 vaccination at face value? May the employer ask for additional information? (3/1/22)
- L.3. How does an employer show that it would be an "undue hardship" to accommodate an employee's request for religious accommodation? (3/1/22)
- L.4. If an employer grants some employees a religious accommodation from a COVID-19 vaccination requirement because of sincerely held religious beliefs, practices, or observances, does it have to grant all such requests? (3/1/22)
- L.5. Must an employer provide the religious accommodation preferred by an employee if there are other possible accommodations that also are effective in eliminating the religious conflict and do not cause an undue hardship under Title VII? (3/1/22)
- L.6. If an employer grants a religious accommodation to an employee, can the employer later reconsider it? (3/1/22)

#### EIDL Deferment Extended from 24 to 30 Months

- This deferment extension is effective for all COVID-EIDL Loans approved in calendar years 2020, 2021, and 2022. Loans now have a total deferment of 30 months from the date of the Note. Interest will continue to accrue on the loans during the deferment.
- Borrowers may make partial or full payments during the deferment period but are not required to. The SBA recommends using <u>www.pay.gov</u>.
- The SBA will not send monthly SBA Form 1201 payment notices; however, the SBA will send regular payment reminders via email.
- Existing COVID EIDL Borrowers can find account balances and payment due dates in the SBA Capital
   Access Financial System (CAFS) and learn how to set up an account in the CAFS system by logging in at
   <u>Capital Access Financial System (sba.gov).</u>
- Deferments may result in balloon payments. The deferment will not stop any established Preauthorized Debit (PAD) or recurring payments on the loan. COVID-EIDL Borrowers with an SBA established PAD must contact their SBA servicing center to stop recurring payments during the extended deferment period. COVID-EIDL Borrowers who have established a PAD through Pay.Gov or any other bill pay service are responsible for terminating recurring payments during the extended deferment period.
- After the deferment period ends, COVID-EIDL Borrowers will be required to make regular principal and interest payments beginning 30 months from the date of the Note.

## Construction: Changes to Davis-Bacon Prevailing Wage

The Department also proposes changes, in § 1.2, to the definition of "prevailing wage," and, in § 1.7, to the scope of data considered to identify the prevailing wage in a given area. To address the overuse of weighted average rates, the Department proposes to return to the definition of "prevailing wage" in § 1.2 that it used from 1935 to 1983. [13] Currently, a single wage rate may be identified as prevailing in the area only if it is paid to a majority of workers in a classification on the wage survey; otherwise a weighted average is used. The Department proposes to return instead to the "three-step" method that was in effect before 1983. Under that method (also known as the 30-percent rule), in the absence of a wage rate paid to a majority of workers in a particular classification, a wage rate will be considered prevailing if it is paid to at least 30 percent of such workers. The Department also proposes to return to a prior policy on another change made during the 1981-1982 rulemaking related to the delineation of wage survey data submitted for "metropolitan" or "rural" counties in § 1.7(b). Title: \*Passenger Car and Light Truck Corporate Average Fuel Economy Standards

Abstract:

This rulemaking would reconsider Corporate Average Fuel Economy (CAFE) standards for passenger cars and light trucks that were established in the agency's April 30,2020 final rule. This rulemaking would respond to requirements of the Energy Independence and Security Act of 2007 (EISA), title 1, subtitle A, section 102, as it amends 49 USC 32902. The statute requires that corporate average fuel economy standards be prescribed separately for passenger automobiles and non-passenger automobiles. For model years 2021 to 2030, the average fuel economy required to be attained by each fleet of passenger and non-passenger automobiles shall be the maximum feasible for each model year. The law requires the standards be set at least 18 months prior to the start of the model year.



# U.S. Imports Little from Russia



## Half of Airbus Titanium Comes from Russia; 1/3 for Boeing

#### TITANIUM AND TITANIUM DIOXIDE<sup>1</sup>

(Data in metric tons unless otherwise noted)

<u>Domestic Production and Use</u>: <u>Titanium sponge metal was produced by one operation in Uta</u>h. Production data were withheld to avoid disclosing company proprietary data. The facility in Salt Lake City, UT, with an estimated capacity of 500 tons per year, produced titanium that was further refined for use in electronics. A second sponge facility in Henderson, NV, with an estimated capacity of 12,600 tons per year, was idled since 2020 owing to market conditions. A third facility, in Rowley, UT, with an estimated capacity of 10,900 tons per year, has remained on careand-maintenance status since 2016.

Although detailed 2021 consumption data were withheld to avoid disclosing proprietary data, the majority of titanium metal was used in aerospace applications, and the remainder was used in armor, chemical processing, marine hardware, medical implants, power generation, consumer, and other applications. The value of imported sponge was about \$140 million, a significant decrease compared with \$173 million in 2020.

In 2021, titanium dioxide (TiO₂) pigment production, by four companies operating five facilities in four States, was valued at about \$3.2 billion. The estimated end-use distribution of TiO₂ pigment consumption was paints (including lacquers and varnishes), 60%; plastics, 20%; paper, 5%; and other, 15%. Other uses of TiO₂ included catalysts, ceramics, coated fabrics and textiles, floor coverings, printing ink, and roofing granules.

Import Sources (2017–20): Sponge metal: Japan, 88%; Kazakhstan, 8%; Ukraine, 3%; and other, 1%. Titanium dioxide pigment: Canada, 40%; China, 19%; Germany, 9%; Belgium, 5%; and other, 27%.



#### Yield gap on 2-year and 10-year Treasuries





# Tariffs, Trade, and Supply Chains Legislation on Capitol Hill

### U.S. China, Supply Chain Bill Moves to Conference

- Bipartisan Innovation Act is new term for USICA/America COMPETES bills
- March 23, 2022: Senate proceeded to move by a 66-31 vote on House bill
- House and Senate must reconcile differences in bills both chambers passed
- Senate intends to form conference by end of March
- First Conference Committee meetings in April to negotiate final bill
- Efforts to include JOBS Act, College Transparency Act continue
- House GOP wants to include domestic energy provisions
- House includes provisions for domestic tooling, forming, casting, machining

#### USTR Grants 352 China 301 Tariff Exclusions

- Exclusion temporarily suspends 25% or 7.5% tariffs on particular import
- Exclusions apply to goods entered for consumption, or withdrawn from warehouse for consumption, on or after 12:01AM Eastern time on October 12, 2021, and before 11:59PM Eastern time on December 31, 2022
- The reinstated exclusions are available for any product that meets the description in the product exclusion
- U.S. Customs and Border Protection will issue instructions on entry guidance and implementation
- Air purification equipment; aluminum valve bodies; steel push pins; AC and DC motors; printed circuit board assemblies; x-ray tables; crab meat; woven fabric; bicycles; metal chair frames; foldable tables; blankets

## U.S. Replaces UK Steel, Aluminum Tariffs with TRQs

- Deal reached on March 22, 2022 between U.S. and UK
- Steel and Aluminum Tariff Rate Quota system takes effect June 1, 2022
- Steel TRQ is set at 0.5 million metric tons (MMT) under 54 product categories and allocated in line with the 2018-2019 historical period
- Steel must be melted and poured in UK and have UK country of origin
- Steel melted and poured in UK but further processed in EU eligible for duty-free treatment and count against UK TRQ, not to exceed, 37,800 MT
- Aluminum TRQ is set at 0.9 thousand metric tons (TMT) for unwrought aluminum under 2 product categories and 11.4 TMT for semi-finished (wrought) aluminum, other than foil (7607), under 12 product categories

CAMMU Statement on United States-United Kingdom Agreement on Steel and Aluminum

Washington, D.C. – The Coalition of American Metal Manufacturers and Users (CAMMU) today issued the following statement:

"The US-UK agreement to replace the existing Section 232 steel and aluminum tariffs with a tariff rate quote (TRQ) system that allows a certain amount of imported steel and aluminum from the UK will increase the supply of these raw materials in the U.S., which could help U.S. manufacturers who continue to have long delivery delays and continue to pay the highest prices in the world. However, it is disappointing that the agreement will not completely terminate these unnecessary trade restrictions on one of this country's closest allies, the United Kingdom.

As we are already seeing with the U.S.-EUTRQ agreement where some steel products' quota filled up for the year in the first two weeks of January, this type of government restriction on raw materials and intervention lead to market manipulations and allow for gaming of the system that puts this country's smallest manufacturers at an even further disadvantage.
