No, the hand signal "4" itself is not generally considered a cry for help; the widely recognized hand signal for discreetly asking for help is typically made by holding your palm up, tucking your thumb into your palm, and then folding your fingers over the thumb, essentially "trapping" the thumb - often referred to as the "Signal for Help" or "violence at home signal."
