I hope this email finds you well. I am writing to inform you that after careful consideration, I have decided not to sign the affidavits you have prepared. Add

I want to clarify several points regarding this decision:

- 1. As a general rule, we do not sign documents that we have not created ourselves. This is to ensure that we fully understand and agree with every aspect
- 2. In Connecticut homeschool programs, school districts do not typically sign affidavits or similar documents for our students. This is not a standard practi
- 3. I remain deeply confused about the purpose of these affidavits. It's entirely unclear to me why they are necessary or what specific need they are mean context of our homeschooling program. This lack of understanding is a significant factor irrour decision.
- 4. This decision extends to all members of my staff. None of us will be signing these affidavits.

Given these concerns, neither I nor my staff feel comfortable signing these documents. I cannot emphasize enough how puzzled I am by the need for the could provide more information about their purpose and necessity, I would be very interested in understanding the rationale behind them.
