 \hookrightarrow <u>Reminder</u>.....Please continue to exercise caution when launching your boat at the community boat ramp. There is slick mud on the concrete launch pad below the waterline. Also, watch for snakes. Some were seen during recent clean-up of the area.

 \hookrightarrow The Association is reviewing the need for additional street lighting. Please notify the Association if you believe additional lighting is needed in your area. The Association will compile the data for consideration.

 \hookrightarrow Mowing of right of ways will begin again soon. Please remember not to park on the road easements. Parking on the side of roads in the subdivision impacts large vehicles trying to get through the streets and creates a safety hazard.

SUMMARY OF MARCH POA BOARD MEETING

ATTENDANCE

Directors present were Gretchen Beausoleil, Roger Biedanski, David Doughty, Fay Earls, Petie Grant, Rod Kirschner, Marcy Metz, Gail Miller, and Barbara Niles. Also present was Ann Young, Administrative Assistant. Absent were Charlotte Arnold and Jim Savoy.

MANAGEMENT/TREASURER'S REPORT

Financial report was presented for February, 2019, itemizing checks, deposits, and balances. A motion was made by David Doughty, seconded by Petie Grant to approve the financial report as presented. The motion passed.

OLD BUSINESS

Budget for 2019-20 & Special Assessment Review

The Board continued its review of income and expenditures in order to propose a budget to property owners for their review and approval during the June 8 annual meeting.

Mowing

Mowing bids were presented to the Board for review and consideration. The Association's attorney advised that the only time soliciting bids (Texas Property Code 209.0052) is required is when the Association is obtaining a bid from a company that has a relationship with a current board member. In that case, soliciting at least 2 other bids is required if the current mowing contract is with a current board member, or a family member of a current board member. If the current mowing company has no affiliation with a current board member, no bids are required.

However, since a current board member is affiliated with the company that had the mowing contract last year and has submitted a bid to renew the contract, the attorney further advised that the Association is not required to go with the lowest bid, but just needs to make an informed and reasonable business decision as to which contractor will provide the most bang for the buck so to speak. Some factors for the Board to consider were: 1) historical performance (if applicable), 2) reputation in the community/industry, 3) the ability to meet the needs of the needs of the Association and the ability to perform good work, 4) providing proof of applicable insurance, 5) offering a reasonable price for the services to be performed.

Based on all of the information presented, Board members accepted the bid from the current contractor at the same rate as paid last year. The motion was passed unanimously.

Boat ramp parking area/stone/gravel

Last month the Board discussed the need for additional stone/rock/gravel for the boat ramp and parking area. Recent flooding has caused a need for additional materials to be placed in the area. Prices and materials were obtained and the Board reviewed various options. The decision was made to experiment with one load of cement treated gravel that will be placed around the boat launch area. If the new materials work successfully, the Board will consider using these materials in additional areas around the boat ramp and parking area.

Property owners will be notified by email of the temporary closing of the boat ramp during the completion of this project.

Parking on road easements



The Deed Restrictions prohibit parking of boats, trailers or automotive vehicles on roads or road shoulders for a period longer than twenty-four (24) hours.

Property owners were made aware through the Newsletter and Facebook page of the concerns created from vehicles parking on the road easements in the subdivision. Parking on the easements is also a traffic safety issue, as well as a problem for the people who mow the right of ways. It is understandable that for brief periods of time during bad weather, some property owners avoid parking on their own property to avoid getting stuck. However, during dry weather, this should not be the issue.
