• **FREE 911 PLAQUES** are still being prepared for property owners who have requested them. Additional numbers for the plaques have been ordered, so not all orders have been filled. If you have not received the plaque you ordered, it is in progress.

The 980 North VFD, in partnership with the county Emergency Services District, has made the materials available to make individual plaques with house numbers. This will help emergency responders locate addresses more easily. Please contact the Association office with your house number if you would like to have a free plaque. With the help from the success of the last few annual fundraisers, the Department has placed an order for a new brush buggy that will be utilized to help fight ground fires. The buggy will be fully equipped with a foam system and a 70-gallon water tank. As soon as the buggy is received, pictures will be provided. Thank you to our supporters for your generous contributions and continued support to make this possible. The volunteer members of the 980 North VFD consider it an honor and a privilege to provide this service to our community.

The Department is trying to organize an event that will bring our community together. One idea that has been discussed is a pot luck game day at the fire station grounds. Hopefully this will be announced in the very near future.

The Department is pleased to welcome several new members to the team: Gabe, Tara & Ashton Johnson, Luke Lewis, Michael DeJournett. We now have 23 members whose volunteer duties range from firefighting to support.

Community Reminders and General Information

You may contact the Association office for information for electrical, septic, water, phone, and internet service providers, and applications for home improvements.

Property owners should not dispose of household garbage on their property. It has been observed that some property owners have cardboard, treated wood, plastic bags of trash, etc. on their burn piles. The only items that should be burned on site are natural vegetation such as leaves, limbs, or plant debris that originated on their property. It is considered a deed restriction violation to have garbage and trash items discarded and burned on site.

Unrestrained dogs are subject to pick up by the county animal control authority. Please keep your pets restrained. This is a county ordinance. If you experience an animal nuisance, continue to take pictures and log the event(s) and file a report with the sheriff dispatch for the animal control deputy. (936) 653-4367.

You may report pot holes and any other hazardous road conditions to the County Commissioner (936) 377-2481, or to the Association office (936) 891-5132.

Please do use the road easement for parking. Mowers are not able to reach those areas. In some areas, parking on the road easement causes a traffic hazard.

Are You Prepared For An Emergency?

An emergency is defined as "an unforeseen combination of circumstances or the resulting state that calls for immediate action." An emergency doesn't necessarily mean a disaster. It could mean that your child needs a copy of his birth certificate to register for school, or you need a copy of the paperwork for your automobile when a brand-new set of wheels catches your eye. If you don't already have important papers together in a safe place, maybe this is a good month to buy a small fireproof box and gather those papers together that might include:

- Wills, social security cards, passports, birth certificates, divorce and custody decrees, immigration documents.
- Property deeds, mortgage company address and phone number, homeowners and life insurance policies and phone numbers, copies of health insurance card and phone numbers.
- o Inoculation records, health records, doctors' and dentists' names, addresses and phone numbers. This is also important for pets, as well.
- Auto ownership papers, auto insurance policies and phone numbers, drivers and auto license numbers.
- o Credit card numbers, addresses and phone numbers for outstanding loans.
- Stock and securities certificates, address and phone number of broker, bank account numbers, addresses and phone numbers of banks.
- A current copy of your employment resume, as well as a list of previous home addresses and dates of residence.
- An extra copy of your address book, complete with phone numbers and addresses of friends, relatives and professional resources.

You'll be surprised at how useful it will be to have this information in order and accessible.
