



## Four Front Doodles, LLC.

Four Front Doodles, LLC is committed to producing healthy, happy, and well-adjusted puppies. We take great pride in the quality and health of our puppies and are pleased to offer a comprehensive 10-year health guarantee for our beloved doodles.

When you purchase a puppy from FFD, you automatically receive a 10-year health guarantee, which becomes effective on the date you receive your puppy.

### **10 Year Health Guarantee**

#### 1. Initial Health Check

All puppies from Four Front Doodles, LLC come with their vet records from a licensed veterinarian, verifying that they are in good health at the time of sale. It is required that you take your puppy to a licensed veterinarian within 14 days of receiving the puppy, he/she is examined by a licensed veterinarian and any health problems that pose a serious risk of euthanasia or death due to a genetic defect, buyer shall notify Four Front Doodles, LLC with a written statement from the licensed veterinarian describing the puppy's health issues.

A Hip or Elbow Dysplasia diagnosis must be documented and confirmed by your veterinarian and/or an official OFA consultation. Four Front Doodles, LLC reserves the right to seek the opinion of a veterinarian of the breeder's choice, if needed.

In the case of sudden demise of puppy, Front Doodles, LLC must receive a written notice of puppy's death from the new owner's veterinarian, along with a necropsy report indicating cause of death. Cause of death must be determined to be due to congenital defect only.

Failure to notify Four Front Doodles, LLC within the 20-day period of any immediate issues with your puppy, as mentioned above will void this guarantee.

## 2. Congenital and Hereditary Conditions

We guarantee that your puppy is free from any life-threatening congenital or hereditary conditions for the first ten (10) years of their life. If a life-threatening congenital or hereditary condition is diagnosed by a licensed veterinarian within this period, we will provide one of the following options:

### - Return & Replacement Puppy

- Return your original puppy and a replacement puppy of similar value and breed will be provided to you. Replacement puppy is based upon availability of current litters.

### - Credit Towards Future Puppy

- Instead of a direct replacement, Four Front Doodles will provide a credit towards the purchase of a future puppy. Credit is based upon original purchase price of puppy.  
Example: Original Purchase Price: \$2,400.00 – Credit Towards New Puppy - \$2,400.00

## 3. General Health

We guarantee that your puppy will be free from any life-threatening illness for the first three (3) years of their life. Should your puppy develop a life-threatening illness within this time frame, you must notify us immediately. This guarantee covers conditions that adversely affect the health of the puppy and excludes injuries, infections, and illnesses caused by accidents, neglect, or improper care.

## 4. Extended Health Protection

From year four (4) to year ten (10), we guarantee your puppy against any genetic disorders that may significantly affect their quality of life. In the event of such a condition being diagnosed and confirmed by two licensed veterinarians, we will offer a replacement puppy of equivalent value or a credit towards a future puppy, subject to availability.

## **Owner Responsibilities**

To maintain the validity of this health guarantee, the owner must:

1. Veterinary Care:
  - Provide regular veterinary care, including:
  - Vaccinations, deworming, and annual check-ups
2. Diet:
  - Maintain a healthy diet
  - Ensuring proper nutrition
  - Weight management

3. Quality Dog Food:
  - The owner agrees to feed their dog high-quality dog food
  - Ensuring proper nutrition is essential for the health and well-being of your dog
    - Examples: 4 Health, Purina Pro Plan, Hill's, Fresh Pet, Blue Buffalo
4. Exercise:
  - Provide adequate exercise
  - Mental stimulation to ensure overall well-being
5. Spay/Neuter:
  - The puppy must be at least 12 months old before being spayed or neutered for this contract to remain valid. Electing to spay or neuter the puppy before this age is at your own discretion but will void the contract.
6. Preventative Measures:
  - Administer hip and joint, flea, tick, and heartworm preventatives as recommended by your veterinarian

### **Exclusions**

This health guarantee does **not** cover:

1. Conditions resulting from injuries, neglect, or improper care.
2. Injuries and/or trauma while in your care (broken bones, related injuries, etc.)
3. Common conditions that may affect any breed, such as ear infections, dental issues, parasites, giardia, coccidiosis, heartworm, mites, fleas, skin allergies, or hip dysplasia due to non-genetic causes.
4. Any condition that develops due to the puppy's environment, including exposure to harmful chemicals or extreme conditions.
5. Feeding this dog anything other than a quality dog food. Proper protein/calcium ratios especially are crucial to proper health and development.

## **Claim Process**

In the unfortunate event that a health issue arises, the following steps should be taken:

1. Notification: Notify Four Front Doodles, LLC immediately upon diagnosis of a covered condition.
2. Documentation: Provide written documentation from a licensed veterinarian, including test results and diagnosis. We will also require documentation from your licensed veterinarian, including yearly check up, vaccination, and wellness check receipts to ensure your puppy has received proper care.
3. Second Opinion: Be prepared to obtain a second opinion from a veterinarian of Four Front Doodles, LLC's choosing, if requested.

## **Agreement**

By purchasing a puppy from Four Front Doodles, LLC., you acknowledge that you have read, understood, and agree to the terms and conditions of this health guarantee.

## **Disclosure**

If Four Front Doodles, LLC is no longer open for business, this notice serves to inform all concerned parties that any and all puppy contracts previously established with Four Front Doodles, LLC will be voided and considered null and void.
