

Transcript of call with ##ShirinaHolmatovaHolmatova

Lady Whistleblow: yeah, sorry, I just needed to make sure that... because I don't live alone anymore. Because, like you said, you are calling me on behalf of someone who is worried for my safety... And I had to move out of my place because I was threatened with my safety..

#ShirinaHolmatova: Of course.. Trust me I know a lot more about what you're going through because you are not alone. Similar things have happened to lots of people.

Lady Whistleblow: But how... I don't understand... who's given you my number and how did they get my number?

#ShirinaHolmatova: Listen, I can't tell you for the same reason... like just as how you feel you can't trust me, this person... they want to help you but letting you know who they are is putting themselves at risk as well. They want to help you but they need to know...

Lady Whistleblow: But if you don't trust me, how can I trust you?

#ShirinaHolmatova: Because first, I wanted to call you and see **if you would be interested in at least talking to this person...** and if you do, if you could not... basically keep it confidential for the safety of both of you.

Lady Whistleblow: yeah, fine. I'll talk to them but I am not meeting anyone because I don't trust anyone

#ShirinaHolmatova: That's completely understandable... Umm so...

Lady Whistleblow: So are you from Narghiza's side?

#ShirinaHolmatova (after a brief pause): Sorry?

Lady Whistleblow: Are you from Narghiza's side? Whose side are you from?

#ShirinaHolmatova: AAhh... I'm sorry (chuckle) I... I'm... can't say...

Lady Whistleblow: OK.. so what's the next step? Now you told me that someone on the inside, which I'm guessing is someone who is their friend, **wants to help me get my money back.**

#ShirinaHolmatova: Yes

Lady Whistleblow: What's the next step?

#ShirinaHolmatova: Listen, I don't know about what... what is planned, or what is going to happen. My... **My job was simply to give you a call and see if you would be OK with this.**

Lady Whistleblow: Yeah, I'm ok with this... Yes of course if they can bring my money back, I'm OK with it.

#ShirinaHolmatova: yes, but... Um... you need to be aware obviously that the people you are dealing with in this situation, they are crazy people. They are incredibly unsafe and I r... everyone involved needs to be really careful and you know because if this person is going to help you they will be risking their life and their safety.

Lady Whistleblow: Ok

#ShirinaHolmatova: Ok. So **if you are all alright with this, I will tell the person to give you a call sometime tomorrow. Is that OK?**

Lady Whistleblow: Yeah. But tomorrow for half the day I am not available. I'm not available in the morning.

#ShirinaHolmatova: OK. I will tell them to give you a call a...

Lady Whistleblow: Actually you know what... no no no... actually I can.. I can make time in the morning. Can you give me an exact time when.. when this person would call? Is it a woman or a man that would call?

#ShirinaHolmatova: Oh I.. I.. I can't... I can't say to you.. yet. Umm, but I... I do have to tell you that please do not say anything to anybody especially Joanne.

(Long Pause)

Lady Whistleblow chuckles.

#ShirinaHolmatova: Because she is not reliable.

Lady Whistleblow: yeah I know. I put one and one together and I realized that Ross pays her money... 'cause he told me he gives money to her and her family, and now that I see Enrico has been giving Ross a lot of my money I'm guessing she's also benefitted from this (the con)

#ShirinaHolmatova: yes... yes.. like I said, the people that you are dealing with they are absolutely horrible people so it's best that... you know... just... for your safety as well.. just do not tell anybody about this phone call.

Ok, so umm, so would about some time between 10 to 12 um work?

Lady Whistleblow: It's a big window. I would prefer a call before 10 o'clock if it's possible

#ShirinaHolmatova: Oh Ok

Lady Whistleblow: before 10 would be easier to take the call

#ShirinaHolmatova: Ah Ok.. now I... I.. I can't let you know right now when that this person.. this person will call you.. but ummm... yeah I'm sorry I'm just a messenger I don't really know ah..

Lady Whistleblow: Do you wanna call them and call me back?

#ShirinaHolmatova: eeh.. ok... sure!

Lady Whistleblow: Ok.. call them and call me back please. Or they can call me... I mean since we're in an arrangement... You're calling me from a No Caller ID. That person can also call me from a No Caller ID.

#ShirinaHolmatova: Ah yes... it is just... you know like, if this.. **this person uses their voice, then it will be pro.. very risky for them that's why I had to call you.**

Lady Whistleblow: Tsk.. Look I cannot take their voice anywhere. The thing is that all I am interested in is my money. I have a sick mother, that desperately needs money and these assholes have done this. I don't give a shit. All I want is my money. Because if I do not get my money, I will be sending these people to prison. I have access to their accounts and I have seen what they do. They are involved in money laundry and avoiding bankruptcy, the... the.. it's.. it's... If I'm not getting my money they're all gonna go down.

#ShirinaHolmatova: Listen, you... like... I .. I know you don't know who I am but I.. I feel for you because I know exac... like I.. I've been through a similar situation that you have.. and I as well want these people to go to jail... and so does the person who wants to help you. But the thing is in order to work together **it needs to be.. like.. very carefully executed.. what.. what the plan is, the steps you guys take.** Because if you both make the mistake you both will be putting yourself at risk.

Lady Whistleblow: OK

#ShirinaHolmatova: Ok

Lady Whistleblow: You can call that person and call me back please.

#ShirinaHolmatova: OK, I will

Lady Whistleblow: or.. or that person can call me directly from a no caller ID.. they can give me another name.. it doesn't matter.. but you know so that you are not in this.. you know in the middle if you know.. instead of calling me, calling them and you know stuff like that.

#ShirinaHolmatova: yes I, I understand... Umm look I, I, I will try to give this person a call but they might, they might not be able to talk about these things with me, uh, like over the phone.. you know..

Lady Whistleblow: But they can confirm a time to you.. right?

#ShirinaHolmatova: Aaah sorry?!

Lady Whistleblow: But they can confirm a time to you, they can tell you whether they can call me before 10 or after 10 or when they can call right?

#ShirinaHolmatova: Aaaah... eh.. eh.. I'm not sure because look it's very complicated. This person is also trying to make sure that nobody on their end finds out that they are going to do this as well. So, umm, I, I don't know what kind of precautions and stuff that they will have to take, but if... look, worst case scenario, this person will try to call you tomorrow. If you, if you don't pick up, uumm, they can, they can try again... is that alright?

Lady Whistleblow: yeah, but if you can make it before 10 it would be much easier because after then it will be... tomorrow is a very difficult day for me

#ShirinaHolmatova: Ok.. I... I understand. Yeah. Ok...well, I will, I will certainly pass on that message. Thank you so much for your time and just know that you are not lone in what you are going through and there is someone who wants to help you.

Lady Whistleblow: OK thank you

#ShirinaHolmatova: Ok.. Have a good night

Lady Whistleblow: thank you, you too

#ShirinaHolmatova: bye

Lady Whistleblow: bye

It seemed to me that there were three key messages the caller was trying to deliver to me: Firstly, that the Pucci family "are absolutely horrible people" and "are crazy people. They are incredibly unsafe and"... "everyone involved needs to be really careful". Secondly, the caller wanted me to know that they are aware of my investigations because they are aware of my interactions with "Joanne" and wanted me to know that "she is not reliable". Thirdly, that they are calling on behalf of someone that can help me get my money back.
