The Spring Market is a rain or shine event. It is not an exclusively handmade-only event. Retail, resale or direct sales are allowed without duplication. However, we find that 80% or more of our vendors are handmade.

Application deadline is Saturday, March 7, 2026.

A current California Retail Sales Permit is required from the California Department of Tax and Fee Administration (CDTFA) for sellers, unless exempt (see below). Temporary permits valid for 90 days are also an option. There is no fee involved, but all non-exempt sellers must have registered sales permits.

### **Payment Information**

Payments will be accepted AFTER you have received confirmation by email to participate from [CentralCoastCraftFair@gmail.com](mailto:CentralCoastCraftFair@gmail.com). Direct or private messaging via Messenger or Instagram will not be used to complete applications or payments.

Two payment options are available: PayPal invoice or cash/check. You will never be asked to pay via Messenger, Friends & Family, Zelle, CashApp, or any other unsecured payment system.

If selecting **PayPal Invoice**, it will be sent to the email address provided. There will be a \$5.00 convenience fee added to each invoice that is non-refundable.

If selecting payment by **Check**, it must be mailed, or hand-delivered in-person. Details will be provided in your confirmation email.

Payments are due no later than March 1, 2026, or within 24 hours upon application confirmation up until March 7, 2026. There will be no refunds after March 1, 2026. If you are unable to attend, and communicate that up to 48 hours before the event, your fee may be applied to a future @CaliforniaCraftShow event.

### **Booth Sizes, Assignments and Layout**

Indoor and outdoor spaces are available. Limited indoor spaces available are 6x8 (\$40) and 8x8 (\$65) feet. Outdoor spaces are 10x10 (\$75) feet.

OUTDOOR vendors need to bring their canopy, tables, chairs, and any equipment you will need.

OUTDOOR vendors are **REQUIRED** to bring and use canopy weights, with **a minimum of 15 pounds per leg**. **This is NOT a suggestion.** There can be occasional gusts of wind, and it would be tragic if you lost your canopy to a freak gust, or worse yet some of your product or your neighbor's. If you have tent walls, you may find them useful or not depending on your display, direction of the sun, or in case of rain.

There is no access to electricity outside. If needed, please plan on supplying your own using a whisper generator, batteries or solar.

For INSIDE vendors, per the American Legion Hall:

***At no time may Permittee nail, staple, or glue decorations to ceiling, rafters, walls, painted surfaces, fabrics, or floors, or hang anything from rafters or light fixtures. Permittee may use only "painter's tape" on walls or floors. All decorations must be flame-proof in accordance with local fire regulations.***

For INSIDE vendors, 6 foot tables can be rented for \$5.00 each, and chairs are available at NO COST for INDOOR USE ONLY. There are a limited number of electrical outlets available for use. Please indicate on your application if you will need access.

Return your chairs and tables to the appropriate storage rack at the end of the event.

For ALL vendors, please remove all trash, paper, zip tie fragments or any other rubbish from the area of your booth space. We want to remain good stewards of this facility so we can be invited back next year.

A layout with booth assignments will be sent out in the week of the event. We plan your booth spaces for the best fit and flow, and try very hard to honor all the space requests

of our returning vendors or any other special requests. We reserve the right to assign spaces to suit the needs of the show.

### **Money, Change, and Payment Processing**

How you accept payment for your goods is also up to you (cash, check, card or electronic). There are many options for credit card and online payment processing available out there with varying fees associated with them. The most common are: PayPal, Square, Venmo, and Zelle.

**REMEMBER** to charge your card readers and devices ahead of time, and practice using them with your phones and/or devices **BEFORE** the event!!! Also, bring back up chargers, readers or devices just in case. There is limited access to electricity and overloading any of the outlets may result in bad news.

Please note, the Craft Fair will **NOT** have change available for vendors. Please bring enough cash and change for your business.

There is no WiFi provided by the American Legion Hall. You will need to bring your own Mobile/WiFi hotspot if you need internet access.

### **Day-of Set up and Load in/out details**

- Vendors may start arriving **NO EARLIER THAN 8:00am on Saturday.**
- ALL vendor vehicles must be removed from the American Legion Hall parking lot by 9:30am. Vendor parking is available on the side streets near the hall, but **NOT ON 8TH STREET, which is parallel to the Hall.**
- Please do not start packing up until after 3:00pm. Early packing up and leaving before 3:00pm is a good way to not be invited back to future events. Please be considerate to your fellow vendors.

You may load in/out from the front entrance of the American Legion Hall or from the side entrance on the north side of the Hall.

### **Food & Snacks**

We realize it's a long day, and if you're like me you pack a bag full of snacks. If you forget to bring some munchies, there are some great restaurants in the neighborhood; some provide delivery service through DoorDash, too!

We look forward to a well-attended event in 2026! The Spring Market will be geared toward locals as a family-friendly event. I love supporting our local makers and small businesses by providing a local venue for you to sell your wares and build your business.
