REMOTE ONLINE NOTARIZATION (RON)

For remote online notarization, the signers appear via audio-visual communication from their own device (Computer, Laptop, Tablet or Mobile Device) and are required to enter the secure platform. The signers must be properly identified by the notary via visual presentation of the US Government ID.



RON makes notarization more accessible to people who lack adequate transportation, live in remote areas, have non-traditional work schedules, have health issues that confine them to their home, or busy work schedules that make it hard to find a time for multiple signers plus a notary public to meet.


