\_\_\_\_\_. The client has requested to reserve Gemini Studioz for the function summarized above. The client understands and agrees to the following terms and conditions of reserving Gemini Studioz as the venue of the party above.

### 1. Payment Schedule:

The host, or representative of the host, of the party must pay the full deposit of \$100 at the signing of the party contract. The deposit must be paid to secure the requested date of event. All parties and/or special events must be reserved no later than 14 days prior to the requested date of the event. If party is scheduled less than 48hrs of party, there is an additional \$35 fee included. The payment for the event must be paid in full prior to the beginning of the event/party. The host will be liable for all amounts owed to Gemini Studioz, LLC.

## 2. Cancellation Policy:

If the host cancels the event for any reason, Gemini Studioz, LLC will refund the host the total amount of any monies paid by the host **EXCLUDING the NON-REFUNDABLE \$100 DEPOSIT.** The host must give Gemini Studioz at least a 72 hour notice of the cancellation. If notice of cancellation is not given properly the host will forfeit his/her payments made other than that of the NON-REFUNDABLE \$100 deposit. In the event that Gemini Studioz, LLC has to cancel the event for any reason, a representative or staff member of Gemini Studioz will contact the host no later than 24 hours of the scheduled event.

## 3. Guest Conduct

Gemini Studioz, LLC reserves the right to cancel the event at any time due to the behavior of the host or any guests of the host. In the event Gemini Studioz, LLC must cancel an event for the above reason the host forfeits his/her deposit and any payments made. All guests must abide by all of the rules and regulations established by Gemini Studioz, LLC to prevent injury to themselves or any of the guests in attendance.

## 4. Set Up and Attendance:

Gemini Studioz will provide tables and chairs to accommodate \_\_\_\_ guests. The host will be allowed 30 minutes prior to the event to set up and decorate Gemini Studioz as they see fit for their event. There will be additional charges for time over the 30 minute grace period. The host and guests must arrive at least 15 minutes prior to the event to insure your event gets the maximum amount of time allowed. If you and/or your guests arrive late to the event and you must purchase more time to extend the party beyond the scheduled time. If additional time is not purchased, your party or event will follow the original scheduled time. (In the event it is a Pole Party and no additional time is purchased, your party will end ON TIME).

## 5. Prices and Fees

6. Damages/Cleaning Fee

Any damages caused by the host and/or any of the host’s guests will be charged to the host in a separate invoice no later than 30 days after the event. The host will be held liable for any cost of repairs.

There is an additional **\$35 Cleanup Fee** that will be added to your final invoice total.

7. Security

A licensed security company must be provided by party host and must be approved by Gemini Studioz, LLC for special events.

8. Guests with Medical Conditions or Pregnant:

Any and all medical conditions that may prevent a guest from fully participating in the party or event must be given to the instructor prior to the beginning of party/event. If a participant is pregnant she is not advised to participate in any pole party routines taught by the Gemini Studioz instructor. The pregnant participant will participate at her own risk.

9. Limitation of Liability:

Gemini Studioz, LLC is not held liable for any injuries sustained, loss or stolen personal property, or damages to personal property.

10. Miscellaneous:

In case any one or more of the following conditions cannot be met by the host or Gemini Studioz, LLC for any reason this agreement shall be held invalid or unenforceable. Neither Host nor Gemini Studioz shall be required to perform any term or condition so long as such performance is delayed or prevented by force majeure (acts of God, war, terrorist acts, strikes, lockouts, material or labor restrictions, or prohibitions by any governmental authority).
